1) Staff Report

The report was given by Community Development Director Merriam.

City Attorney Smith clarified staff recommendation and stated staff was seeking direction from Council on updating the cannabis ordinance. He added that the new policy would be reviewed by the Planning Commission and return to Council for final adoption.

- 2) City Council Clarifying & Technical Questions
  - At Member Hurst's request and Council consensus, Mayor Estrada moved City Council Clarifying & Technical Questions after Public Input.
- 3) Public Input

Laura Del Castillo, Eden Infusions, spoke in support of staff recommendation and asked that Council expand zones where cannabis retail would be allowed.

Johnathan Kolodinski, Creme de Canna, spoke in support of staff recommendation, but asked that cannabis square footage not be restricted to 11,000 square foot, two tier footprint. He asked Council to allow three (3) cannabis dispensaries to operate in the City and allow cannabis distribution to locations outside of City limits.

Jordan Levy asked Council to establish guidelines and reserve permits for participants of the Cannabis Equity Program.

Kelly Highland, BTW Industries, asked Council to modify zoning designations in the industrial zone to allow cannabis retail businesses to operate citywide.

Victor Gomez, Pinnacle Strategy, spoke in support of zoning designations and tax rates as proposed by staff. He asked Council to allow three (3) dispensaries to operate within City limits.

Allan Flores, District 3, asked Council to allow three (3) cannabis dispensaries to operate within City limits and designate one (1) permit for Cannabis Equity Program participants.

# 2) City Council Clarifying & Technical Questions (continued)

Community Development Director Merriam and City Manager Huffaker answered questions from Members Hernandez and Coffman-Gomez regarding processing of permits for cannabis dispensaries, proposed taxation of new cannabis services, proposed limitations to square footage of cannabis cultivation, the Cannabis Equity Program, potential for restrictions for hiring cannabis service staff, and proposed tax rate for cannabis dispensaries.

In answering Member Gonzalez, Community Development Director Merriam explained proposed cannabis tax on different stages of cannabis plant cultivation, proposed allowed cannabis retail locations, and exclusion of sites for cannabis due to proximity to schools.

Member Hurst asked staff for clarification on State law in regards to allowed permits for cannabis and questions regarding micro cannabis business permitting.

In answering Member Parker, Community Development Director Merriam explained uses allowed under cannabis cultivation permits.

Mayor Pro Tempore Garcia stated she would not take action on cannabis policy until the following questions were answered:

In Santa Cruz County, had there been an increase of driving under the influence (DUI) relating to cannabis?

In Santa Cruz County, had there been increase in youth usage of cannabis?

In Santa Cruz County, had there been an increase in hospital visits for usage of cannabis?

In Santa Cruz County, had there been an increase in babies being born with cannabis in their system?

Community Development Director Merriam answered questions from Mayor Estrada regarding enforcement of cannabis law and proposed policy to be recommended for approval.

Community Development Director Merriam, in answering Member Parker, explained updates to the policy to provide for more security at cannabis facilities.

#### **MAXIMUM AREA FOR CULTIVATION:**

#### **DELIVERY PERMITS:**

MOTION: It was moved by Member Coffman-Gomez, seconded by Member Gonzalez to direct staff to draft policy allowing licensed cultivation/manufacturing/retail businesses within City limits to deliver products, non-storefront delivery limited to product cultivated/manufactured at locally licensed facility, and prohibit delivery of cannabis by any other sources.

Member Gonzalez asked that City Council be the final approving body for cannabis retail permits.

# **DISTANCE REQUIREMENTS:**

# Cultivation:

Straight line from property line to property line

Increased setback requirements due to odors

All other cannabis uses:

Path of travel from property line to front door of business

- No odors, no direct impact to adjacent properties
- Except for distance requirement from schools

State Requirements: Radius distance from k-12 schools, youth centers measured horizontally from property line to property line as specified in Health and Safety Code 11362.768

# 1) Staff Report

The report was given by Deputy City Manager Vides and Jared Boigon of TBWB Strategies.

# 2) City Council Clarifying & Technical Questions

Deputy City Manager Vides, Mr. Boigon, and Police Officer Radich answered questions from Mayor Pro Tempore Garcia regarding sending mailers to residents with details about Measure G's success, period for campaigning for renewal of the public safety sales tax, efforts by Police and Fire staff to form a committee to advocate for renewal of the public safety sales tax, funding efforts by the committee, endorsements being pursued by the committee, and planned website for the committee campaign.

Member Coffman-Gomez spoke about low voter turnout in the 2014 elections and the effect it had on Measure G. Mr. Boigon answered questions from Member Coffman-Gomez regarding data presented by TBWB Strategies and predictions for Measure G's renewal in 2020.

Deputy City Manager Vides, Mr. Boigon, and City Clerk Flores answered questions from Member Parker regarding costs associated with elections, probability of Measure G renewal success, and reasons staff was recommending March 2020 for placing the measure on the ballot.

# 3) Public Input

Steve Trujillo, District 7, spoke about the benefits of placing the renewal of the public safety sales tax measure on the March 2020 ballot.

Daniel Dodge Jr., District 5, stated more public outreach was necessary prior to placing Measure G renewal on the ballot and asked that it be placed on the November 2020 ballot.

Pastor Mathews-Johnson asked Council to place renewal of the public safety sales tax measure on the March 2020 ballot. She spoke about information distributed and meetings held to inform the public about the measure renewal.

Susan Holford, District 7, spoke about the challenges in passing a sales tax measure and stated it affected the poorest most. She asked that the renewal of the public safety sales tax measure be placed on the March 2020 ballot.

Vick Marani spoke about the benefits of placing renewal of the public safety sales tax measure on the November 2020 ballot.

# 5) City Council Deliberation on the Motion

Member Gonzalez stated placing the measure on the ballot in November and failing would lead to a more expensive special election. He listed the benefits of placing the measure on the March 2020 ballot.

Deputy City Manager Vides answered questions from Member Coffman-Gomez regarding effective date for the new public safety tax measure if approved by the voters and when Parks & Community Services would receive funding from the measure. Member Coffman-Gomez spoke about the history of Measure G.

Mr. Boigon answered questions from Mayor Estrada regarding potential for organized opposition to the sales tax renewal and the effect it would have on the polls.

Member Hurst spoke about the importance of supporting the public safety tax measure and placing it on the March 2020 ballot.

Member Parker stated her support for the renewal of the public safety tax measure and insisted it should be placed on the November 2020 ballot because it was more likely to succeed.

City Attorney Smith, in answering Mayor Pro Tempore Garcia, defined "no-fault evictions." He added that Council could choose to create a new ordinance to further strengthen policy that would be set by Assembly Bill 1482.

City Attorney Smith, Housing Manager Landaverry, and City Manager Huffaker, in answering Member Gonzalez, spoke about who the proposed ordinance protected and how it would benefit those in the process of being evicted.

In answering Member Hernandez, City Attorney Smith and Housing Manager Landaverry explained the eviction process and ability to litigate the reasons for eviction.

City Attorney Smith, in answering Member Parker, stated the eviction process, including court hearings took approximately 45 days.

In answering Mayor Estrada, Housing Manager Landaverry stated workshops would be available to inform the public about the new ordinance.

# 3) Public Hearing

Mayor Estrada opened the Public Hearing.

Brenda Barnett, Capitola resident, stated her apartment complex had been sold and tenants received significant rent increases. She urged Council to adopt the proposed ordinance.

Rachel Ellis, Community Action Board Member, asked Council to approve the proposed ordinance and make the effective date retroactive.

Steve Trujillo asked Council to appoint a rent control board. He urged Council to pursue more affordable housing and attempt to retain those being displaced by offering other rentals within the City.

Karen Silva stated she received a no-cause eviction notice from Miles Lane Properties and asked Council to adopt the ordinance in order to protect the tenants.

Claudia, Miles Lane Properties tenant, stated she also received a no-cause eviction notice and asked Council to adopt the proposed ordinance in order to protect her from being displaced.

Jessica Vásquez, Santa Cruz County resident, asked Council to approve the proposed ordinance.

Gretchen Regan Heart, regional director at California Rural Legal Assistance, offered to meet with the Council and public to discuss the eviction process and assistance that can be obtained. In answering Member Gonzalez, Ms. Heart spoke about the protections offered by the proposed ordinance and those who would be protected by it.

Daniel Dodge Jr. stated there were several properties within City limits that were evicting their tenants and asked Council to approve the proposed ordinance to protect them.

Seeing no one else approach the podium, Mayor Estrada closed the Public Hearing.

# 1) Staff Report

The report was given by Principal Engineer Fontes and Emilia Conlin, planner at Ecology Action.

# 2) City Council Clarifying & Technical Questions

In answering Mayor Pro Tempore Garcia, Ms. Conlin spoke about efforts to educate parents about benefits of walking or biking to school as opposed to driving.

Member Coffman-Gomez spoke about pedestrian challenges at the Alta Vista Avenue and Arthur Road intersection and asked that it be included in the Complete Streets to School Plan. Ms. Conlin answered questions from Member Coffman-Gomez regarding use of short term demonstrations of potential improvements to streets. Member Coffman-Gomez asked staff to explore improvements to the Freedom School area and Linscott Charter School area.

Member Hurst spoke about traffic congestion near Pájaro Valley High School (PVHS) and gave recommendations on alternate ingress/egress routes that could be explored. He spoke about traffic concerns near Starlight Elementary and Diamond Tech School. He stated Green Valley Road between Kralj Drive and Magnolia Drive had seepage issues and the mud on the sidewalk prevented children from walking to school.

Member Hernandez asked staff to pursue beacon crosswalks for the Complete Streets to School Plan. He asked staff to continue working with schools with high percentages of student active transportation because they were areas with high density populations.

In answering Member Gonzalez, Ms. Conlin stated it was possible to add green bike lanes near schools and in result more bike racks. He asked that Santa Clara Street not be modified as travelling through it was already very restrictive.

In answering Member Coffman-Gomez, Ms. Conlin listed schools that didn't have bus service.

In answering Mayor Estrada, Ms.Conlin explained how projects would be prioritized in the final plan.

# 3) Public Input

Anna Kammer asked staff to explore safety improvements on Hammer Drive near H.A. Hyde Elementary School and at Palm Avenue near Mintie White Elementary school.

Ruth Gonzalez, risk and safety manager at Pájaro Valley Unified School District (PVUSD), spoke in support of the Complete Streets to School Plan and stated PVUSD's commitment toward assisting in completion of the plan

Gina Cole spoke about the need for the completion of the Complete Streets Plan. She asked Council to pursue short term demonstrations of potential improvements to streets.

Daniel Dodge Jr. spoke about safety concerns near many schools and spoke in support of staff recommendation.

**MOTION**: It was moved by Member Parker, seconded by Mayor Pro Tempore Garcia to direct staff to prepare a final plan.

# 5) City Council Deliberation on the Motion

Member Parker spoke about the success of the improvements made to MacQuiddy Elementary School and in support of making improvements to other schools.

Mayor Pro Tempore Garcia asked staff to prioritize safety improvements to the schools within District 5 because addressing issues on a single street benefited multiple schools within close proximity.

Member Hurst spoke about the importance of collaboration between agencies in order to better serve residents of the City.

Member Coffman-Gomez asked staff to explore safety improvements to the intersection at Hammer Drive and Pennsylvania Drive.

Member Hernandez stressed the importance of promoting walking and bicycling to schools.

Member Gonzalez asked for more outreach to the community about walking school buses.

Mayor Estrada spoke about THE importance of walking to school and challenges children face as part of travelling to school. He asked staff to ensure pathways to and from schools were well lit. He asked staff to concentrate safety efforts on routes near highways.
