AGENDA ITEM: September 10, 2019 City Council

RECOMMENDATION:

Staff recommends that the City Council approve Contract Change Order Number 5 in the amount of \$175,000 for the Mañana Lane Sanitary Sewer Replacement Project, and approve an appropriation of \$175,000 from the Wastewater Enterprise Fund.

DISCUSSION:

At the September 13, 2016 meeting, City Council adopted Resolution No. 160-16 awarding the contract for the Mañana Lane Sanitary Sewer Replacement Project to Bay Pacific Pipeline, Inc. in the amount of \$1,486,310.00. The Mañana Lane sewer drains an area of approximately 110 acres of residential neighborhoods west of Freedom Boulevard, which is one of the larger tributary areas drained by a sanitary sewer in the City. This sewer had overflowed in the past during rain events and is located adjacent to the Watsonville Slough, making spills on this line of particular environmental concern.

In addition to the capacity problems, the sewer crossed a mobile home park through easements. Several residences were located above the sewer and one of the manholes was difficult to access as it was located in a private yard, making regular maintenance difficult. To correct these problems, the project replaced 3,155 lineal feet of existing 8", 10", and 12" sewer pipe with 15", 16", and 18" sewer pipe, as well as realigned the portions of the sewer that flowed underneath the mobile homes.

Significant Unforeseen Site Conditions. Work commenced in late November 2016. In January 2017 two significant events altered the progress of the work and the cost of the project. While trenching for replacement pipe in the mobile home park, the project

encountered existing PG&E gas and electric lines in conflict with the new design grade of the pipe that were required to be relocated per PG&E design, increasing the scope of work of the project, and delaying this specific operation by twelve months. Shortly thereafter, heavy rains and differing site conditions at the Auto Center portion of the project required the contractor to change installation methods from pipe bursting to open trenching, resulting in additional costs, lost productivity, and overtime labor and equipment costs.

The contractor and City persevered through 2017 to first work around the PG&E conflict, and then address it directly. The Mañana Sanitary Sewer Line project reached substantial completion in February 2018. However, five change orders were issued to the project to address minor unforeseen conditions, redesign costs due to differing site conditions, additional trenching and conduit installation for the PG&E trench package to reroute the utility lines, and to negotiate the additional costs requested by the contractor at the Auto Center Drive site.

Those Change Orders are as follows:

Contract Change Order No. 1 -

\$39,220.37

Additional costs included work due to unforeseen utilities at the Portola Heights trailer park and dealership at 595 Auto Center Drive.

Contract Change Order No. 2 -

\$131,341.92

The first of two change orders that compensates the Contractor for force account work related to the PG&E trench package to re-route the existing gas and electric lines.

Contract Change Order No. 3 -

\$92,428.50

The second of two change orders that compensates the Contractor for force account work related to the PG&E trench package to re-route the existing gas and electric lines. This also included the re-routing of a existing gas service at 141 Miles Lane and costs for redesign on Mañana Lane to avoid an existing water main.

Contract Change Order No. 4 -

(\$9,628.75)

This credit is an adjustment to the final base quantities of the project.

Contract Change Order No. 5 -

\$175,000.00

The Contractor encountered differing site conditions on a section of Mañana Lane, which delayed the project and resulted in additional work in shoring, trenching, and backfill material. The change order also covers the final negotiated cost agreed by the City and Contractor as complete compensation for all extra work associated with the differing site conditions at 595 Auto Center Drive site.

Total Change Orders

\$428,362.04

Staff recommends that the City Council adopt a resolution approving Contract Change Order No. 5 (Change Order Nos. 1 through 4 have already been approved by staff), to close out this project.

STRATEGIC PLAN:

This action is consistent with the Strategic Plan Goal 3 of improving infrastructure.

FINANCIAL IMPACT:

The project is funded by a low-interest loan agreement with the Clean Water State Revolving Fund (project number C-06-8021-110). This project was included in the City's originally approved 2016-2017 Budget and has had carryforward and new appropriations each year. We are asking for an additional \$175,000 appropriation to project 0710-911-7855-14123. There is adequate funding in the Wastewater Enterprise Fund to support this change order.

ALTERNATIVES:

The Council can choose not to approve Contract Change Order No. 5, at which point the Contractor will request arbitration to recover the full non-negotiated costs.

WHEREAS, this project required four (4) change orders due to additional work for significant unforeseen site conditions, those change orders totaled \$253,362.04; and

RECOMMENDATION:

Staff recommends that the City Council adopt a resolution awarding a three-year contract for the WWTP Biosolids Loading, Transportation, and Beneficial Reuse, Project No. WW-19-01 to Denali Water Solutions, LLC in the amount not to exceed of \$1,019,100.

DISCUSSION:

At the June 11, 2019 meeting, the City Council adopted Resolution No. 77 -19 (CM) approving the plans, specifications, and calling for bids for the Three-Year WWTP Biosolids Loading, Transportation, and Beneficial Reuse Contract. Biosolids is the term used for sewage sludge that has been removed from wastewater and stabilized through a two-stage process, anaerobic digestion and dewatering. This two-stage process is required to comply with Environmental Protection Agency and Permit regulations. The site utilizes belt pressed for further dewatering which provides a material referenced as cake. The solids cake material is further dried by spreading and cultivating the solids on the site's drying beds.

After completion of the biosolids drying process the City is left with approximately 4,000 to 6,000 tons of biosolids which are cultivated and stockpiled on site. These biosolids must be removed annually from the City's Wastewater Treatment Facility. The biosoilds are typically removed in September through October each year to take advantage of the warm, dry summer weather for drying and avoiding the negative impacts of the wet winter weather. The biosolids removal and reuse is necessary for the treatment process to protect human health, water quality, and preserve the natural environment.

Bids for this project were opened on August 20, 2019 at 10:00 A.M. The bids received for the project are as follows:

Staff reviewed the bids received and recommends that the City Council award bid to the lowest responsive bidder, Denali Water Solutions, LLC. Denali which is the current WWTP Biosolids reuse service provider. The staff is satisfied with the current service of this vendor.

STRATEGIC PLAN:

The biosolids loading, transportation, and beneficial reuse is consistent with the City Council Strategic Plan, Goal 3 Infrastructure and Environment.

FINANCIAL IMPACT:

Funds in the amount of \$450,000 have been budgeted annually within the Wastewater Enterprise Fund 530 - 7551.

ALTERNATIVES:

City Council may decide not to approve the biosolids loading, transportation, and beneficial reuse contract request. Staff would seek alternative solutions, such as increased stockpiling. These alternatives would potentially have a greater cost to the department and would not solve the need to adequately treat the wastewater and remove biosolids from the process.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WATSONVILLE URGING THE UNITED STATES CONGRESS TO ENACT H. R. RESOLUTION 763 – ENERGY INNOVATION AND CARBON DIVIDEND ACT OF 2019

WHEREAS, the National Oceanic and Atmospheric Administration released its

Fourth Annual Climate Assessment in November 2018 reporting that the impacts of
climate change are already being felt in communities across the country, and that more
frequent and intense extreme weather and climate-related events, as well as changes in
average climate conditions, are expected to continue to damage infrastructure,
ecosystems, and social systems that provide essential benefits to communities; and

WHEREAS, conservative estimates by the world's climate scientists state that to achieve climate stabilization and avoid cataclysmic climate change, emissions of greenhouse gases (GHGs) must be brought to 80-95% below 1990 levels by 2050; and

WHEREAS, the City of Watsonville is committed to reducing GHG emissions through implementation of its Climate Action Plan adopted on February 24, 2015, by Resolution No. 35-15 (CM), and its Carbon Fund Program adopted by Ordinance No. 1314-15 which established a Carbon Fund Fee to assist in achieving the climate related goals in the Climate Action Plan for the City; and

WHEREAS, H.R. 763 has four major components: 1) Carbon Fee – this policy puts a fee on fossil fuels like coal, oil, and gas. It starts low and grows over time, 2) Carbon Dividend – the money collected from the carbon fee is allocated in equal shares every month to the American people; 3) Border Carbon Adjustment – to protect U.S. manufacturers and jobs, imported goods will pay a border carbon adjustment, and goods exported from the United States will receive a refund, and 4) Regulatory Adjustment –

the EPA regulation of carbon-based pollution is restricted for 10 years while the carbon fee is implemented. If targets are not met, these regulations may be enacted. The regulatory adjustment does not impact existing effective regulations on automobile mileage, water quality, air quality, health, or other issues; and

WHEREAS, H.R. 763 encourages market-driven innovation and clean energy technologies and market efficiencies which will reduce harmful pollution and leave a healthier, more stable, and more prosperous nation for future generations; and

WHEREAS, this resolution in support of H.R. 763 does not preclude the City of Watsonville from providing support to other carbon and carbon pricing related bills such as the recent bill H.R. 4051 put forth by Congressman Jimmy Panetta.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF WATSONVILLE, CALIFORNIA, AS FOLLOWS:

That the City Council of the City of Watsonville hereby supports the enactment of H.R. 973, the Energy Innovation and Carbon Dividend Act of 2019, introduced in the House of Representatives on January 24, 2019.

Summary: H.R.763 — 116th Congress (2019-2020)

Introduced in House (01/24/2019)

Energy Innovation and Carbon Dividend Act of 2019

This bill imposes a fee on the carbon content of fuels, including crude oil, natural gas, coal, or any other product derived from those fuels that will be used so as to emit greenhouse gases into the atmosphere.

The fee is imposed on the producers or importers of the fuels and is equal to the greenhouse gas content of the fuel multiplied by the carbon fee rate. The rate begins at \$15 in 2019, increases by \$10 each year, and is subject to further adjustments based on the progress in meeting specified emissions reduction targets. The bill also imposes a specified fee on fluorinated greenhouse gases.

The bill includes

- exemptions for fuels used for agricultural or nonemitting purposes,
- exemptions for fuels used by the Armed Forces,
- rebates for facilities that capture and sequester carbon dioxide, and
- border adjustment provisions that require certain fees or refunds for carbon-intensive products that are exported or imported.

The fees must be deposited into a Carbon Dividend Trust Fund and used for administrative expenses and dividend payments to U.S. citizens or lawful residents. The fees must be decommissioned when emissions levels and monthly dividend payments fall below specified levels.

The bill also suspends certain regulations that limit greenhouse gas emissions. The suspensions expire if the emissions targets established by this bill are not reached after a specified time period.

GENERAL PLAN/ZONING MAP AMENDMENT FINDINGS (WMC § 14-12.708)

The following findings apply to the portion of the project site in which the General Plan land use designation is changed from Industrial to Public/Quasi-Public on the General Plan Land Use Map and the Zoning District is changed from IP (Industrial Park) to N (Institutional) on the Zoning Map.

1. That the proposed amendment is consistent with the policies embodied in the General Plan.

Supportive Evidence

The existing designation on the General Plan Land Use Map for the site is Industrial, and the Zoning designation is Industrial Park (IP). The adjoining hospital property at 75 Nielson Street, however, is designated Public/Quasi-Public (P/QP) on the General Plan Land Use Map and Institutional (N) on the Zoning Map. The General Plan allows hospitals on land designated P/QP, and medical clinics are conditionally permitted within the N Zoning District. Granting the General Plan and Zoning Map Amendments to adopt the adjoining property's General Plan and Zoning designations will allow the site to be used as a medical clinic, and thereby complement the Watsonville Community Hospital by providing supplemental outpatient medical services to the community.

2. That the proposed amendment is compatible to the extent possible with the actual and general planned use of the adjacent properties.

Supportive Evidence

The site is unimproved, vacant land surrounded by light industrial and medical development. Granting the General Plan and Zoning Map Amendments will allow for the establishment of a medical office use that would complement the existing Watsonville Community Hospital located next to the site at 75 Nielson Street.



SUBJECT: Revisions to City Council Campaign Contribution Limits

AGENDA ITEM: September 10, 2019 City Council

RECOMMENDATION:

It is recommended that the City Council introduce an ordinance Amending Title 1 (General Provisions) of the Watsonville Municipal Code by Rescinding Chapter 6 (Election Campaign Contribution Control) and Enacting a New Chapter 6 Entitled "Election Campaign Contribution Control".

DISCUSSION:

On October 26, 2010, the Council adopted Ordinance 1265-10 (CM), eff. November 25, 2010), codified in Chapter 6 of Title 1 of the Watsonville Municipal Code titled Election Campaign Contribution Control. It was modeled after the County's Chapter 8.04.

The County considered revising its Election Campaign Contribution Control Ordinance on <u>June 11</u> and <u>June 25</u>, 2019, and adopted a final version by a 5-0 vote on <u>August 6</u>, 2019, which becomes effective September 7, 2019. Also attached is a July 2, 2019, article from the Santa Cruz Sentinel entitled "Campaign finance cap raised."

Reporting timeline and contribution limit laws have changed since 2010. Chapter 6 of Title 1 of the Watsonville Municipal Code should be amended. The changes align the Municipal Code with the Political Reform Act as it applies to filing statements of organization and campaign disclosure forms. This revised campaign ordinance regulates campaign contributions to Council and will be in effect for elections conducted in 2020.

The Ordinance increases the contribution and solicitation limit from \$400 to \$500 per campaign cycle. No contributions may be accepted by any candidate before the beginning of the election cycle related to the election for which the person is a candidate. Contributions accepted for

campaign expenses and for officeholder expenses are included in the \$500 limit. Contributions or solicitations to reduce campaign debt from prior election cycles are included in the \$500. The \$500 contribution limit increases by twenty-five dollars (\$25) every two years. The first increase occurs on January 1, 2022.

This ordinance has a lower financial threshold than the State for filing Statements of Organization for a recipient Committee [FPPC Form 410]. California Government Code §84201 requires filing the Form 410 with the State and a copy with the local election official when contributions from others are \$2,000 or more. The Board of Supervisors decided to require filing a Form 410 locally with the County elections official when contributions from others are \$1,000 or more. The Council could be the same as the County and require filing a Form 410 locally when contributions are \$1,000 or more. Or, the Council could decide to delete Section 1-6.070 of the proposed ordinance which would mean not requiring filing locally at \$1,000 or more but only when the \$2,000 threshold is met.

The ordinance is now and will continue to be enforceable by the Santa Cruz County District Attorney.

The proposed ordinance presented today is amended to reflect the requested changes.

Campaign finance cap raised

SANTA CRUZ >> Santa Cruz County is giving up the strictest campaign contribution limits of any California county, though its new cap remains among the lowest in the state.

Voters will soon be able to chip in up to \$500 to candidates for countywide office, under recently approved changes to local campaign finance regulations. The prior limit of \$400 had been the lowest of any California county, according to a 2016 report from nonpartisan government watchdog Common Cause.

Unlike most other states, California law sets no limits for campaign contributions toward local elections. Instead, cities and counties can choose to impose their own restrictions — or not.

At least two other counties, San Francisco and Sacramento, have \$500 contribution limits in place, while Alameda County has the state's highest limits at \$20,000. Most counties, including nearby Monterey, set no limits for campaign contributions, according to a list of regulations compiled by the Fair Political Practices Commission.

The \$100 contribution increase was unanimously approved by the Santa Cruz County Board of Supervisors last week, along with an automatic increase of \$25 every two years, starting in 2022.

"We're well under the average, and I think our board felt they don't like the influence of money on campaigns so they wanted to keep it limited," said Santa Cruz County Clerk Gail Pellerin.

Supervisors did not approve another proposed change put forward by the county Elections Department that would have removed a ban on campaign contributions from businesses and labor unions. The proposal to scrap the corporate campaign finance ban came in light of Supreme Court's landmark Citizens United ruling, according to Pellerin. County counsel warned the local ban could be "out of sync" with precedent set by the high court, she said, potentially creating a vulnerability for a legal challenge.

Worried about the impacts of a possible influx of corporate cash on local elections, supervisors decided to keep the ban in place despite staff's concerns.

TITLE 9. POLITICAL REFORM [81000 - 91014] (Title 9 added June 4, 1974, by initiative Proposition 9.)

CHAPTER 4. Campaign Disclosure [84100 - 84511] (Chapter 4 added June 4, 1974, by initiative Proposition 9.)

ARTICLE 1. Organization of Committees [84100 - 84108] (Article 1 added June 4, 1974, by initiative Proposition 9.)

84100. Every committee shall have a treasurer. No expenditure shall be made by or on behalf of a committee without the authorization of the treasurer or that of his or her designated agents. No contribution or expenditure shall be accepted or made by or on behalf of a committee at a time when there is a vacancy in the office of treasurer.

(Repealed and added by Stats. 1979, Ch. 779. Note: This section was added on June 4, 1974, by initiative Prop. 9.)

- 84101. (a) A committee that is a committee by virtue of subdivision (a) of Section 82013 shall file a statement of organization. The committee shall file the original of the statement of organization online or electronically with the Secretary of State and shall also file a copy of the statement of organization with the local filing officer, if any, with whom the committee is required to file the originals of its campaign reports pursuant to Section 84215. The original and copy of the statement of organization shall be filed within 10 days after the committee has qualified as a committee. The Secretary of State shall assign a number to each committee that files a statement of organization and shall notify the committee of the number. The Secretary of State shall email or send a copy of statements filed pursuant to this section to the county elections official of each county that he or she deems appropriate. A county elections official who receives a copy of a statement of organization from the Secretary of State pursuant to this section shall email or send a copy of the statement to the clerk of each city in the county that he or she deems appropriate.
- (b) In addition to filing the statement of organization as required by subdivision (a), if a committee qualifies as a committee under subdivision (a) of Section 82013 within 16 days before the date of an election in connection with which the committee is required to file preelection statements, the committee shall file, within 24 hours of qualifying as a committee, the original of its statement of organization online or electronically with the Secretary of State, and a copy with the local filing officer, if any, with whom the committee is required to file the originals of its campaign reports pursuant to Section 84215 by email, fax, online transmission, guaranteed overnight delivery, or personal delivery.
- (c) If an independent expenditure committee qualifies as a committee pursuant to subdivision (a) of Section 82013 during the time period described in Section 82036.5 and makes independent expenditures of one thousand dollars (\$1,000) or more to support or oppose a candidate or candidates for office, the committee shall file, within 24 hours of qualifying as a committee, the original of its statement of organization online or electronically with the Secretary of State. The committee shall also file a copy of its statement with the filing officer with whom the committee is required to file the original of its campaign reports pursuant to Section 84215, and at all locations required for the candidate or candidates supported or opposed by the independent expenditures, by email, facsimile transmission, guaranteed overnight delivery, or personal delivery. The filings required by this section are in addition to filings that may be required by Section 84204.
- (d) For purposes of this section, in calculating whether two thousand dollars (\$2,000) in contributions has been received, payments for a filing fee or for a statement of qualifications to appear in a sample ballot shall not be included if these payments have been made from the candidate's personal funds.

(a) Notwithstanding Section 81006, the Secretary of State shall charge each committee that is required to file a statement of organization pursuant to subdivision (a) of Section 84101, and each committee that is required to file a statement of organization pursuant to subdivision (a) of Section 84101 shall pay, a fee of fifty dollars (\$50) per year until the committee is terminated pursuant to Section 84214.
- (b) A committee shall pay the fee prescribed in subdivision (a) no later than 15 days after filing its statement of organization.
- (c) (1) A committee annually shall pay the fee prescribed in subdivision (a) no later than April 30 of each year.
- (2) A committee that is created and pays the initial fee pursuant to subdivision (b) in October, November, or December of a calendar year is not subject to the annual fee pursuant to paragraph (1) for the following calendar year.

If a committee has more than one sponsor, and the sponsors are members of an industry or other identifiable group, a term identifying that industry or group shall be included in the name of the committee.
- (b) In the case of a sponsored committee, the name, street address, and telephone number of each sponsor.
- (c) The full name, street address, email address, and telephone number, of the treasurer and any other principal officers.
- (1) A committee with more than one principal officer shall identify its principal officers as follows:
- (A) A committee with three or fewer principal officers shall identify all principal officers.
- (B) A committee with more than three principal officers shall identify no fewer than three principal officers.
- (2) If no individual other than the treasurer is a principal officer, the treasurer shall be identified as both the treasurer and the principal officer.
- (d) The full name and office sought by a candidate, and the title and ballot number, if any, of any measure, that the committee supports or opposes as its primary activity. A committee that does not support or oppose one or more candidates or ballot measures as its primary activity shall provide a brief description of its political activities, including whether it supports or opposes candidates or measures and whether such candidates or measures have common characteristics, such as a political party preference.
- (e) A statement whether the committee is independent or controlled and, if it is controlled, the name of each candidate or state measure proponent by which it is controlled, or the name of any controlled committee with which it acts jointly. If a committee is controlled by a candidate for partisan or voter-nominated office, the controlled committee shall indicate the political party, if any, for which the candidate has disclosed a preference.
- (f) For a committee that is a committee by virtue of subdivision (a) or (b) of Section 82013, the name and address of the financial institution in which the committee has established an account and the account number.
- (g) Other information as shall be required by the rules or regulations of the Commission consistent with the purposes and provisions of this chapter.

- (b) In addition to filing an amendment to a statement of organization as required by subdivision (a), a committee as defined in subdivision (a) of Section 82013 shall file an amendment to its statement of organization within 24 hours if the change requiring the amendment occurs within 16 days before the date of the election in connection

with which the committee is required to file a preelection statement, and if any of the following information is changed:

- (1) The name of the committee.
- (2) The name of the treasurer or other principal officers.
- (3) The name of any candidate or committee by which the committee is controlled or with which it acts jointly.

The amendment shall include the changed information, the date of the change, and the committee's name and identification number.

The committee shall file the original of the amendment online or electronically with the Secretary of State and a copy with the local filing officer, if any, with whom the committee is required to file the original of its campaign reports, by email, fax, online transmission, guaranteed overnight delivery, or personal delivery.

The detailed accounts, records, bills, and receipts shall be retained by the filer for a period specified by the Commission. However, the Commission shall not require retention of records for a period longer than the statute of limitations specified in Section 91000.5 or two years after the adoption of an audit report pursuant to Chapter 10 (commencing with Section 90000), whichever is less.

84105. A candidate or committee that receives contributions of five thousand dollars (\$5,000) or more from any person shall inform the contributor within two weeks of receipt of the contributions that he or she may be required to file campaign reports, and shall include a reference to the filing requirements for multipurpose organizations under Section 84222. However, a candidate or committee that receives a contribution of ten thousand dollars (\$10,000) or more from any person during any period in which late contribution reports are required to be filed pursuant to Section 84203 shall provide the information to the contributor within one week. The notification required by this section is not required to be sent to any contributor who has an identification number assigned by the Secretary of State issued pursuant to Section 84101.

84107. Within 30 days of the designation of the numerical order of propositions appearing on the ballot, any committee which is primarily formed to support or oppose a ballot measure, shall, if supporting the measure, include the statement, "a committee for Proposition _____," or, if opposing the measure, include the statement, "a committee against Proposition _____," in any reference to the committee required by law.

- 84108. (a) Every slate mailer organization shall comply with the requirements of Sections 84100, 84101, 84103, and 84104.
- (b) The statement of organization of a slate mailer organization shall include:
- (1) The name, street address, email address, and telephone number of the organization. In the case of an individual or business entity that qualifies as a slate mailer organization, the name of the slate mailer organization shall include the name by which the individual or entity is identified for legal purposes. Whenever identification of a slate mailer organization is required by this title, the identification shall include the full name of the slate mailer organization as contained in its statement of organization.
- (2) The full name, street address, email address, and telephone number of the treasurer and other principal officers.

- (3) The full name, street address, email address, and telephone number of each person with final decisionmaking authority as to which candidates or measures will be supported or opposed in the organization's slate mailers.
- (c) The statement of organization shall be filed online or electronically with the Secretary of State within 10 days after the slate mailer organization receives or is promised five hundred dollars (\$500) or more for producing one or more slate mailers. However, if an entity qualifies as a slate mailer organization within 16 days before the date of an election in which it is required to file preelection statements, the slate mailer organization shall file the statement of organization online or electronically with the Secretary of State within 24 hours of qualifying as a slate mailer organization.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF WATSONVILLE,
CALIFORNIA, DOES HEREBY ORDAIN AS FOLLOWS:
SECTION 1. ENACTMENT.

Title 1 (General Provisions) of the Watsonville Municipal Code is hereby amended by rescinding Chapter 6 (Election Campaign Contribution Control) and adding

a new Chapter 6 entitled Election Campaign Contribution Control to read in words and figures as follows:

Sec. 1-6.010 Intent and purpose of provisions.

(a) Inherent in the high cost of election campaigning is the problem of excessive or improper influence, real or perceived, exercised by campaign contributors over elected officials, and the electoral process. The purpose of this Chapter is to enact realistic and enforceable limits on the amounts that individual campaigns may accept in City elections, in order to prevent corruption in local campaigns, reduce the influence of large contributions, ensure that individuals and interest groups continue to have a fair and equal opportunity to anticipate in electing City candidates, and maintain public trust in governmental institutions and the electoral process. To those ends, this chapter also enacts; appropriate reporting to provide for transparency in City election finance and full enforcement of its provisions.

(b) This chapter is enacted in accordance with Section 7 of Article XI of the California Constitution, California Elections Code Section 10003, California Government Code Section 81013, and Watsonville City Charter Section 200and may be cited as the "Watsonville Election Campaign Contribution Control Ordinance."

Sec. 1-6.020 Definitions.

The definitions of words and phrases provided in the Political Reform Acts of 1974 and 1996, as amended (Government Code Section 81000 et seq.), shall apply when those same words are used in this chapter, except:

(a) "Business or labor committee" shall mean a committee created or sponsored by a corporation, partnership, labor union, labor organization or other for profit or not for profit business entity for the sole purpose of using the voluntary donations of its members or employees for public purposes.

(b) "Candidate" shall mean any individual listed on the ballot for nomination for and for election to City Council, or who otherwise has taken affirmative action to seek nomination or election to City Council, or who receives a contribution or makes an expenditure, or who gives their consent for any other person to receive a contribution or make an expenditure with a view to bring about their nomination or election to City Council. "Candidate" also means an officeholder in connection with a recall election relating to such officeholder.

(c) "Committee" shall mean any person or combination of two or more persons acting in support of or in opposition to a candidate, or in support of or in opposition to the qualification for the ballot of any recall petition, or which seeks or plans to seek to influence the outcome of any election of a candidate, or which supports or opposes the qualification of any recall petition for the ballot.

- (d) "Corporation" shall mean a corporation organized under the laws of California, or any other state or nation.
- (e) "City Council" shall mean the office of City Council of the City of Watsonville.
- (f) "Election," "election of a candidate," and "city election" shall mean any primary, general or special City election held within the City, including a recall election, which involves the election of any person to City Council.

- (g) "Election cycle" carries the definitions below, specific to the type of election at issue.
- (1) Special Elections. For purposes of any special election for City Council, the term "election cycle" means the period commencing on the date a special election is called and ending on the day of the special election.
- (2) Recall Elections. For purposes of any recall election, the term "election cycle" means the period commencing on either the date a committee is formed pursuant to the Political Reform Act in support of a recall election or the date the City Clerk approves a recall petition for circulation and gathering of signatures, whichever occurs earlier, and ending on the day the first of the following events occur:
- (i) The time provided by law for the gathering of signature on recall petitions expires without sufficient recall petition signatures having been filed with the City Clerk to require a recall election;
- (ii) All committees formed in support of the recall have been terminated pursuant to the provisions of the Political Reform Act; or
 - (iii) The date the recall election is held.
- (h) "Enforcement authority" shall mean the District Attorney of Santa Cruz County, except as such authority is vested in the California Fair Political Practices Commission by State law. Nothing in this chapter shall be construed as limiting the authority of any law enforcement agency, prosecuting attorney or other person to enforce the provisions of this chapter under any circumstances where such law enforcement agency, prosecuting attorney or other person has lawful authority to do so.

(i) "Indebted former candidate" means a person who was a candidate for a Council office at a City election and who has campaign debt remaining from such election after expiration of the election cycle for the Council office for which they were a candidate.

(j) "Individual" shall mean a human being, and shall not include a partnership, corporation, association, firm, business entity, committee, club, other organization, or a group of persons however organized.

(k) "Measure" shall mean a local proposition submitted to a popular vote at an election by initiative, referendum, or as an advisory measure.

(I) "Proceedings to qualify a recall petition for the ballot" shall mean the attempt by any person or persons to qualify a recall petition for submission of the same to a popular vote at any election, whether or not such recall is ultimately qualified for the ballot.

Sec. 1-6.030 Interpretation.

This chapter shall be construed liberally in order to effectuate its purposes. No error, irregularity, informality, neglect or omission of any officer in any procedure taken under this chapter which does not directly affect the jurisdiction of the City to control campaign contributions shall avoid the effect of this chapter.

Sec. 1-6.040 Campaign contribution limit.

(a) Elections of a Candidate. Except as otherwise provided in this section, no person shall make, and no City candidate or treasurer of any controlled committee of any City candidate shall solicit or accept, any contributions which would cause the total amount contributed by such person to such candidate or to their controlled committee to

exceed Five Hundred Dollars (\$500) during any election cycle for any Council office. No contributions shall be accepted by any candidate before the beginning of the election cycle related to the election for which the person is a candidate. Contributions accepted for campaign expenses and for officeholder expenses shall be aggregated for purposes of the limitation set forth in this section.

- (b) City Council Members with Outstanding Debt from Prior Election. No person shall make, and no City Council Member or any controlled committee, shall solicit or accept any contributions for the purpose of retiring outstanding debt from a prior City election which would cause the total amount contributed by such person to such Council Member or to their controlled committee to exceed five hundred dollars (\$500) for the election in which the outstanding debt was incurred, regardless of when the contributions are made or received. This restriction shall not apply to indebted former candidates who are not elected.
- (c) Recall Elections. The contribution limitations set forth in Watsonville Municipal Code Subdivision (a) of this section shall also apply to any committee which collects contributions for the purpose of making expenditures in support of or opposition to the recall of an City Council office, and to contributions received by such Council Member.
- (d) Candidate's Personal Funds. This section shall not apply to a Council candidate's contribution of their personal funds to their own controlled committee. Contributions by the spouse of a Council candidate from such spouse's separate property shall be subject to the contribution limitations set forth in Subdivision (a) of this section.

(e) Escalator. Contribution limits shall be increased by twenty-five dollars

(\$25) every two years, with the first escalation to occur on January 1, 2022.

Sec. 1-6.050 Business and labor union contribution limitations.

(a) No corporation, partnership, labor union, labor organization or other

business entity shall make a contribution to any candidate, to any committee organized

to support or oppose the nomination or election of any candidate, or any person or

committee in support of or in opposition to any proceedings to qualify a recall petition for

the ballot.

(b) Notwithstanding Section 1-6.040 and subsection (a) of this section, a

business or labor committee created for or sponsored by a corporation, partnership,

labor union, labor organization or other business entity for the sole purpose of using the

voluntary donations of its individual members or employees for political purposes may

make contributions from such accumulated voluntary donations to one or more

candidates or committee; provided, that:

(1) Such contributions shall not exceed a total of One Thousand

Dollars (\$1,000) in support of or in opposition to a candidate, or in support of or in

opposition to a recall;

(2) No contribution to any business or labor committee from an

individual member or employee shall exceed the limitations established in this chapter

for total contributions to candidates or committees;

(3) Contributions to any business or labor committee by an individual

member or employee shall be reported by the recipient committee pursuant to this

chapter and State law.

(c) If a candidate, campaign treasurer or other person is offered a contribution which would be in excess of the limitations set forth in this section, the candidate, campaign treasurer or other person must refuse the contribution. If, however, a contribution is accepted which is in violation of this section, the candidate, campaign treasurer or other person accepting such contribution shall report in writing within ten days of the acceptance of the contribution to the enforcement authority the facts surrounding such payment or contribution. The amount of any such payment or contribution accepted which is in excess of the amount permitted by this section shall be paid to the City Finance Director, at the time such written report is made, for deposit in the general fund of the City, and shall not be used to benefit any candidate or committee. In addition and at the same time that the excess amount is paid to the City Finance Director, the same amount shall be paid to the person or entity making the payment or contribution.

(d) Any corporation, partnership, labor union, labor organization or other business entity found by a court to be in violation of this section shall pay promptly the amount contributed in excess of the amount permitted by this section to the City Finance Director, for deposit in the general fund of the City. In addition, and at the same time that the excess amount is paid to the City Finance Director, the same amount shall be paid to the person or entity making the payment or contribution.

Sec. 1-6.060 Reporting requirements - Generally.

(a) In order to make certain that the campaign contribution limitations established by this chapter will in fact be enforceable and enforced, the City Council determines that the reporting requirements contained in this section are necessary; the

City Council further determines that the requirements of this section and this chapter do not prevent any person from complying with the requirements of the California Political Reform Act, or other provisions of State law relating to campaign disclosure.

(b) Checking Account Required. Every candidate, committee or other person

who accepts any campaign contribution, or who makes any expenditure to influence the

outcome of any City election, including any expenditure directly or indirectly in aid of or

in opposition to the nomination or election of one or more candidates, or in aid of or in

opposition to the qualification of any recall petition for the ballot shall, before accepting

any contributions or making such expenditure, establish a checking account at a

recognized financial institution. All monetary contributions accepted by such candidate,

committee or other person, and the proceeds from the sale or transfer of any

nonmonetary contributions accepted shall be placed in the account established

pursuant to this section. All expenditures made by such candidate, committee or other

person to influence the outcome of any election, or in support of or in opposition to any

proceedings to qualify a recall petition for the ballot, shall be made by drawing a check

on such account.

(c) Upon the establishment of a campaign contribution account, the name of

the financial institution, the specific location, and the account number shall be filed with

the City Clerk within twenty-four (24) hours, or prior to the close of business on the first

working day following the establishment of such an account.

(d) The City Council may adopt, from time to time, specific forms to be used

for complying with the reporting requirements established by this chapter.

Sec. 1-6.070 Reporting requirements—Statement of Organization.

Every committee which seeks or intends to seek to influence the outcome of any City Council election, or which seeks or intends to seek to influence any proceeding to qualify a recall petition for the ballot, shall file with the City Clerk, in conformance with the applicable provisions of the Political Reform Act, a copy of any statement of organization or amendment thereto that the committee filed with the California Secretary of State (see Government Code Section 84101 et seq.). when more than One Thousand Dollars (\$1,000) in total campaign contributions has been received, or more than one thousand dollars expended with the intent of influencing the outcome of any election, or any proceedings to qualify a recall election for the ballot. [California Government Code §84201 requires filing only at \$2000]

Sec. 1-6.080 Reporting requirements—Campaign statements.

(a) Every candidate, committee or other person who accepts any campaign contribution, or who makes any expenditure to influence the outcome of any City election, including any expenditure in aid of or in opposition to one or more candidates, or in aid of or in opposition to the qualification for the ballot of any recall petition, shall file campaign statements with the City Clerk at the same times as campaign statements are required to be filed under the provisions of the Political Reform Act, California Government Code Section 81000 et seq. In addition to the statements required to be filed under the provisions of the Political Reform Act, California Government Code Section 81000 et seq, every candidate, committee or other person must also file a statement with the City Clerk on the Friday before any election for the period from 16 days before the election through Thursday before the election, and in addition to

disclosing contributions received during that period, shall disclose estimated expenditures, debts, loans or contributions through the date of the election.

(b) Each campaign statement required to be filed by this section shall contain the same information required by <u>California Government Code Section 84211</u>, be on the same form required by the California Fair Political Practices Commission, and shall be timely filed as required by <u>California Government Code Section 84200.8</u>

Sec. 1-6.090 Reporting requirements—Exceptions.

- (a) The provisions of Section 1-6.070 relating to reporting requirements shall not apply to any loans and/or donations made by a candidate of their own money or property used in behalf of his or her own candidacy, except insofar as such expenditures exceed One Thousand Dollars (\$1,000). For the purposes of this subdivision, in calculating whether One Thousand Dollars (\$1,000) in expenditures have been made, payments for a filing fee or for a statement of qualification shall not be included if these payments have been made from the candidate's personal funds.
- (b) The provisions of Sections 1-6.060, 1-6.070 and 1.6-080 relating to reporting requirements shall not apply to any expenditures made by an individual from their own financial resources to express personal political views when such expenditure is made independent of any candidate or committee and is in no way subject to the control of any candidate or committee, except insofar as such expenditures exceed one thousand dollars.
- (c) The provisions of Section 1-06.060 shall not apply to any candidate who did not receive any contribution and the only expenditure will be made with their own

personal funds for a filing fee and/or statement of qualification that will appear in the voter information pamphlet.

Sec. 1-6.100 Advertising rates—Service fees and charges.

To the extent that any person sells space in any newspaper, newsletter, or magazine, or sells any advertising time on any radio, television, or cable television station, or performs other services in connection with any efforts to support or oppose any proceedings to qualify a recall petition for the ballot, or in connection with any election relating to a measure, or in connection with any efforts to support or oppose any proceedings to qualify a measure for the ballot, the charges made for the use of such space, time or services shall not exceed the charges normally made for comparable use of such space, time or services by other purchasers or users thereof.

Sec. 1-6.110 Enforcement authority—Complaints, legal action, investigatory powers.

(a) Any person who believes that a violation of any portion of this chapter has occurred may file a written complaint with the enforcement authority. A copy of any such written complaint shall, at the time such complaint is made, be filed with the City Clerk, and a copy shall also be provided to any person alleged to have violated any portion of this chapter. If the enforcement authority determines that there is a reason to believe a violation of this chapter has occurred, it shall make an investigation. Whenever the enforcement authority has reason to believe a violation of this chapter has occurred or is about to occur, it may institute such legal action as it deems necessary, including, but not limited to, the following: criminal action, civil action in the name of the City for damages or money due and owing, injunctive relief, and/or declaratory relief.

(b) The enforcement authority shall have such investigative powers as are necessary for the performance of the duties prescribed in this chapter, and may, as

provided by state law, demand and be furnished records of campaign contributions and

expenses at any time.

Sec. 1-6.120 Violation—Penalty.

A violation of any of the provisions of this chapter shall be a misdemeanor and

punishable as provided by this Code.

SECTION 2. PUBLICATION.

This ordinance shall be published in the Watsonville Register-Pajaronian in

compliance with the provisions of the Charter of the City of Watsonville.

SECTION 3. EFFECTIVE DATE.

This ordinance shall be in force and take effect thirty (30) days after its final

AGENDA ITEM: September 10, 2019 City Council

RECOMMENDATION:

It is recommended that the City Council approve the purchase of a new law enforcement Records Management System (RMS) in an amount not to exceed \$450,000; and that the City Council approve an agreement between the Santa Cruz Consolidated Emergency Communications Center (dba Santa Cruz Regional 9-1-1), a joint powers authority, and the City of Watsonville for system administration and maintenance of the Santa Cruz Metropolitan Records System (SCMRS); and authorizing the City Manager or his designee to execute the agreement and amendments and any necessary documents.

DISCUSSION:

Records Management System:

A records management system is an agency-wide system that provides for the storage, retrieval, retention, manipulation, archiving, and viewing of information, records, documents, or files pertaining to law enforcement operations. In 1999, the Santa Cruz County municipal police agencies, Capitola, Santa Cruz, Scotts Valley and Watsonville Police joined together in a letter agreement known as Santa Cruz Metropolitan Records System (SCMRS) in order to purchase and administer a shared law enforcement Records Management System, Cyrun's Alliance PD Central. The SCMRS agencies contracted with Santa Cruz Regional 9-1-1 (SCR9-1-1) to provide the technical and policy administration of the RMS, its related wide-area network and mobile data computers (MDC's) accessing the RMS. Scotts Valley Police left the SCMRS group in 2012.

SCR9-1-1 is the lead agency for the purpose of selecting, purchasing and implementing a new RMS solution for Capitola Police, Santa Cruz Police, Watsonville Police and the Santa Cruz Sheriff's Office. On January 28, 2019, SCR9-1-1 released a request for proposal and

received 7 proposals. After extensive discussions and demonstrations, the SCMRS agencies decided to move forward with the purchase of Central Square Technologies. SCR9-1-1 intends to enter into a 5-year contract and the cost will be distributed among the SCMRS agencies using a RMS cost sharing formula that was adopted by the Chief's Executive Group that combines percentage of population and percentage of cases for the purchase of the RMS and the annual maintenance cost. The formula for cost sharing related to the RMS project is as follows: Santa Cruz Sheriff's Office - 43.99%, Santa Cruz Police Department - 29.46%, Watsonville Police Department - 20.5% and Capitola Police Department 6.06%.

The Watsonville Police Department (WPD) allocated \$450,000 of Measure G funding under FY 2019/20 to move forward with the RMS Project. The WPD is the only SCMRS agency that has the ability to pay up front for the 5-year contract; the other agencies will be financing the project and will need the WPD to issue a check to Government Capital Corp (the agency providing the financing for the project) by September 26, 2019 in order for SCMRS to sign the contract with Government Capital Corp and create a financed account.

SCMRS Agreement

In 2001, the City of Watsonville, Capitola, Santa Cruz and Scotts Valley entered into an agreement with the Santa Cruz Consolidated Emergency Communications Center (dba Santa Cruz Regional 9-1-1) to provide system administration and maintenance of the SCMRS. By consolidating the records system, all parties benefited from reduced cost and economies of scale. However, Scotts Valley Police left the SCMRS group in 2012.

This new agreement between Santa Cruz Regional 9-1-1 (SCR9-1-1) and the City of Watsonville for system administration and maintenance of the SCMRS includes the addition of the County of Santa Cruz Sheriff's Office into the existing SCMRS group. This addition further enhances the buying power of the consolidated group and it is a financial benefit to the original members of the SCMRS. The City of Watsonville's share of SCMRS expenses was reduced from 42.29% to 20.50% due to the County of Santa Cruz Sheriff's Office joining the SCMRS consortium. Watsonville's contribution in FY 2018/19 was \$144,879. In FY 2019/20, Watsonville's contribution was reduced to \$114,701, a cost savings of \$30,178. The previous contribution covered SCMRS staff support, maintenance of a wide area network and software maintenance fees for the current records management system and the mobile data computer infrastructure. The new contribution includes all previous services and adds the implementation of the new records management system.

STRATEGIC PLAN:

The new RMS system addresses the City Councils' focus area of Public Safety. The new RMS system will result in much faster information identification, easier data searching and analytics and improved officer and citizen safety.

The Agreement between the Santa Cruz Consolidated Emergency communications Center and the City of Watsonville addresses the City Councils' focus area of Public Safety. The agreement will facilitate the sharing of vital intelligence information across jurisdictions and

will provide support in the implementation of services for a new consolidated law enforcement records management system.

FINANCIAL IMPACT:

If approved, the City of Watsonville will pay an amount not to exceed \$450,000 for the purchase of the new RMS using Measure G funds. Over the past three years, the Police Department has been reserving Measure G funds in anticipation of this purchase. In addition, by having the ability to pay up front, the City of Watsonville will save the cost of financing fees.

If approved, the City of Watsonville will be subject to a cost-sharing formula based on Watsonville's population and the number of cases. The cost sharing percentages for each jurisdiction shall be re-calculated every three years in February and implemented in that upcoming fiscal year. Watsonville's current cost share is 20.50% (\$114,701 for FY 19/20). The city's contribution will continue to be paid by the General Fund.

ALTERNATIVES:

The Council may choose to not approve the purchase of a new RMS. The Watsonville Police Department will have to use the existing RMS system which no longer meets performance expectations.

The Council may choose to not approve the agreement between SCMRS and SCR9-1-1. However, the City of Watsonville will not have the support needed for system administration or the implementation of the new records management system.

AGREEMENT BETWEEN SANTA CRUZ CONSOLIDATED EMERGENCY COMMUNICATIONS CENTER AND CITY OF WATSONVILLE FOR SYSTEM ADMINISTRATION AND MAINTENANCE OF THE SANTA CRUZ METRO RECORDS SYSTEM (SCMRS)

This Agreement is entered into on SEPTEMBER 26, 2019, ("Effective Date") between SANTA CRUZ CONSOLIDATED EMERGENCY COMMUNICATIONS CENTER (dba SANTA CRUZ REGIONAL 9-1-1), a joint powers authority organized and existing under the laws of the State of California by the County of Santa Cruz and the Cities of Capitola, Santa Cruz and Watsonville, hereinafter referred to as "Authority" and CITY OF WATSONVILLE, hereinafter referred to as "Customer". Additional agencies participating in this Agreement are the Cities of Capitola and Santa Cruz, and the County of Santa Cruz and are collectively hereinafter referred to as the "Customer Parties" or "Customers."

RECITALS

WHEREAS, it is beneficial for the Customer to participate in a consolidated law enforcement records management system serving Capitola, Santa Cruz, and Watsonville Police Departments and the Santa Cruz County Sheriff's Office; and

WHEREAS, Customer has requested Authority to provide system procurement and implementation services for a new consolidated law enforcement records management system; and

WHEREAS, Customer has requested Authority to provide system administration and maintenance services to Customer; and

WHEREAS, Authority is willing to provide such services provided that Customer reimburses Authority for all costs incurred in purchasing a solution and providing such services and provided that all Customers participating in the consolidated records management system agree to continue participating in the system; and

WHEREAS, it is therefore necessary and desirable that the parties enter into the Agreement as set forth below;

NOW, THEREFORE, IT IS HEREBY AGREED between the Authority and the Customer as follows:

AGREEMENT

- 1. <u>Term.</u> The term of this Agreement shall be from July 1, 2019 through June 30 2022, and shall be automatically renewed unless terminated in accordance with the terms of Paragraph 5. Renewal shall be upon the same terms and conditions as set forth herein, except that the annual service charge payments by Customer as required by Paragraph 4 (a) shall be modified each year in accordance with the provisions of EXHIBIT C.
- 2. <u>Powers and Duties.</u> The Authority shall have the powers common to the powers as set forth in recitals of this agreement, to wit: the power to procure, implement, and maintain a law enforcement records management solution on behalf of parties to this agreement.

The Authority is authorized in its own name to perform all acts necessary for the exercise of common powers, including, but not limited to, any or all of the following:

- (a) to make and enter into contracts;
- (b) to employ agents and employees;
- (c) to procure, implement, manage, and maintain a law enforcement records management solution;
- (d) to incur debts, liabilities, or obligations.

3. Obligations of the Parties.

- (a) Authority will provide system administration and maintenance services to Customer as set forth in EXHIBIT A, attached hereto and incorporated herein by reference.
- (b) Customer shall provide personnel and facilities as set forth in EXHIBIT B, attached hereto and incorporated herein by reference.
- (c) Customer shall make payments as set forth in EXHIBIT C, attached hereto and incorporated herein by reference.

4. Payment.

(a) Schedule. In February of each year, Authority shall provide Customer with a detailed statement of service charges (Budget) for the upcoming fiscal year. Customer shall make quarterly payments to the Authority for its proportionate share according to the following schedule:

July 15: 35% of total service charge

October 15: 25% of total service charge

January 15: 25% of total service charge

April 15: 15% of total service charge

- (b) Payment. Service charge payments not received within thirty (30) calendar days following the scheduled dates for payment are subject to five (5%) percent late fee.
- 5. <u>Termination.</u> This Agreement shall automatically be renewed for successive three (3) year terms in accordance with Paragraph 1, unless either party notifies the other in writing of its intent to terminate this Agreement at least one (1) year prior to the expiration of the then current term. In the event that one or more of the Customer Parties notifies the Authority of its intent to terminate its agreement and thus its participation in SCMRS, the Authority and other Customer Parties shall have the authority to terminate or modify the agreement with notice to each other at least nine (9) months prior to the expiration of the then current term.

6. <u>Disposition of Assets and Liabilities upon Termination</u>.

- (a) In the event that 1) all Customer Parties agree to terminate this agreement, or 2) the Authority exercises its independent right to terminate in accordance with Paragraph 5, the Authority shall liquidate all assets purchased through the SCMRS Operating Budget and shall distribute the proceeds to each Customer participant in accordance with the cost sharing contained in Exhibit C in effect for the fiscal year preceding the termination.
- (b) In the event that one or more Customer Parties serves a notice of termination in accordance with Paragraph 5, and the remaining Customer Party(ies) continue to receive system administration and maintenance services from the Authority under a successor agreement, ownership of all assets purchased through the SCMRS Operating Budget shall be assumed by the Authority for use in servicing the remaining Customer Parties participating under a successor agreement.
- (c) Upon termination of this agreement, in whole or in part, as defined in Paragraph 6, Sections (a) and (b), all Customer Parties are responsible for any and all SCMRS budget liabilities, regardless of their participation, based upon their percentage share as outlined in Exhibit C, including but not limited to 1) any and all costs associated with the separation of employment (e.g., layoffs) of budgeted SCMRS personnel due to the termination of the agreement, and 2) any and all outstanding costs for equipment, software, support contracts or other assets used exclusively for the SCMRS.

7. <u>Notice.</u> All notices, demands, requests, consents, approvals, waivers, or communications ("notices") that either party desires or is required to give to the other party or any other person shall be in writing and either personally served or sent by prepaid postage, first class mail. Notices shall be addressed as appears below for each party, provided that if either party gives notice of a change of name or address, notices to the giver of that notice shall thereafter be given as demanded in that notice.

8. <u>Mutual Indemnification.</u> It is agreed that the Authority shall defend, hold harmless, and indemnify Customer, its officers and employees, from any and all claims for injuries or damages to persons and/or property, which arises out of the terms and conditions of this Agreement and which results from the negligent act or omissions or intentional misconduct of the Authority, its officers, and/or employees. Authority represents and warrants that, to the best of its knowledge as of the Effective Date of this Agreement, Customer's use of the SCRMS software and related services will not infringe the intellectual property rights of any third party. Authority shall not enter into any stipulated judgment or settlement that purports to bind Customer without Customer's express written authorization, which shall not be unreasonably delayed or withheld.

It is further agreed that the Customer shall defend, hold harmless, and indemnify Authority, its officers and employees, from any and all claims for injuries or damages to persons and/or property, which arises out of the terms and conditions of this Agreement and which results from the negligent act or omissions or intentional misconduct of the Customer, its officers, and/or employees.

In the event of concurrent negligence of the Authority, its officers and/or employees, and Customer, its officers and/or employees, then the liability for any and all claims for injuries or damages to persons and/or property, which arises out of the terms and conditions of this Agreement shall be apportioned according to the California theory of comparative negligence.

Section 2778 of the California Civil Code shall apply to any interpretation of the agreement of indemnity between the Authority and Customer.

9. <u>Dispute Resolution.</u>

- (a) Informal Dispute Resolution. If a dispute, controversy or claim arises between the parties relating to this Agreement, the parties shall promptly notify one another of the dispute in writing. Each party shall promptly designate a representative to resolve the dispute. The representatives shall meet within ten (10) days following the first receipt by a party of such written notice and shall attempt to resolve the dispute within fifteen (15) days.
- (b) Formal Dispute Resolution. In the event a dispute between the parties which arises under this Agreement cannot be resolved under Section 9(a) ("Informal Dispute Resolution") above, such dispute shall be submitted to a mediator agreed upon by the parties. The mediation shall be conducted in the County of Santa Cruz, California, unless the parties consent to a different location. Each party shall bear their own costs associated with the mediation. Any questions involving contract interpretation shall be resolved using the laws of California.

10. <u>Insurance</u>.

- (a) Each party shall have in effect, during the entire life of this Agreement, Workers' Compensation and employer liability insurance providing full statutory coverage. Each party certifies that it is aware of the provisions of Labor Code Section 3700 which require every employer to be insured against liability for Workers' Compensation or to undertake self-insurance in accordance with the provisions of the code. In lieu of this insurance coverage, evidence of legally appropriate self-insured status shall suffice.
- (b) Each Party shall take out and maintain during the entire life of this Agreement such bodily injury liability and property damage liability insurance as shall protect it from any and all claims for damages for bodily injury, including accidental death, as well as any and all claims for property damage which may arise from the performance of services under the Agreement. Such insurance shall be combined single-limit bodily injury and property damage for each occurrence and shall include comprehensive liability of at least \$1,000,000.00. In lieu of this insurance coverage, evidence of legally appropriate self-insured status shall suffice.
- (c) In the event of a breach of any provision of this section, or in the event any notice is received which indicates any required insurance coverage will be diminished or canceled, the non-breaching party at its option may, notwithstanding any other provision of this Agreement to the contrary, immediately declare a material breach of this Agreement and suspend all further work or obligations pursuant to this Agreement.
- 11. <u>Inspection of Records.</u> All records, books, reports, and documentation maintained by Authority related to performance under the Agreement shall be open for inspection by Customer upon demand at reasonable times.

- 12. <u>Non-Assignment.</u> Authority shall not assign the work covered by this Agreement to a third party without the prior written consent of the Customer.
- 13. <u>Attachments.</u> Should a conflict arise between the language in the body of this Agreement and any attachment to this Agreement, the language in the body of this Agreement controls. This Agreement includes the following attachments:

Exhibit A: Provisions of Authority Services

Exhibit B: Obligations of the Customer

Exhibit C: Payment Plan

14. Merger Clause. This Agreement, including the attached EXHIBITS "A", "B", and "C" sets forth the entire Agreement between the parties. The parties agree that this written Agreement supersedes any previous written or oral agreements between the parties, and any modifications to this Agreement must be made in a written document signed by all parties. The unenforceability, invalidity, or illegality of any provision(s) of this Agreement shall not render the other provisions unenforceable, invalid, or illegal. Waiver by any party or any portion of this Agreement shall not constitute a waiver of any other portion thereof. This Agreement shall be governed by, and interpreted in accordance with, California law.

EXHIBIT A

PROVISIONS OF AUTHORITY SERVICES

SCMRS System administration and maintenance services are described as:

- 1) Purchase, installation, and maintenance of a complete law enforcement records management solution. This includes hardware necessary for the server-side of the solution (such as servers, network switches, disk storage, etc.), records management system software (RMS), GIS data needed by the RMS, and other required server software (such as operating systems or database management software). Solution shall be deployed at Santa Cruz Regional 9-1-1. Optionally, the Customer may instruct Authority to purchase, install, and maintain a secondary RMS site at another location for purposes of redundancy and reliability.
- 2) Purchase of network hardware and installation and configuration of network circuits and/or routing to support operation of a wide area network (WAN) connecting Santa Cruz, Watsonville, Capitola, Santa Cruz Sheriff's Office, and the Authority.
- 3) Ensure that server hardware continues to meet the minimum specifications recommended by the RMS software vendor (Vendor), and coordinate replacement and upgrades as needed. Evaluate and advise Customers regarding client workstation specifications.
- 4) Assist Customers in setting up Customer's equipment so as to make the RMS functional at authorized Customer facilities. Assist in developing and training Customers in the customization of the RMS solution and in creation of new reports so as to take full advantage of the RMS system and its features
- 5) Implement customizations to the RMS, provide custom report output for the RMS, perform daily backup of Customer database files, transfer database backups to a remote site on a weekly basis, and provide assistance in setting up printers and other devices.
- 6) Work with Customer and Vendor and other third parties to implement interfaces as delineated in the RFP. Assist Customers with implementing additional interfaces between the RMS and other Customer technology solutions on an ad hoc basis.
- 7) Provide RMS System Administrator training to designated Customer employees, as defined in Section 1 of Exhibit B, on an as-needed basis.

- 8) Provide the staff necessary to perform the above listed functions. Provide mechanism for reporting and tracking trouble tickets. Staff the SCMRS Help Desk Monday to Friday, from 9 a.m. to 5 p.m., excluding holidays. SCMRS staff are available after hours for critical system issues. Staff shall respond via telephone or remote support within 15 minutes of being paged out and able to respond on site within 60 minutes of determining the need to be physically present. Staff shall work until the issue is resolved. After hours call out procedures defining the process for notification shall be established and provided to all Customers.
- (a) Post-implementation ad hoc services for reporting, interfaces, and training should not exceed 80 hours per Customer annually.
- 9) Act as the single point of contact between Customer and Vendor for RMS issues of any kind and Mobile software issues.

Capitola, Santa Cruz, and Watsonville PDs Only:

- 10) Maintenance of the existing Alliance PD Central RMS: Manage servers, databases, and wide-area network (WAN) to support use of Alliance throughout the PDs until the new RMS is implemented. Support for the current RMS includes the Crossroads interface for Traffic Collisions and Citations, the CopLink data replication feed and its server, and Crystal Reports.
- 11) Provide first line maintenance and troubleshooting for PD-owned Mobile Data Computer (MDC) and Network hardware. Coordinate repair and/or replacement, if needed. Provide, deploy, and manage endpoint protection solution for MDCs. Assist City IT personnel with deployment of additional applications and resources to the MDCs. Support the Radio IP VPN server and clients.
- 12) Advise and support PDs on public safety related technical projects including (but not limited to) voice radio communications and frequency coordination, computer workstation and/or network system upgrades, and/or mobile police computing upgrades and enhancements.

Santa Cruz PD Only:

13) Provide first line maintenance, troubleshooting and support for additional technical systems in the police department patrol vehicles. Manage access to Mobile Office applications including the RMS and other City-applications or websites deployed through Terminal Services or Web Browsers. Support the Mobile Audio/Video recording solution in the patrol vehicles as well as the server, network, and disk duplicator for this system. Coordinate with City vendors to implement, install, troubleshoot, and maintain all technical systems (excluding radios) within the patrol vehicles.

- 13) Support the Coplogic Citizen Reporting system. Assist PD in implementing new report forms, maintain interface with RMS, and user/personnel management.
- 14) Coordination of Police Department issues with City of Santa Cruz Information Technology Department services including assistance with budget needs and recommendations annually.

EXHIBIT B

OBLIGATIONS OF THE CUSTOMER

The Customer shall:

- 1) Designate at least one (1) employee to be the local Systems Administrator (SA) for their respective Agency within 10 days of signing this agreement or within 10 days of a change in personnel. The SA will act as the initial point of contact for local system issues and will be responsible for coordinating with Authority staff to resolve issues related to the RMS and the services provided by the Authority or the Vendor under this Agreement.
- a) Implementation Team Major upgrades or replacement of the RMS will require Customer participation to ensure project success. Customers shall support system upgrades or implementations as recommended by the SCMRS project manager and/or Vendor project manager. Customer shall provide personnel resources including the Customer's SA
- b) Records Administrator (RA) Designate at least one (1) employee to be the local RA for their respective Agency within 10 days of signing this agreement or within 10 days of a change in personnel. The RA must have a comprehensive understanding of the internal structure and workflow of the RMS, departmental policies and procedures as well as how the records department interacts with dispatch and field operations personnel.
- 2) If any systems exist local to each Customer, Customer shall be responsible for backing up individual databases and files residing on local servers.
- 3) Be responsible for maintenance of any software programs residing on local Customer workstation or MDC, other than those covered under this Agreement. Customer IT personnel shall work with SCMRS personnel to verify compatibility of any additional software.
- 4) Be responsible for maintenance of local agency printers, workstation PC hardware, and other individual Customer computer component equipment.
- 5) Be responsible for installation of Mobile Data Computer hardware units and related equipment such as Cradlepoint routers.
- 6) Participate in an advisory entity, subordinate to the Parties, known as the SCMRS Executive Group. Membership will be comprised of the Chief of Police, or their designee, the Sheriff, or their designee, of each Customer receiving service and the Authority General

Manager. The Executive Group will meet regularly to review and approve programs and operating policies. The Executive Group will also review the annual SCMRS budget and staffing plan as proposed by Authority staff and otherwise make recommendations to the Authority Board regarding SCMRS fiscal matters.

7) Participate in an advisory entity, subordinate to the Parties and the SCMRS Executive Group, known as the SCMRS Mid-Managers/Users Group. Membership will include each Customer's Systems Administrator, or their designee, the Customer's Records Administrator, or their designee, the Customer's information technology representative (if that person is not the Systems Administrator), and the Authority's Systems Administrator (normally the SCMRS Systems Supervisor), or their designee. The SCMRS Mid-Managers/Users Group will meet regularly to consider and approve modifications to the RMS configuration, prioritize technical support issues, collaborate on projects and reports, and otherwise make recommendations to the Executive Group regarding SCMRS operations.

EXHIBIT C

PAYMENT PLAN

- 1) <u>Actual Annual Costs.</u> In order to ensure full recovery of Authority costs, the Customer shall reimburse the Authority for its proportionate share of the Authority's actual annual costs associated with staffing, maintaining, and administering RMS and the P1 Mobile system including any and all hardware, software, network connections, vendor maintenance agreements, and other budgeted expenditures as specified in the SCMRS budget each fiscal year.
- 2) <u>Indirect Overheard Costs.</u> Customer agrees to pay their proportionate share of annual Indirect Management Overhead charges to compensate the Authority for staff time and costs not itemized under paragraph 1 of this Exhibit, that are expended to support the administration of this Agreement, supervision of the SCMRS staff, and provide a facility for SCMRS operations. Initial charges are established as follows and will be annually reviewed by the Controller for the Authority and the SCMRS Executive Group and modified as approved by the Authority Board of Directors:
 - (a) 11.49% of budgeted SCMRS Salary and Benefits, and
- (b) 1.93% of budgeted Authority building maintenance costs including debt service, insurance, maintenance of structure/grounds, and utilities.
- 3) <u>Cost Sharing Formula.</u> Pursuant to Authority Policy 334 –*Revenue Records Management System*, Customer is subject to a cost-sharing formula based on population of their respective jurisdiction and the number of cases written annually. The cost sharing percentages for each Customer receiving service shall be re-calculated in February and implemented in the upcoming fiscal year (the following July 1st), every three (3) years as stated in Policy 334 section 5.1.
- (a) As indicated in Exhibit A, Santa Cruz County Sheriff does not participate in MDC Hardware support and maintenance so a separate cost-sharing formula based solely on population shall prevail for costs directly related to MDC Hardware support and maintenance for Capitola, Santa Cruz, and Watsonville Police Departments. The basis for adjusting each Customer's population percentage is the provisional population estimates complied annually by the State of California, Department of Finance, adjusted to the publication date which is published before, but nearest each first (1st) day of January prior to the July 1 adjustment date.

- (b) Santa Cruz Police Department receives additional services as outlined in Exhibit A. Charges for these services were implemented in 2007 at \$66,579 and are subject to an annual cost of living adjustment, using the United States Department of Labor, Bureau of Labor Statistics Consumer Price Index for All Urban Consumers (CPI-U), San Francisco, Sub-group, "All Items."
- 4) The Authority will establish a separate SCMRS Budget (including staff task time documentation) in support of this Agreement which will ensure full cost recovery and accurately determine a SCMRS annual budget surplus/deficit amount to be carried over or reconciled for each fiscal year. The SCMRS budget, and any mid-year adjustments will be first presented to the SCMRS Executive Group and then must be approved by the Board of Directors of the Authority.
- 5) The Authority shall notify each Customer Party no later than February 28 of any changes to 1) their costs of operation, 2) the indirect overhead costs as described within paragraph 2 of this Exhibit, and 3) their cost sharing percentage resulting from changes in the annual provisional population estimates as described within paragraph 3 of this Exhibit.

AGENDA ITEM: September 10, 2019 City Council

RECOMMENDATION:

Staff recommends that the City Council adopt a resolution accepting the bid for construction of the Airport Freedom Trunk Sewer Replacement Project, No. SS-16-02, from K.J. Woods Construction, Inc. in the amount of \$4,248,000 and to authorize and direct the City Manager to award and execute the contract contingent upon execution of the final budget approval financing amendment by the State Water Board Clean Water State Revolving Fund staff, and appropriate an additional \$992,000 in loan revenues and \$948,000 in expenditures for this project.

DISCUSSION:

Background. In 2007, the *Sanitary Sewer Capacity and Assurance Plan* was prepared and serves to identify the portions of the sewer collection system which are subject to overflows in order to develop a prioritized plan to rehabilitate and replace problem sewers. The report prioritized the sewer lines that need to be enlarged for existing peak flow conditions and for potential future peak flow conditions.

The Airport Freedom Trunk Sewer Replacement project was rated a top priority project due to insufficient capacity under existing peak flow conditions. The project will replace a portion of the City's existing sewer in the Airport property and Freedom Boulevard which is in need of replacement and has reached the end of its useful life. It will also improve the existing sewer's alignment by relocating the new alignment to Freedom Boulevard, away

from easements in private property that are difficult for City crews to access for maintenance. Project limits are indicated on attached Project Map (See Attachment 1).

For the past several years, staff has collaborated with the Santa Cruz County Public Works Department which operates the Freedom County Sanitation District under the County Board of Supervisors, to develop a means to co-sponsor this mutually beneficial project. The proposed sewer line drains unincorporated Freedom neighborhoods as well as City neighborhoods, and is maintained by the City.

The sewer replacement project would accomplish three things: 1) increase the capacity with a larger pipe in order to prevent overflows, 2) improve sewer access and maintenance easements, and 3) address a portion of the City's existing aging sewer infrastructure in the Airport property and Freedom Boulevard that has reached the end of its useful life and is in need of replacement.

Award of Bid. At the May 28, 2019 meeting, the City Council adopted Resolution No. 70-19 (CM) approving the plans, specifications, and calling for bids for the Airport Freedom Trunk Sewer Replacement Project. The project will install approximately 6,120 linear feet of 15" to 18" trunk sewer through the Airport property and along Freedom Boulevard.

Bids for this project were opened on July 16, 2019 at 11:00 A.M. The bids received for the project are as follows:

Staff reviewed the bids received and determined that the apparent low bid, Phoenix Electric Company, provided an unresponsive bid which was rejected accordingly. The letter sent to Phoenix Electric is attached for reference. Staff therefore recommends that City Council award to the lowest responsive bidder, K.J. Woods Construction, Inc.

STRATEGIC PLAN:

This project is consistent with the Strategic Plan Goal 3 – Infrastructure & Environment, Long-Range Capital Improvement Plan focus to replace aging facilities and expansion to meet future demand.

FINANCIAL IMPACT:

The project will be funded by a Clean Water State Revolving Fund (CWSRF) loan. The original loan amount approved was \$3,007,579. The debt service for this loan at 1.6% interest for a 20-year term is estimated to be \$178,000/year. Council authorized the City Manager to apply for and execute the loan at its May 24, 2016 meeting resolutions 75-16, 76-16, and 77-16. Staff has had initial discussions with CWSRF staff, and they have

indicated they are willing to increase the amount of the loan to cover the cost of project construction and administration. Staff is prepared to request an increase in the total loan amount to \$4,000,000. The remaining \$248,000 will be paid out of the Wastewater Fund which has sufficient funds to cover this difference. The Freedom County Sanitation District has agreed through a written agreement to pay the City half of the original debt service, or approximately \$89,000/year for 20 years. The FY 2019-20 approved budget includes appropriations for the CWSRF loan revenues of \$3,008,000 and expenditures of \$3,300,000 with the balance covered by cash in the Wastewater Fund. With the adjusted amounts we are requesting appropriation authority of the difference or \$992,000 in loan revenues and \$948,000 in expenditures. This results in slightly less use of cash to cover the difference. See table below. We are also requesting that the existing loan budget be moved to project 14624 to keep revenues and expenditures together.

This letter is to inform you that the Bid your firm has submitted for the referenced project has been found to be not fully responsive to the bidding requirements set forth on the project.

The City of Watsonville is rejecting your bid, opened July 16, 2019, as being non-responsive due to the reasons outlined below:

General Provision 2.11 requires that "The bidder shall provide on the form provided in the 'Proposal and Contract' portion of the Contract Specifications a listing of projects that indicate the bidder's experience as a contractor."

The projects Phoenix Electric listed on the Certification of Bidder's Experience and Qualifications form were in fact projects completed by K.J. Woods Construction, Inc. as the prime contractor. Although Phoenix Electric has hired and intends to utilize the project manager that gained the listed experience while employed with K.J. Woods for the subject project, this does not meet the experience requirements for Phoenix Electric Company as a contractor as stated in General Provision 2.11.

Subsequent to Bid opening, Phoenix Electric Company provided an additional list of project experience specific to Phoenix Electric Company. However, the projects listed are not "of equal or greater complexity and of similar nature" to the Airport Freedom Trunk Sewer Project as required in General Provision 2.11.
