7.a. 2022 REPORT ON SPECIAL EVENTS

Receive the report on 2022 Special Events

- a) Staff Report: Jessica Beebe Special Events Supervisor provided a report on 2022 Special Events. Beebe gave an overview of special events that were put together and or supported by the Parks and Community Services Department.
- b) Commission Questions & Input: Commissioner De Worken asked if the Parks Department is connected to Firework Display at the Watsonville Airport. De Worken also commented on the availability of different vendors other than food venders allowed at the Firework Display.

Beebe advised the Parks did send teammates over to assist with things like parking but was not involved in planning or booth organization.

Commissioner Leonor commented on how the community came out to support the various special events put on by the City of Watsonville

Commissioner Sanchez asked if the Department reaches out for partnership. Beebe responded that outreach is done with local businesses to partner with the City on special events. She also stated that often times non-profit organizations will reach out to the City and will be awarded a sponsorship to assist with their special event.

7.b. REPORT ON FACILITY RENTALS

Receive the report on Facility Rentals

- a) Staff Report: Israel Tirado Facilities Coordinator, provided a report on Facility rentals. Tirado provided information on the current facilities available for rent, along with a breakdown of expenditures and revenues.
- b) Commission Questions & Input: Commissioner Barba asked why Non-Profit organizations get a discount and how the Department is managing EA Hall fields.

Tirado responded that the school is responsible for the gate opening and closure at EA Hall. He also stated that non-profit organizations get a discounted rate when the facilities are used and open to the public.

De Worken asked if there are any tiers for cost. Tirado responded that there are tiers and the cost is dependent on each facility and the information is available on our website.

Commissioner Sanchez requested a report that shows the expenditures and revenue for cost recovery.

c) Public Input: Ms. Leonor commented on the cost of facility rentals and would like to see them available for the community that may not be able to afford the extra cost.

8. NEW BUSINESS

8.a. APPROVAL OF A COMMUNITY GARDEN AT JOYCE MCKENZIE PARK

Staff recommends that the Parks and Recreation Commission approve the creation of a community garden on the sand area of Joyce McKenzie Park so that neighborhood can turn the old volleyball court into a community garden.

- a) Staff Report: Leonardo Cruz Community Environmental Outreach Coordinator provided a report on the installation on a community garden located at Joyce McKenzie Park located on the old sand volleyball court. Cruz advised that there are about 15 households that are currently willing to be a part of the community garden. Cruz provided details on how the community garden will benefit the community by allowing families to supplement the cost of their groceries with growing their own fruits and vegetables. Cruz also explained that the City of Watsonville will provide soil and key water features to ensure all water conservation laws and policies are followed. Cruz went on to say that the community members will be responsible for the maintenance and upkeep of the garden.
- b) Commission Questions & Input: Commissioner Barba, Commissioner De Worken, and Commissioner Leonor all commented on the need of fencing being placed around the community garden to keep animals and unauthorized people out. Cruz replied that any fencing would have to be paid for and installed by the community.

Commissioner De Worken asked how the plots will be divided and who would have access to the community garden. Cruz replied that the plots are dived up by 24 square feet raised plot beds. This can also change based on the number of community families participating by providing more space. Access to the community garden will be limited to the families that pay to utilize it. Commissioner Leonor asked if there will be a place for composting, and who is responsible for the construction and set-up of the garden. Cruz explained that there will be a place for onsite composting. Cruz went on to say that the Community is responsible for all construction of the plots and fencing. City of Watsonville Public Works Department will have staff there for assistance to ensure regulations set by the city are being followed. Cruz added that the group committed to the garden are families who own or work in landscaping and construction.
