A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WATSONVILLE APPROVING AMENDMENT NO 1 OF CONSULTANT CONTRACT WITH SELBERT PERKINS DESIGN, A CORPORATION, ADDING TO THE SCOPE OF SERVICES, EXTENDING TERM OF CONTRACT AND INCREASING COMPENSATION, IN AMOUNT NOT TO EXCEED \$100,000, AND DIRECTING THE CITY MANAGER TO EXECUTE SAME

WHEREAS, in December 2021, the Council adopted Resolution No. 318-21 awarding a contract to Selbert Perkins Design, a corporation, to design a new citywide branding and wayfinding signage program for the City of Watsonville; and

WHEREAS, in October 2022, the Council adopted Resolution No. 211-22 approving the City of Watsonville Signage and Wayfinding Master Plan and provided direction to staff to implement a phased implementation plan; and

WHEREAS, this First Amendment will add to "Section 1. Scope of Services", extend the term of the contract from January 30, 2023 to June 30, 2023, and increase the contract amount by \$100,000 for a revised total amount not to exceed \$209,000; and

WHEREAS, the City Manager has recommended that Amendment No. 1 to the Consultant Contract with Selbert Perkins Design, in an amount not to exceed \$100,000, be accepted, to design a new Parks and Trails Signage Master Plan and Ramsay Park Signage Implementation Plan.

NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF WATSONVILLE, CALIFORNIA, AS FOLLOWS:

1. This action is exempt from the requirements of the California Environmental Quality Act (CEQA) in accordance with CEQA Guidelines Section 15378(b)(5), in that adopting a Resolution amending a contract with Selbert Perkins Design does not meet

CEQA's definition of a "project," because the action does not have the potential for resulting in either a direct physical change in the environment or a reasonably foreseeable indirect physical change in the environment.

- 3. That the City Manager be and is hereby authorized and directed to execute the Contract for and on behalf of the City of Watsonville with minor revisions that may be approved by the City Manager and the City Attorney.
