



- Building Community Resilience and Equitable Access to Services









Climate Resilience & Environmental Mandates

Transportation Funding

Two Forms of Funding

- Formula Annual, Based on Taxes
- Competitive One Time, Generates Additional Costs

Federal IIJA Funding

- Competitive among agencies
- Formula allocated to State

In Watsonville

Most challenging for us as community have been those who suffer from severe/untreated mental illness and late stage addiction.



What we know

Most of the people we encounter will not take the services offered. So, the mere offering of services or jail time alone can be deleterious to a person.

Those suffering from late stage addiction and mental illness rarely have the mental stability to make the right choice in service of a better life.





58% of state and local government organizations were hit by ransomware in 2021, up from 34% in 2020

Smaller counties and municipalities represented the majority of victimized local government agencies, "likely indicative of their cybersecurity resource and budget limitations," the FBI says.



Cybersecurity

The Infrastructure Investment and Jobs Act (IIJA) provides funds to local municipalities for cybersecurity through a State managed process.

With limited IIJA funding to share across the state, Watsonville is concerned that fund distribution will be consumed by larger agencies.



Cybersecurity

Watsonville has a strategic plan of items to meet minimum cybersecurity requirements.

While the State may not have received the funds or be prepared to distribute, it would beneficial to know the requirements for Watsonville to request IIJA funds from the State.
