8. PRESENTATIONS & ORAL COMMUNICATIONS

8.a. ORAL COMMUNICATIONS FROM THE PUBLIC (2 MINUTES EACH)

Steve Trujillo, Cabrillo Board Area VII Trustee, spoke in support of newly appointed Area V Trustee Martha Vega and spoke about importance of women being represented in government. He stated Cabrillo College would serve as shelter site for flood evacuees and spoke about the importance of providing adequate shelter for those that were evacuated.

Antonio Rivas thanked various jurisdictions, including the Council, for their work providing assistance to flood victims, and thanked all organizations and individuals who were coordinating efforts.

Omar Alvarez, Empower Watsonville Youth Leadership Vice President, spoke about the reasons he became involved with the program and spoke about their efforts for preventative approaches to address substance abuse among youth.

Hector Lopez, Empower Watsonville Youth Leadership, spoke about their mission, efforts to help local youth, and activities which benefited the community.

Daniel Hernandez, District 5, spoke about an accident he suffered near Eight and Main Streets. He requested speed bumps on Southern Circle and Western Drive and requested Member Clark contact him to further address the issue.

Rosalina Sotelo, 100 Amber Court, spoke about humidity issues in her home which she believed were caused by a well that was constructed along with a nearby development and requested assistant to address the issue.

Dr. Nancy Bilicich, District 7, thanked the City for updating its evacuation warning boundaries during the most recent storms.

Daniel Dodge Jr., District 5, thanked Council and all volunteers who were providing resources and assistance to flood victims. He asked Council to support local non-profit Raices y Cariño in their efforts to provide hot food, clothes, and other necessities to victims of the flood.

Martha Victoria Vega, District 2, thanked staff for their response to the Pájaro Levee breach that caused flooding and spoke about collaboration between the City and various other organizations to assist affected residents. She spoke about the importance of supporting youth and congratulated Pájaro Valley High School Boys' Soccer Team on their season.

Adam Bolaños-Scow, Pájaro Valley Unified School District (PVUSD) School Board Area 6 Trustee, congratulated Pájaro Valley High School Boys' Soccer Team and stated he looked forward to collaborating with the City.

Mayor Pro Tempore Quiroz-Carter spoke about efforts to assist flood victims, the various locations where resources were available, and the importance of continuing to collaborate to help residents in need.

Member Orozco spoke about volunteer efforts to provide resources and aid to victims of the flood. She thanked everyone who had been involved in the efforts.

Member Salcido thanked Santa Cruz County District 4 Supervisor Hernandez and Monterey County District 1 Supervisor Alejo for their efforts. She spoke about her work with the Police Activities League to assist youth impacted by the flood and congratulated the Pájaro Valley High School Boys' Soccer Team.

Member Clark thanked staff, volunteers, and all other community members who were working to provide assistance and resources to those affected by the flood.

Mayor Montesino spoke about the extensive community response and efforts to assist those that were impacted by the flood and provide needed items.

Member Dutra thanked all staff and volunteers that had assisted in supporting flood victims, spoke about the importance of scheduled levee repairs to avoid flooding in the future, and about his experience with past floods.

Senior Utilities Engineer Berry, in answering Mayor Montesino, spoke about potential for incorporating additional park space or exercise equipment in certain areas of the parking lot.

In answering Member Salcido, Senior Project Manager Young and Parks & Community Services Director Calubaquib spoke about graffiti prevention and abatement, materials that would be used for construction, potential for including a gymnasium, funding sources, and usage and design of the sports fields.

Senior Utilities Engineer Berry, in answering Mayor Pro Tempore Quiroz-Carter, spoke about various sources of lighting included in the project.

In answering Mayor Montesino, Senior Project Manager Young spoke about lighting for the sports fields, and soil improvements that would help optimize turf conditions.

Senior Utilities Engineer Berry answered questions from Member Orozco regarding the timeline for completion of the project.

In answering Member Salcido, Senior Utilities Engineer Berry spoke about potential increases in construction costs and working in phases to complete the project.

Nick Bulaich, District 1, thanked staff for addressing parking in the project design.

Senior Utilities Engineer Berry spoke about environmental education on various subjects, including local bird species that would be part of the City's new exploration center activities.
