RE: 200 Manabe Ow Road - Please Approve and Support Proposed Reyes Project

Dear Watsonville City Council,

I am writing to express my strong support for the proposed Reyes development at 200 Manabe Ow Road in Watsonville and ask that you please approve this project without any delay or additional conditions.

My family has been actively working with city staff and the community to develop the Manabe Ow Business Park land for the past 20+ years. We helped the city of Watsonville annex the land from the County; this was a very challenging political process that resulted in the land having countless obstacles for it to be developed. Aside from the major physical constraints: much of the land was under the floodplain (over 30,000 dump truck loads worth of dirt would need to be imported to raise the site), much of the project was not easily accessible by roads (new roads and a bridge would need to be built at the cost of many millions of dollars), the property was not served by utilities, etc., LAFCO imposed many use restrictions on the land as part of the annexation that disallowed many of the most logical uses from being able to go onto the land (housing, auto dealerships, big box retail, etc.). Many people said that developing the land was impossible and would never happen.

Nevertheless, my family and I worked with city staff and community groups to invest substantial capital, time, energy, and resources over the past 20 years to create the Manabe Ow Specific Plan and Infrastructure Plan and in 2016 we proved the naysayers wrong when we built the backbone infrastructure and FedEx Ground Distribution Center as the lead project of the Manabe Ow Business Park.

Reyes' proposed development project is consistent with what we envisioned and hoped would eventually be constructed when we formulated the Manabe Ow Specific Plan. Reves (formerly Elyxir Distributing) has had a longtime presence in Watsonville, creates hundreds of quality local jobs, and adds millions of dollars to the local economy. I hope that you will enthusiastically support Reyes' proposed development and vote to approve it without any delay or additional conditions. This project is over 20 years in the making and we are fortunate that Reyes is reinvesting in the community and choosing to modernize and grow its facility and workforce in Watsonville.
