A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WATSONVILLE APPROVING FIRST AMENDMENT TO CONTRACT BETWEEN THE CITY OF WATSONVILLE AND 4LEAF, INC., A CORPORATION, AMENDING THE SCOPE OF WORK AND ADDING TO THE COMPENSATION (INCREASING THE CONTRACT BY \$18,500) FOR CONSTRUCTION MANAGEMENT AND INSPECTION SERVICES FOR THE GREEN VALLEY AND FREEDOM BOULEVARD WATER AND SEWER IMPROVEMENTS, PROJECT NO. SS-20-14623; AND AUTHORIZING AND DIRECTING THE CITY MANAGER TO EXECUTE SAME

WHEREAS, on May 12, 2021, the Public Works and Utilities Department advertised a Request for Qualifications Statements from Consulting Engineering Firms for Periodic and On-Call Professional Engineering Services (Staff Augmentation, Design, Construction Management, and Inspection), with a due date of June 15, 2021; and

WHEREAS, a number of firms submitted qualifications statements; these statements were reviewed by City staff and a list was developed; and

WHEREAS, 4LEAF, Inc., a corporation, is on this list of eligible consultants for On-Call Construction Management and Inspection Services; and

WHEREAS, on January 11, 2022, Council adopted Resolution No. 2-22 (CM) awarding contract to 4LEAF, Inc., a corporation, for Construction Management and Inspection Services on the Green Valley and Freedom Boulevard Water and Sewer Improvements, Project No. SS-20-14623 in an amount not to exceed \$304,641; and

**WHEREAS,** this First Amendment to the Contract will add to the scope of work and increase the contract amount by \$18,500, bringing the total contract amount to \$323,141.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF WATSONVILLE, CALIFORNIA, AS FOLLOWS:

1. This action is not subject to review under the California Environmental Quality Act (CEQA) pursuant to Public Resources Code Section 21000, et seq. and the

- 3. The City Manager hereby authorized and directed to execute said First Amendment for and on behalf of the City of Watsonville with minor revisions that may be approved by the City Manager and the City Attorney.
