A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WATSONVILLE REPEALING RESOLUTION NO. 143-14 (CM) ADOPTED ON OCTOBER 14, 2014, WHICH ADOPTED COUNCIL PROTOCOLS, AND REPLACE WITH RESOLUTION APPROVING AN UPDATED VERSION OF COUNCIL PROTOCOLS

WHEREAS, on November 13, 2001, the City Council adopted Resolution No. 265-01A (CM) approving the *Watsonville City Council Protocol: Guidelines for Training, Conference and Meeting Reimbursement*; and

WHEREAS, on October 28, 2003, the City Council adopted Resolution No. 281-03 (CM) approving *City Council Protocols*; and

WHEREAS, on December 14, 2004, the City Council adopted Resolution No. 305-04 (CM) rescinding Resolution No. 281-03 (CM) and approving the revised *City Council Protocols*; and

WHEREAS, on January 25, 2005, the City Council adopted Resolution 21-05 (CM) amending Resolution 305-04 (CM) to incorporate cell telephones; and

WHEREAS, on September 12, 2006, the City Council adopted Resolution No. 198-06 (CM) adopting and reaffirming City Council Protocols; and

WHEREAS, on August 11, 2009, the City Council adopted Resolution No. 161-09 (CM) amending Protocols to allow the reimbursement of a dedicated landline for City business and amending allocation limits for training, conference, and meeting expenses; and

WHEREAS, on December 14, 2010, the City Council adopted Resolution No. 192-10 (CM) amending Protocols amending the section for City-Issued Cell Phones, Cell Phone and Dedicated Landline Reimbursement Allocations to establish a uniform City's policy on cellular data plans; and

WHEREAS, on March 26, 2013, the City Council adopted Resolution No. 39-13 (CM) amending the section for Use of Car for Meetings of Part III - Use of City Resources and Staff for mileage reimbursement for Council Members traveling outside of City limits while on City business; and

WHEREAS, on October 14, 2014, the City Council amended Part II – City Council Operational Matters: Contents of City Council Agenda explaining how members of the Council may place items on the Agenda.
