A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WATSONVILLE APPROVING FIRST AMENDMENT TO CONTRACT BETWEEN THE CITY OF WATSONVILLE AND CAL ENGINEERING & GEOLOGY, INC., AMENDING THE SCOPE OF WORK, ADDING TO THE COMPENSATION (INCREASING THE CONTRACT AMOUNT BY \$78,157.25), AND EXTENDING THE TERM OF THE CONTRACT FOR THE PREPARATION OF CONSTRUCTION PLANS AND DOCUMENTS FOR THE PENNSYLVANIA DRIVE RECONSTRUCTION PROJECT FROM CLIFFORD AVENUE TO WINDING WAY; APPROPRIATING \$78,157.25 IN UNALLOCATED SB 1 FUNDS FROM FUND 0306 TO ACCOUNT NO. 0306-924-7837-14817; AND AUTHORIZING AND DIRECTING THE CITY MANAGER TO EXECUTE SAME

WHEREAS, on January 3, 2022, the City executed a contract for Consultant Services with Cal Engineering & Geology, Inc., to investigate the settlement, recommend a repair and prepare construction plans and documents; and

WHEREAS, the cost of the contract was \$92,836.00 and the term of the contract was June 30, 2023; and

WHEREAS, § 3-5.170 of the Municipal Code provides that amendments to contracts that reasonably relate to the scope of the original contract, are based on post-award information that requires modification of the contract based on unforeseen conditions and were originally approved by Council shall be approved by Council; and

WHEREAS, this First Amendment to Contract will add to the scope of work, increase the contract amount by \$78,157.25, bringing the total contract amount to \$170,993.25 and extend the contract term from June 30, 2023, to June 30, 2025.
