**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WATSONVILLE
NOMINATING PROVIDENCE MARTINEZ ALANIZ FOR APPOINTMENT TO
THE HOUSING AUTHORITY BOARD OF COMMISSIONERS OF THE
COUNTY OF SANTA CRUZ AS THE AT-LARGE REPRESENTATIVE FOR
THE CITY OF WATSONVILLE, FOR A TERM ENDING FEBRUARY 10, 2023**

WHEREAS, on January 22, 2019, the City Council nominated Council Member Rebecca García for appointment to the Housing Authority Board of Commissioners of the County of Santa Cruz as the at-large representative for the City of Watsonville, pursuant to Resolution No. 6-19 (CM), for a four (4) year term. The County later confirmed Council Member Garcia's appointment to the Housing Authority Board of Commissioners ("Board"). Council Member Garcia resigned from the Board on June 29, 2022, resulting in a vacancy; and

WHEREAS, the City Clerk published notice of the vacancy in the City Clerk's Office and published in the Register Pajaronian on September 9, 2022, on the City's website/in the clerk's office pursuant to California Government Code Section 54974(a); and

WHEREAS, Providence Martinez Alaniz is a community member in Watsonville, who has expressed interest in serving on the Housing Authority Board.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY
OF WATSONVILLE, CALIFORNIA, AS FOLLOWS:**

1. This action is not subject to review under the California Environmental Quality Act (CEQA) pursuant to Public Resources Code Section 21000, et seq. and the CEQA Guidelines (14 Cal. Code Regs. §§ 15000 et. seq.), including without limitation, Public Resources Code section 21065 and California Code of Regulations 15378 as this

is not a “project” that may cause a direct, or reasonably foreseeable indirect, physical change in the environment and because the action constitutes organizational or administrative activities of governments that will not result in direct or indirect physical changes in the environment. Additionally, even if a “project,” the action would be exempt under the “common sense” exception (14 Cal. Code Regs. § 15061(b)(3)) because it can be seen with certainty that there is no possibility that this action may have a significant effect on the environment.

2. That Providence Martinez Alaniz is hereby nominated for appointment to the Housing Authority Board of Commissioners of the County of Santa Cruz as the at-large representative for the City of Watsonville, for a term starting upon her appointment to the Board and ending February 10, 2023.

3. That the Council hereby approves such appointment.

4. That the City Clerk is hereby directed to transmit a copy of this Resolution to the nominated member and to the Board of Supervisors of Santa Cruz County.
