Dan Hernandez, District 1, expressed concerns over interactions with City staff and officials. He stated Police Chief Zamora had not yet met with him despite multiple requests.

Marta Bulaich, District 1, stated her concerns with the recent community meeting held regarding CEIBA College Preparatory's rezoning request as well as pick up and drop off locations proposed by the school.

Bobby Marchessault, District 2, requested an update on progress made towards implementing recommendations from the Police & Social Equity Ad Hoc Committee.

#### 8.b. ORAL COMMUNICATIONS FROM THE COUNCIL

Member Quiroz-Carter welcomed the delegation from Velas, São Jorge Island, Azore Islands, Portugal that was visiting.

Member Hurst spoke about various events he attended in the past weeks.

Member García spoke about being shadowed by local high school students who learned about City procedures and asked staff questions regarding various topics. She thanked City Manager Mendez, Police Captain Figueroa, Fire Chief Lopez, and Parks & Community Services Director

Calubaquib for taking time to speak with them, and stated both students were interested in attending a future Council meeting.

Member Estrada stated ballots for the General Election would be mailed soon and spoke about various resources for the public if they had questions regarding content of the ballot.

Member Dutra spoke about the tour of City facilities with the delegation visiting from Velas, São Jorge Island, Azore Islands, Portugal.

Mayor Parker spoke about her attendance at various events over the past weeks, including National Night Out. She encouraged those who were unable to attend to do so next year.

## 12.a. CONSIDERATION OF ORDINANCE REPEALING & REPLACING CHAPTER 2 OF TITLE 7 (SIDEWALKS, DRIVEWAYS, CURBS, AND GUTTERS) OF THE WATSONVILLE MUNICIPAL CODE REGARDING SIDEWALK MAINTENANCE & LIABILITY

#### 1) Staff Report by Assistant Public Works & Utilities Director Rodriguez

#### 2) City Council Clarifying & Technical Questions

In answering Member Dutra, Assistant Public Works & Utilities Director Rodriguez stated the Municipal Code identified property owners as the responsible parties for repairing sidewalks in front of their properties and stated the City provided a payment agreement option.

Assistant Public Works & Utilities Director Rodriguez, in answering Member García, spoke about repair permit fees and inspection costs associated with sidewalk repairs.

In answering Member García, Assistant Public Works & Utilities Director Rodriguez stated property owners were responsible for maintaining sidewalks adjacent to their property, but would investigate responsibility regarding a damaged sidewalk in a specific area of the City.

Assistant Public Works & Utilities Director Rodriguez, in answering Member Hurst, explained responsibility for sidewalk repair as outlined in the Municipal Code and California's Streets & Highways Code. He spoke about potential budget issues that could arise from absorbing costs for all sidewalk repairs.

In answering Mayor Parker, Assistant Public Works & Utilities Director Rodriguez stated property owners were responsible for maintaining trees on their property to prevent possible damage to the sidewalk.

Assistant Public Works & Utilities Director Rodriguez, in answering Member Hurst, spoke about provisions in the Municipal Code for cases where property owners declined to make repairs to the sidewalk.

In answering Member Quiroz-Carter, Assistant Public Works & Utilities Director stated the City's website had information regarding the topic. She spoke about potential scenarios where sidewalks could be damaged and the process for determining liability.

City Attorney Zutler, in answering Mayor Parker, stated the ordinance proposed under Item 12.a.6. would codify California's existing law and aid the City in enforcing it.

City Manager Mendez spoke about the need for updating the Municipal Code with the proposed ordinance.

In answering Member García, City Attorney Zutler stated the Municipal Code already identified property owners as the parties responsible for maintaining and repairing the sidewalk in front of their homes and spoke about potential for exploring fiscal impacts of making the City responsible for all sidewalk repair.

City Manager Mendez spoke about possible negative impacts on the City's General Fund should it take responsibility for sidewalk repairs within City limits.

Mayor Parker stated a large-scale education effort for property owners was necessary to make them aware of their responsibility.

In answering Mayor Parker, City Attorney Zutler stated she was not aware of cities having policies that significantly differed from the one that was being considered by Council.

City Manager Mendez spoke about potential avenues for funding sidewalk repair.

#### 3) Public Comments

Steve Trujillo, District 7, expressed concerns with the permit fee charged to property owners for repairs and spoke about the need for making residents aware of requirements.

Providence Martinez Alaniz, District 3, expressed concerns with property owners being responsible for the sidewalks in front of their homes and the repair fees involved.

**4) MOTION:** It was moved by Member Estrada, seconded by Mayor Parker to introduce the ordinance listed under Item 12.a.6. below.

#### 5) City Council Deliberation on Motion

Member García requested staff explore the possibility of the City paying for part of the sidewalk repair costs.

Member Dutra expressed concern over the cost of the repair permit fee and stated he would not support the motion.

Member Hurst stated concerns with the City potentially being liable for sidewalk repairs that were not done.

Mayor Parker explained why she would support the motion.

Member Quiroz-Carter stated the reasons she would support the motion and spoke about the need for providing residents additional input opportunities.

#### 2) City Council Clarifying & Technical Questions

In answering Member García, Associate Planner Wikle spoke about size requirements for lot splitting.

Associate Planner Wikle, in answering Member García, stated there was no location criteria allowing parking exemptions on lot split requests and explained staff would need to determine if the lot was located within a specific distance of public transportation per SB 9.

#### 3) Public Comments

Steve Trujillo, District 7, expressed concerns with the need for adding sewer and water lines when splitting lots, and the current drought conditions across the State.

**4) MOTION:** It was moved by Member Quiroz-Carter, seconded by Member Estrada to introduce the ordinances listed under Items 12.b.6 through 12.b.10. below.

#### 5) City Council Deliberation on Motion

Member Hurst expressed concerns with potential overcrowding issues and stated additional housing was needed.

In answering Member Dutra, Associate Planner Wikle spoke about potential impacts should Council not approve the ordinances and stated SB 9 contained provisions that would allow a jurisdiction to not approve housing units under specific circumstances.

City Attorney Zutler, in answering Member Dutra, stated the proposed ordinances would allow the City a measure of control over future housing developments while still complying with SB 9 requirements.

Member Quiroz-Carter spoke about the need for additional housing and in support of the motion.

Mayor Parker expressed concerns with accessory dwelling units and sewer laterals in relation to said units.

Member Estrada stated he would support the motion and spoke about the need for housing.
