6.a. REPORT ON JULY IS PARKS MAKE LIFE BETTER MONTH

Commissioner Leonor asked what the Parks Department does for kids and families that are not able to participate due to activities being at capacity. Adriana Flores, Sr. Admin Analyst advised that there is a waitlist that is used to fill spots as they become available. Alternate activities are also offered to those families as other options. For financial barriers the Parks Department partners with the Friends of Watsonville Parks & Community Services, a non-profit organization, to offer a scholarship program.

Commissioner Leonor also asked if the Scavenger Hunt requires registration. Flores advised the Scavenger Hunt is free and does not require registration. The clues can be found on the Parks website.

Youth Representative Brandon asked how the Parks Department can estimate the attendance for next year, and how Camp WOW can be expanded.

Calubaquib replied that they use the kids currently enrolled as well as the kids on the waitlist an estimate can be made on how many possible registrations for next year.

The number of teammates also determines how many kids can be registered for Camp WOW.

Commissioner De Worken asked what type of outreach is being done to reach youth and young adults who may want a summer job.

Calubaquib replied that the Recreation Division spends time attending job fairs and reaching out to local schools to spread the word about open positions.

Commissioner Ibarra asked how the public is notified about programs that are offered, other than social media. Ibarra also asked what the Parks Department is doing to get younger individuals to apply for open positions.

Beebe advised that the Parks Fun Guide is sent out to the community members through the mail. Calubaquib replied that the Jr. Rec Leader program is a great way to build that bridge with the younger community. Also, word of mouth along with the recreation department tabling at job fairs, as well as school events in the community.
