## FIRST AMENDMENT TO SECOND AMENDED LEASE BETWEEN CITY OF WATSONVILLE AND MONTEREY BAY AVIATION, INC., DBA UNITED FLIGHT SERVICES

This first amendment to the Lease dated as of October 15th, 2014, is made and entered on the last date signed below, by and between the CITY OF WATSONVILLE, a municipal corporation, "Landlord", and MONTERY BAY AVIATION, Inc. a corporation doing business as United Flight Services ("Tenant").

Whereas, Landlord and Tenant entered a Second Amended Lease for property commonly known as 120 Aviation Way, Watsonville, CA, dated on or about October 15, 2014 and which the Council approved on October 14, 2014 by Resolution No. 135-14, and

Whereas Landlord and Tenant agree that the initial term of the Second Amended Lease may be changed from twenty to twenty-four years; and

Now therefore, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Landlord and Tenant agree to the following amendment to the Second Amended Lease:

## 2. Term.

The text of the first paragraph of section 2 is deleted and replaced with the following:

"The initial term of this Lease shall be twenty-four (24) years, which term commenced October 15, 2014 and will expire October 31, 2038, unless sooner terminated or extended under the terms or conditions of this Lease (the "Term").

The Lease is otherwise ratified and affirmed and shall remain in full force and effect.
