SUBJECT: APPROVE CONTRACT AMENDMENT #1 WITH TRAFFIC

PATTERNS, LLC., FOR THE ON CALL TRAFFIC SERVICES FOR DESIGN REVIEW, TRAFFIC ENGINEERING STUDIES, TRAFFIC ANALYSIS REVIEW, PRIVATE DEVELOPMENT SITE PLAN REVIEW AND OFF-SITE IMPROVEMENT

RECOMMENDED ACTION:

Staff recommends the City Council adopt a resolution approving Amendment No. 1 to the contract with Traffic Patterns, LLC., in the amount of \$95,000 for On-Call Traffic Services for Design Review, Traffic Engineering Studies, Traffic Analysis Review, Private Development Site Plan Review and Off-Site Improvement Concept Plans for a total contract amount not to exceed of \$190,000.

BACKGROUND:

On December 22, 2021, the City executed contract with Traffic Patterns, LLC., for On-Call Traffic Services for Design Review, Traffic Engineering Studies, Traffic Analysis Review, Private Development Site Plan Review and Off-Site Improvement Concept Plans.

In September 2023, former Traffic Operations Manager Adolfo Gonzalez left the city. The vacant Traffic Operations Manager position may not be filled for up to six months.

DISCUSSION:

Traffic Patterns, LLC., has provided consulting engineering services to the city on an oncall and as-needed basis. Since Adolfo's departure, Jaime Rodriguez, Principal Engineer of Traffic Patterns, LLC., has performed some of the duties of the Traffic Operations Manager. Therefore, additional funds are needed to ensure that the Traffic Engineering Services continue until the Traffic Operations Manager vacancy is filled. Staff recommends that the City Council approve the first contract amendment with Traffic Patterns, LLC., for a new total compensation amount not-to-exceed \$190,000.

FINANCIAL IMPACT:
