A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WATSONVILLE APPROVING PLANS AND SPECIFICATIONS AND CALLING FOR BIDS FOR THE WWTF ELECTRICAL SYSTEM HAZARD MITIGATION PROJECT, NO. WW-22-14797, WHICH WILL BE FUNDED FROM THE SEWER ENTERPRISE FUND

**WHEREAS**, the City of Watsonville's Local Hazard Mitigation Plan identified critical components of the Wastewater Treatment Facility (WWTF) existing electrical system as highly vulnerable to seismic, flood, and climate-related hazards; and

WHEREAS, a project was developed to relocate and consolidate the WWTF critical electrical facilities away from their current hazard-vulnerable locations into one new Main Electrical Facility with an increased level of protection against flood and seismic hazards; and

WHEREAS, the City was awarded a grant from the Federal Emergency Management Agency (FEMA) Hazard Mitigation Grant Program and California Governor's Office of Emergency Services (Cal OES) Prepare CA Match program grant in the total amount of \$16,912,774 toward the construction of the WWTF Electrical Hazard Mitigation Project; and

**WHEREAS**, the plans and specifications for the WWTF Electrical Hazard Mitigation Project, No. WW-22-14797 have been prepared and a call for bids for the above named project is needed.

WHEREAS, no action on CEQA is required on the project as a Notice of Exemption under Categories Class 1 – 15303, Class 2 – 15302, and Class 3 – 15303 was recorded at the Santa Cruz County Clerk of the Board on July 17, 2023.
