WHEREAS, on May 9, 2023, the Council adopted Resolution No. 77-23 (CM) accepting a \$75,000 Behavioral Health Justice Intervention Services (BHJIS) Project Grant and extending the term of the contract through December 31, 2023; and

WHEREAS, the City of Watsonville will be awarded an additional \$260,091 Behavioral Health Justice Intervention Services (BHJIS) Project Grant from the California Department of Health Care Services (DHCS) for the Trauma Informed Multi-Disciplinary Critical Incident Response Team and extending the term of the contract through March 31, 2025.
