A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WATSONVILLE APPROVING SECOND AMENDMENT TO CONTRACT WITH COMMUNITY ACTION BOARD OF SANTA CRUZ COUNTY, INC. A CORPORATION, TO SUPPORT COLLABORATIVE PLANNING. CAPACITY BUILDING. STRATEGIC PROGRAM DEVELOPMENT AND IMPLEMENTATION OF THE MULTI-DISCIPLINARY CRITICAL INCIDENT RESPONSE INCREASING THE CONTRACT AMOUNT BY \$40,000, AND EXTENDING THE TERM OF THE CONTRACT THROUGH MARCH 31, 2025, APPROPRIATING \$40,000 TO THE SPECIAL GRANTS FUND (0260); AND **AUTHORIZING AND DIRECTING THE CITY MANAGER TO EXECUTE THE** SAME

WHEREAS, on April 12, 2022, the City Council adopted Resolution No. 70-22 (CM) approving a Contract with Community Action Board of Santa Cruz County, Inc., to support the collaborative planning, capacity building, strategic program development and implementation of the Trauma Informed Multi-Disciplinary Critical Incident Response Team (MDT) in an amount of \$150,000; and

WHEREAS, on May 9, 2023, the City Council adopted Resolution No. 79-23 (CM) approving a First Amendment to Contract with Community Action Board of Santa Cruz County, Inc., increasing the contract amount by \$12,000 (from \$150,000 to \$162,000) and extending the term to December 31, 2023; and

WHEREAS, this Second Amendment to the Contract will increase the contract amount by \$40,000 (from \$162,000 to \$202,000) and extend the term of the contract to March 31, 2025.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY
OF WATSONVILLE, CALIFORNIA, AS FOLLOWS:

1. Adopting a Resolution approving a Second Contract Amendment with Community Action Board of Santa Cruz County, Inc. does not meet CEQA's definition of a "project", because the action does not have the potential for resulting in either a direct
