A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WATSONVILLE AWARDING CONSTRUCTION CONTRACT TO GRANITE ROCK COMPANY, A CORPORATION, FOR THE OHLONE PARKWAY STREET IMPROVEMENTS PROJECT, IN THE AMOUNT OF \$1,478,640.59; PLUS AN ADDITIONAL 15% CONTINGENCY FOR UNFORESEEN CHANGE ORDERS FOR A TOTAL PROJECT AMOUNT OF \$1,700,436; AUTHORIZING CITY MANAGER TO EXECUTE SAME; AND AUTHORIZING \$170,482 BUDGET APPROPRIATION FROM THE SB 1 FUND; \$1,129,518 FROM THE SPECIAL GRANTS FUND AND \$400,436 FROM THE MEASURE R FUND

WHEREAS, on February 13, 2024, Council adopted Resolution No. 19-24 (CM), approving plans and specifications and authorizing calling for bids for the Ohlone Parkway Street Improvements Project; and

WHEREAS, the engineer's estimate of probable construction cost was \$2,356,505; and

WHEREAS, pursuant to Title 7, Chapter 14 of the City of Watsonville Municipal Code, the City issued a notice inviting bids and bids were received for the Ohlone Parkway Street Improvements Project; and

WHEREAS, bids that were submitted by the deadline, were publicly opened in the "Old City Council Chambers", City Hall, 250 Main Street, Watsonville, California, on Thursday March 21, 2024, at 11:00 A.M., and later tabulated by the Purchasing Officer for the consideration of the City Manager and submission to the City Council; and

WHEREAS, the City Manager has recommended that the bid from Granite Rock Company, a corporation, [Contractor License #22], for the Ohlone Parkway Street Improvements Project, in the amount of \$1,478,640.59, be accepted as the lowest responsible and responsive bidder, which is below the engineer's estimate for the project.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF WATSONVILLE, CALIFORNIA, AS FOLLOWS:

1. The project is determined to be categorically exempt from the requirements

of CEQA in accordance with CEQA Guidelines Section 15301, CE Class 1, maintenance

of existing streets involving no expansion of capacity. Public Works Staff have filed a

notice of exemption with the Santa Cruz County Clerk.

2. That the construction contract is hereby awarded to Granite Rock Company,

a corporation, for the Ohlone Parkway Street Improvements Project, in the amount of

\$1,478,640.59 with a 15% contingency for unforeseen change orders, for a total project

amount of \$1,700,436, in the form on file in the Office of the City Clerk.

3. The City Manager is hereby authorized and directed to execute said

construction contract for and on behalf of the City of Watsonville with minor revisions that

may be approved by the City Manager and the City Attorney, contingent upon approval

of the budget.

4. That an appropriation of \$170,482 from the SB 1 Fund [0306], an

appropriation of \$1,129,518 from the Special Grants Fund [0260], and an appropriation

of \$400,436 from the Measure R Fund [0201] to a new account to be created by the

Finance Department are hereby authorized.
