## FIFTH AMENDMENT TO CONSULTANT SERVICES CONTRACT BETWEEN THE CITY OF WATSONVILLE AND HARRIS & ASSOCIATES, INC.

THIS FIFTH AMENDMENT TO CONTRACT for consultant services is entered into by and between the City of Watsonville ("City") and Harris & Associates, Inc. ("Consultant") this day of \_\_\_\_\_\_\_. The City and Consultant agree as follows:

## **RECITALS**

WHEREAS, City and Consultant have previously executed a Consultant Services Contract to provide design services for the Rail Trail Lee Road, Project No. CT-18-01A and the Rail Trail Walker Street, Project No. CT-18-01B dated May 23, 2018; and

WHEREAS, the original contract was in the amount of \$121,665 with an expiration date of June 30, 2020; and

WHEREAS, on December 11, 2019, First Amendment to contract was executed to amend Section 1. And Exhibit "A" both entitled "Scope of Work", and Section 2. Term of Contract, and Section 3. and Exhibit "B", both entitled "Schedule of Performance", and Section 4. and Exhibit "C" both entitled "Compensation", increasing the total contract amount by \$207,445.00 and bringing the total amount of the contract to \$329,110.00; and

WHEREAS, on March 10, 2021, Second Amendment to contract was executed to amend Section 1. And Exhibit "A" both entitled "Scope of Work", and Section 4. and Exhibit "C" both entitled "Compensation", as the City added additional tasks to the work program and increased the total contract amount by \$13,992.00 and bringing the total amount of the contract to \$343,102.00; and

WHEREAS, on March 10, 2021, Third Amendment to contract was executed to amend Section 1. And Exhibit "A" both entitled "Scope of Work", and Section 4. and

Exhibit "C" both entitled "Compensation", as the City added additional tasks to the work program and increased the total contract amount by \$14,784.00 and bringing the total amount of the contract to \$357,886.00; and

WHEREAS, on June 28, 2022, Council adopted Resolution No. 124-22 (CM) approving the Fourth Amendment with Harris & Associates and extending the term of the contract to June 30, 2023; and

**WHEREAS**, the Fifth Amendment of the Contract for Consultant Services is in the best interest of the City of Watsonville.

**NOW, THEREFORE**, the City and the Consultant agree that the Contract shall be amended as follows:

Section 2. is hereby amended to add the following:

"Section 2. Term Of Contract. The term of the Contract shall be extended to June 30, 2024."

Section 3. and Exhibit "B", both entitled "Schedule of Performance" is hereby amended to read:

All work shall be completed by June 30, 2024.

All other terms and conditions of the Contract dated May 23, 2018, as amended, shall remain in full force and effect.
