To whom it may concern,

The City of Watsonville recently passed a new sign ordinance that allows for large shopping centers to apply for a Master Sign Program if the current sign allowances do not meet their needs. As per Section 14-21.130 of the Watsonville Municipal Code for signage we would like to apply for a new Master Sign Program for the East Lake Shopping Center located at 906 thru 1056 East Lake Avenue.

Due to the 250'-0" setback of the shopping center buildings from East Lake Avenue visibility for the 28 shop tenants is lacking. As a result of this visibility issue the shop tenants frequently ask the shopping center owners to provide roadside signage so that potential customers can find their shops.

To meet this need for our shop tenants and the public we are proposing the installation of 3 smaller sub-monument signs to be situated along East Lake Avenue. Each sub-monument sign would accommodate 6 tenant sign panels. Each sign would be freestanding and internally, LED, illuminated. The proposed sub-monument signs will have decorative features similar in appearance to those used on the existing pylon sign. The proposed sub-monument signs will be placed in planters landscaped to match the existing esthetics of the shopping center.

## **EAST LAKE VILLAGE SHOPPING CENTER**906 - 1056 East Lake Avenue

#### **Master Sign Program**

East Lake Village Shopping Center (ELV) has developed a Master Sign Program in place that has been approved by the City of Watsonville. ELV has 5 types of signs that may be used to display a business's name. All signage must be approved by the Management of ELV prior to installation. List below are the 5 types of signage allowed:

## 1. Standard Tenant Cabinet Box Signage – Number of Signs 29 (includes 4 spaces with no signs boxes) See #6 below for Cabinet box signage detail

- a. Each standard tenant space shall be allowed one (1) projecting cabinet sign.
- b. Suite 1036 shall be allowed two (2) projecting cabinet signs.
- c. Suite 1012 shall be allowed two (2) additional signs on the existing architectural feature located on the roof with a sqft.not to exceed a total of 12 sq.ft.
- d. Standard Tenant Cabinet Box Signage can be located below the roof line in cabinet boxes or above the roof line. Owner to approve location
- e. The maximum sign sq.ft. is 16 sq.ft. except for Suite 1012 and anchor tenants.

#### 2. Anchor Tenant Signage 4 (Suite 906, 954, 990, & 1056)

- a. Each anchor tenant space shall be allowed the following signage with owner approval:
  - i. One wall sign beneath the roof gable, over the main entrance to the suite with a total sign area of no more than 165 square feet.
  - ii. One roof-mounted wall sign with maximum total sign area of no more than 92 square feet.\*
  - iii. One building wall sign on the exterior building wall. Maximum size is 150 sq.ft.

\*Roof-mounted wall signs may not have exposed raceways, per WMC §14-21.060(a)(16).

#### 3. Monument Sign (Existing)

a. 1 Monument sign, maximum of 201 sq.ft.of signage per side. Structure/frame shall be 35' tall by 14' wide, with a 4' skinny antenna placed on top of sign post light and is internally illuminated.

#### 4. Sub-Monument Signs

a. 3 Sub monument signs- Each sign shall be double sided, internally illuminated and have a max sign area of 43 sq.ft. on each side. Each sign shall have a decorative end post that is 120" tall by 16" wide, and the top of the end post shall have an illuminated light fixture (total height of post includes light fixture). Signs shall be internally illuminated and the only portion of the sign that appears

illuminated shall be the sign lettering, registered trademark, or logo (not the background).

#### 5. Parking Lot Light Pole Banner Signage:

a. 8 parking lot pole lights – each parking lot pole light shall have two hanging doubled sided banner signs, attached to pole, with a max sq.ft. of 30 sq.ft. or each side. The bottom mounting height of the banner signs shall be no less than 14' above grade.

#### 6. Standard Tenant Cabinet Box Signage Existing:

- a. Projecting Cabinet Signs
  - i. Existing cabinet box signs shall not exceed 16 sq.ft.
  - ii. Cabinet box signs shall be internally illuminatied.
  - iii. All sign cabinets are existing and mounted underneath the roof eves.
