FIRST AMENDMENT TO CONSULTANT SERVICES CONTRACT BETWEEN THE CITY OF WATSONVILLE AND CSG CONSULTANTS INC., A CORPORATION

THIS FIRST AMENDMENT TO CONTRACT for consultant services is entered into by and between the City of Watsonville ("City") and CSG Consultants Inc., a corporation ("Consultant") this _______. The City and Consultant agree as follows:

RECITALS

WHEREAS, The City and Consultant have previously executed a Consultant Services Contract to provide Building & Fire Plan Review, Building & Fire Inspection, and Permit Technician Services executed on June 24, 2020;

WHEREAS, the Contract expires June 30, 2022; and

WHEREAS, the City has experienced a higher demand from customers for these services than was originally expected of the Consultant causing additional cost and time to the project completion; and

WHEREAS, the amendment of the Contract for Consultant Services is in the best interest of the City of Watsonville.

NOW, THEREFORE, the City and the Consultant agree that the Contract shall be amended as follows:

Section 4 is hereby amended to read:

"Section 4 and Exhibit "C" both entitled "Compensation" of the Contract, are hereby amended to provide an additional amount of compensation of Seventy Thousand Dollars (\$70,000) for the remainder of fiscal year 2020/2021 and Seventy Thousand Dollars (\$70,000) for fiscal year 2021/2022 for professional services specified in Exhibit "C" entitled "First Amendment to Compensation", which is attached hereto and incorporated herein."

All other terms and conditions of the Contract dated June 24, 2020, as amended, shall remain in full force and effect.
