A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WATSONVILLE APPROVING PLANS AND SPECIFICATIONS AND CALLING FOR BIDS FOR THE WATSONVILLE EXPLORATION/NATURE CENTER, PROJECT NO. CB 23-01 (ESTIMATED COST OF \$6.14 MILLION WILL BE FUNDED FROM ARPA FUNDS AND MEASURE R FUNDS)

WHEREAS, on August 23, 2021, the City executed a contract with 19six

Architects, a corporation, for the architectural and engineering design services for the

new Nature Center Building located in Ramsay Park; and

WHEREAS, the new Nature Center Building design has been completed by 19six Architects, a corporation, and is ready for advertisement to bid; and

WHEREAS, the Nature Center project was included as part of the overall Ramsay Park Renaissance Project Initial Study, and the Zoning Administrator found that there is no substantial evidence that the project will have a significant effect on the environment and a Mitigated Negative Declaration was prepared for the project in accordance with Public Resources Code section 21080 (c); and

WHEREAS, a Mitigation Monitoring and Reporting Program (MMRP) was also prepared for the Ramsay Park Renaissance Project which included the Nature Center project, and an Administrative Use Permit and Design Review Permit with Environmental Review (PP2022-4245) was approved on August 16, 2023 by the Community Development Department.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY
OF WATSONVILLE, CALIFORNIA, AS FOLLOWS:

1. Further CEQA review is not required because design and intensity of the Watsonville Exploration/Nature Center, Project No. CB 23-01 are consistent with the analysis provided in the project's

- 5. That after the bids are opened, they shall be tabulated and analyzed and a report submitted to the Interim City Manager, who shall recommend the awarding, or other action, to the Council at its next regular meeting, or as soon thereafter as possible.
