A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WATSONVILLE APPROVING SECOND AMENDMENT TO CONTRACT **BETWEEN** CITY OF WATSONVILLE AND INSTRUMENTS, INC., A CORPORATION, FOR WATER, WASTEWATER, AND COLLECTION SYSTEM WONDERWARE UPGRADE, ADDING TO THE SCOPE OF WORK, EXTENDING THE TERM OF CONTRACT FROM MAY 25, 2024, THROUGH DECEMBER 31, 2025; INCREASING THE CONTRACT AMOUNT BY \$31,416 FOR A TOTAL REVISED AMOUNT NOT TO EXCEED \$877,761; AUTHORIZING AND DIRECTING THE CITY MANAGER TO EXECUTE SAME: AND AUTHORIZING BUDGET APPROPRIATION OF \$9.425 FROM THE WATER ENTERPRISE FUND [0720] TO ACCOUNT 0720-913-7813-14417 AND \$21,991 FROM THE WASTEWATER ENTERPRISE FUND [0710] TO ACCOUNT 0710-911-7835-14799

WHEREAS, on May 25, 2021, Council adopted Resolution No. 148-21 (CM) awarding a Contract for Consultant Services to Telstar Instruments, Inc., a corporation, for work associated with replacing the Water and Wastewater Utilities' supervisory control and data acquisition (SCADA) systems, for an amount not to exceed \$655,000; and

WHEREAS, on May 24, 2024, Council adopted Resolution No. 92-22 (CM) approving a first amendment to the contract, adding to the scope of work, amending the compensation to increase the contract amount by \$191,345 for a revised total amount not to exceed \$846,345; and

WHEREAS, additional work must be performed to improve City radio communication systems; and

WHEREAS, the contract must be increased by \$31,416 for a revised total amount not to exceed \$877,761; and

WHEREAS, the term of contract must be extended from May 25, 2024, through December 31, 2025.

seen with certainty that there is no possibility that this action may have a significant effect

on the environment.

hereto and incorporated herein by this reference is hereby approved.

may be approved by the City Manager and the City Attorney.

5. That the budget appropriation of \$21,991 from the Wastewater Enterprise

fund project account 0710-911-7835-14328 to 0710-911-7835-14799 is hereby

authorized.
