

RESOLUTION NO. _____ (CM)

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WATSONVILLE AUTHORIZING THE PURCHASE OF TWO PORTABLE GENERATORS FROM VOLVO CONSTRUCTION EQUIPMENT & SERVICES, THROUGH THE PURCHASING AUTHORITY OF SOURCEWELL, SOURCEWELL CONTRACT NUMBER 020923-CEC , IN AN AMOUNT NOT TO EXCEED \$200,000; AND AUTHORIZING AND DIRECTING CITY MANAGER TO NEGOTIATE AND EXECUTE PURCHASE ORDER INCLUDING ANY EXTENSIONS OR AMENDMENTS THEREOF IN ORDER TO IMPLEMENT CONTRACT (FUNDED FROM THE SOLID WASTE ENTERPRISE AND SEWER ENTERPRISE FUND)

WHEREAS, bidding requirements and a reference to procedures for the purchase of supplies, equipment, and non-personal contractual services and the sale of personal property are set forth in Chapter 3-5 of the Watsonville Municipal Code and Section 3.2.1 of the City of Watsonville Administrative Rules and Regulations; and

WHEREAS, subdivision (e) of § 3-5.210 exempts purchases made cooperatively with one (1) or more units of government through cooperative purchasing programs substantially the same as the City of Watsonville; and

WHEREAS, the City received a quote from Volvo Construction Equipment & Services, member of Sourcewell, through Sourcewell Contract Number 020923-CEC, for the purchase of two (2) portable generators, in an amount of \$200,000; and

WHEREAS, Sourcewell is a National Joint Powers Association (NJPA) that performs competitive procurements in a manner consistent with public purchasing requirements to allow public agencies to quickly procure equipment and materials.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF WATSONVILLE, CALIFORNIA, AS FOLLOWS:

1. Adopting a resolution approving the purchase of equipment does not meet CEQA's definition of a "project," because the action does not have the potential for

resulting in either a direct physical change in the environment or a reasonably foreseeable indirect physical change in the environment.

2. This purchase is exempt from the purchasing procedures of Chapter 5 (Purchasing Procedures) of Title 3 (Finance) of the Watsonville Municipal Code as a purchase made cooperatively with one (1) or more units of government under subdivision (e) of § 3-5.210 of the Municipal Code.

3. The Council hereby authorizes the purchase of two (2) portable generators from Volvo Construction Equipment & Services, through the purchasing authority of Sourcewell, through Sourcewell Contract Number 020923-CEC, in an amount not to exceed \$200,000 funded by the Solid Waste Enterprise Fund and Sewer Enterprise Fund.

4. That the City Manager is hereby authorized and directed to negotiate and execute said Purchase Order contract for and on behalf of the City of Watsonville, including any extensions or amendments thereof in order to implement this purchase.
