Hello Watsonville City Council,

Five years ago, our city engaged in a comprehensive community-wide visioning process for all its parks, including the Watsonville City Plaza. <u>The outcome was clear</u>: the community strongly supported making slight, thoughtful changes to the Plaza, with a focus on renovating and reinforcing the historic gazebo so it could remain the focal point of this iconic gathering place. This conclusion was not reached lightly; it reflects a conversation we've had as a community multiple times, with the same consensus each time.

Given this, I am baffled as to why the potential elimination of the gazebo is once again before the Council. Why does this issue continue to resurface? The community's stance has been consistent, and I struggle to understand how inflationary pressures could justify a departure from what the people of Watsonville have repeatedly expressed they want.

Many of you, like myself, are lifelong residents of Watsonville. You understand that our city does not have an abundance of locations and landmarks that have withstood the test of time and continue to resonate across generations. The Plaza and its gazebo are the heart of Watsonville, defining our city for decades. Yet, for reasons I cannot comprehend, the leadership in our parks department seems determined to push forward with plans that would erase this cherished piece of our history and culture. We should be embracing and preserving the elements that define us, not demolishing them in pursuit of fleeting trends. We are Watsonville, not Aptos, not Santa Cruz, not Capitola. I believe we have the creative talent and innovative minds within our community to bring the gazebo into the 21st century in a way that honors our heritage.

Perhaps there is a belief that demolishing the gazebo and installing a new, cookie-cutter performance stage might stimulate economic activity in our downtown. However, this approach would be akin to performing plastic surgery on a corpse: it may look appealing on the surface, but the life, energy, and soul of the place would be gone.

Before you consider removing essential parts of our city's history, identity, and spirit in hopes of sparking an economic revival, I urge you to take a closer look at the neglected historic buildings just steps away from the Plaza. The Mansion House, among others, is in a state of disrepair, and the owners should be compelled to sell for the betterment of the community.

There are numerous case studies where public entities have successfully revitalized downtown areas by reinvesting in their communities, purchasing old buildings, and offering creative, young entrepreneurs the opportunity to make their mark. Some cities have even <u>provided</u> tenants with two years of free rent—essentially a short-term loan without exchanging funds—on the condition that they make necessary physical improvements. As Alvarado Street Brewery in Old Monterey demonstrated, sometimes all it takes is one successful business to transform a neighborhood.

Please, leave the Plaza as it is. Invest in our community by emphasizing and preserving its strengths and culture—don't destroy them.
