County Behavioral Health- South County Defined

- The Behavioral Health Division uses guidelines based on Census Designated Places (CDPs) maps
- For "South County" this generally includes zip codes 95003, 95019, 95076, 97077
- This includes Watsonville and the unincorporated areas East and Southeast of Aptos Creek (Seacliff, Del Mar, La Selva Beach, Corralitos, Aptos Hills - Larkin Valley, Amesti, Interlaken, Freedom, and Pajaro Dunes)
- In Calendar Year 2023, 81% of the people we served lived in zip code 95076


Santa Cruz County – Person's Experiencing Homeless (PEH) Defined

People are considered "homeless" if:


- They are marked as homeless by BH staff in the BH data system, generally considered to be living unsheltered or in a place not meant for human habitation, shelter, or transitional housing program for homeless persons or in an institutional or residential treatment setting for less than 90 days and homeless before entering with no housing options available; or
- *using a P.O. box* as a mailing address for those without stable living situations.

South County Behavioral Health Clients served by Calendar Year (95076, 95077, 95019, 95003)




CY 2023 South County Behavioral Health Clients by Zip Code and % PEH
