1. ROLL CALL

Mayor Quiroz-Carter, Mayor Pro Tempore Orozco, and Council Members Dutra, Montesino, and Salcido were present. Council Members Clark and Parker were absent.

2. REPORTS TO COUNCIL - No Action Required

2.a. REPORT BY PUBLIC WORKS & UTILITIES DIRECTOR LINDBERG ON CITYWIDE LIGHTING ASSESSMENT

Traffic Patterns Consultant Traffic Engineer Jaime Rodriguez was also present.

In answering Member Dutra, Engineer Rodriguez spoke about repair and replacement options for different types of lights. He spoke about challenges with replacing decorative poles, efforts to use lights with the same illumination strength, the reasons streetlight replacement would happen in phases, and shared costs with Monterey County to replace lighting on the nearby Pajaro bridge.

City Manager Vides, in answering Member Montesino, stated a funding source for light replacements and repairs had not been identified yet. She stated staff would explore pursuing grant funding.

Public Works & Utilities Director Lindberg added that district meetings helped identify the need for better lighting as a concern for many residents.

Member Montesino requested exploring options to expedite repair and replacement of lights throughout the City.

Member Salcido asked a question regarding how many light poles were City owned and how many were owned by PG&E.

In answering Member Salcido, City Manager Vides stated the City did seek payment when City owned light poles were damaged.

2.b. REPORT BY CITY MANAGER VIDES REGARDING A TASK FORCE ON HOMELESSNESS

Police Chief Zamora and Parks & Community Services Director Calubaquib were also present.

In answering Member Salcido, Police Chief Zamora spoke about the potential impact of Proposition 36 on Police's handling of drug possession crimes.

City Manager Vides, in answering Mayor Quiroz-Carter, spoke about the number of community members that could be part of the task force and allowing for extensive participation.

In answering Member Montesino, City Manager Vides spoke about efforts to have a balanced number of participants in each task force working group and the time frame for establishing the task force.

In answering Member Dutra, City Manager Vides spoke about requirements for those interested in being part of the different working groups.

Mayor Pro Tempore Orozco expressed support for creating the homelessness task force with various working groups focusing on specific areas.
