

**THIRD AMENDMENT TO CONSULTANT SERVICES CONTRACT  
BETWEEN THE CITY OF WATSONVILLE  
AND LUHDORFF & SCALMANINI CONSULTING ENGINEERS, INC.**

**THIS THIRD AMENDMENT TO CONTRACT** for consultant services is entered into by and between the **City of Watsonville** ("City") and **Luhdorff & Scalmanini Consulting Engineers, Inc.** ("Consultant") this day of \_\_\_\_\_. The City and Consultant agree as follows:

**RECITALS**

**WHEREAS**, City and Consultant have previously executed a Consultant Services Contract for Plan and Design of a New Well and Pump Station, and Develop Bid Documents dated March 10, 2020; and

**WHEREAS**, the original contract was in the amount of \$434,088.00 with an expiration date of December 31, 2021;

**WHEREAS**, a Request for Qualifications (RFQ) was issued on January 25, 2017 to design a well and pump station and develop bid documents, with the deadline for submittal of Statement of Qualifications on February 23, 2017; and

**WHEREAS**, on June 4, 2020, First Amendment was executed to amend Section 1. And Exhibit "A" both entitled "Scope of Work", and Section 4. And Exhibit "C" both entitled "Compensation", increasing the total contract amount by \$30,719.00 and bringing the total amount of the contract to \$464,807.00; and

**WHEREAS**, on July 20, 2023, Second Amendment was executed to amend Section 2. Term of Contract to June 30, 2024, and Section 3. And Exhibit "B", both entitled "Schedule of Performance".; and

**WHEREAS**, the Third Amendment of the Contract for Consultant Services is in the best interest of the City of Watsonville.

**NOW, THEREFORE**, the City and the Consultant agree that the Contract shall be amended as follows:

Section 2 is hereby amended to add the following:

***"Section 2. Term of Contract. The term of the Contract shall be extended to December 31, 2026"***

Section 3 and Exhibit "B, both entitled "Schedule of Performance" is hereby amended to read:

**All work shall be completed by December 31, 2026.**

All other terms and conditions of the Contract dated March 10, 2020, as amended, shall remain in full force and effect.
