THIRD AMENDMENT TO CONSULTANT SERVICES CONTRACT BETWEEN THE CITY OF WATSONVILLE AND A & G CLEANING SERVICES, LLC

THIS THIRD AMENDMENT TO CONTRACT for consultant services is entered into by and between the City of Watsonville ("City") and A & G Cleaning Services,

LLC., ("Consultant") this day of _______. The City and Consultant agree as follows:

RECITALS

WHEREAS, City and Consultant have previously executed a Consultant Services

Contract to revise for custodial services at the Water Resource Center (WRC) and City

Hal facilities dated January 18, 2024; and

WHEREAS, the original contract was in the amount of \$50,600 with an expiration date of November 30, 2024; and

WHEREAS, City staff solicited proposals for custodial services at Water Resource Center (WRC) and City Hall facilities, with a submittal deadline of October 20, 2023; and

WHEREAS, three proposals were submitted, and A & G Cleaning Services, LLC., was selected as the lowest priced and responsible bidder; and

WHEREAS, on November 2, 2024, the First Amendment was executed to amend the scope of work, and increase the contract compensation in the amount of \$3,000, for a revised total contract amount not to exceed \$53,600; and

WHEREAS, on January 30, 2025, the Second Amendment was executed to amend the contract term, and extend the contract to February 28, 2025; and

WHEREAS, the Third Amendment of the Contract for Consultant Services is in the best interest of the City of Watsonville.

NOW, THEREFORE, the City and the Consultant agree that the Contract shall be amended as follows:

Section 2 is hereby amended to read:

"Section 2. Term of Contract. The term of contract shall be extended to November 30, 2026."

Section 3 and Exhibit "B", both entitled "Schedule of Performance" is hereby amended to read:

"All work shall be completed by November 30, 2026."

Section 4 is hereby amended to read:

"Section 4 and Exhibit "C" both entitled "Compensation" of the Contract, are hereby amended to provide an additional amount of compensation of One Hundred Eighteen Thousand Dollars (\$118,000) for a total contract amount not to exceed \$171,600."

All other terms and conditions of the Contract dated January 18, 2024, as amended, shall remain in full force and effect.
