A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WATSONVILLE APPROVING SECOND AMENDMENT TO CONTRACT FOR PROFESSIONAL SERVICES BETWEEN THE CITY OF WATSONVILLE AND ONPOINT GENERATORS DBA POWERGEN, INC., FOR THE GENERATOR MAINTENANCE AND REPAIR SERVICES PROJECT, NO. WW-23-01-QB, INCREASING CONTRACT COMPENSATION IN THE AMOUNT OF \$73,234.80, FOR A REVISED TOTAL CONTRACT AMOUNT OF \$150,056.74, EXTENDING THE TERM OF THE CONTRACT TO DECEMBER 31, 2026; AND AUTHORIZING AND DIRECTING THE CITY MANAGER TO EXECUTE SAME

WHEREAS, a Request for Proposal (RFP) was issued on July 27, 2023, for the Generator Maintenance and Repair Services Project, No. WW-23-01-QB and awarded the contract to the lowest and qualified bidder; and

WHEREAS, on September 21, 2023, the City awarded a contract to OnPoint Generators, dba PowerGen, Inc., for generator maintenance and repair services, in the amount of \$55,116.48; and

WHEREAS, on August 27, 2024, the First Amendment was executed to amend Section 1. Scope of Services and Section 4. Exhibit "C" both entitled "Compensation" of the contract and increasing compensation in the amount of \$21,705.46; and

WHEREAS, this Second Amendment to contract will increase compensation by \$73,234.80 for a total contract amount of \$150,056.74, and extend the term to December 31, 2026, for generator maintenance and repair services.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF WATSONVILLE, CALIFORNIA, AS FOLLOWS:

1. Contracting for generator maintenance and repair services is not a project under CEQA, as it does not have the potential to result in either a direct physical change or reasonably foreseeable indirect physical change in the environment. If it is a project, it is exempt pursuant to CEQA Guidelines Section 15378(b)(5) as an administrative

activity. This contract amendment does not include any new facts or circumstances that change the determination that contracting for generator maintenance and repair services is not a project and, if so, is exempt pursuant to Section 15378(b)(5).

2. The Second Amendment to Contract between the City of Watsonville and OnPoint Generators, dba PowerGen Inc., a copy of which is attached hereto and incorporated herein by this reference, is hereby approved.

3. The City Manager is hereby authorized and directed to execute the said Second Amendment to Contract for and on behalf of the City of Watsonville with minor revisions that may be approved by the City Manager and the City Attorney.
