6.a. ORAL COMMUNICATIONS FROM THE PUBLIC (2 MINUTES)

Marta Bulaich, District 1, expressed concerns with land use issues regarding Ceiba School and ethics with City government. (She submitted a letter to the Council)

Mr. Katsuyama, District 6, stated that he and his family were being harassed by a neighbor. He expressed concerns with that neighbor continuously parking multiple vehicles along the street. He requested Council's assistance. (He submitted photos to Council)

Tina Katsuyama stated her concerns with signage on Logan Street being removed and with the City's response to her concerns regarding parking violations.

Bernie Gomez, District 1, spoke about racial disparity affecting people of color. He requested the City allocate funding and identify a plan to address the issue.

Kelly Siefke expressed concerns with Council Member Dutra's legal issues and inquired whether money received by Council was considered compensation or a stipend. (She submitted a document to Council.)

Member Dutra stated his concerns with the City's response to an issue brought forward by residents of Logan Street and requested a different solution be explored. He responded to a member of the public who expressed concerns about him. He requested the City explore alternative ways to respond to resident concerns.

Member Parker spoke about budget and position vacancy issues faced by Public Works & Utilities. She stated there would be a District 7 meeting the following Thursday and spoke about flooding concerns in areas of her district.

Member Montesino stated it was necessary to explore available resources to address street cleaning concerns.

Mayor Orozco provided updates regarding various meetings she participated in and proclamations she presented. She invited the public to participate in the Citywide District Based Survey and to submit nominations for the Cesar Chavez Community Awards. She thanked Library staff for organizing Bibliovan tours throughout the City.

- 9.a. NETHERLANDS TRANSPORTATION STUDY VISIT PRESENTATION BY ECOLOGY ACTION MOBILITY TRANSFORMATION DIRECTOR MATT MILLER

In answering Member Parker, Ecology Action Mobility Transformation Director Miller stated that Ecology Action had paid costs of the visit for the City's delegates.

Assistant Public Works & Utilities Director Fontes, in answering Member Parker, spoke about various causes of traffic collisions and community engagement efforts.

In answering Member Parker, Ecology Action Mobility Transportation Director Miller spoke about required pedestrian and bicycle safety education in the Netherlands. He stated the layout and infrastructure of streets and roads in the Netherlands encouraged safer behaviors.

Interim Community Development Director Meek, in answering Member Parker, spoke about the infrastructure of a Netherlands city comparable in size to Watsonville.

Member Quiroz-Carter provided additional details regarding differences between road infrastructure in the Netherlands versus the United States, specifically in Watsonville.

9.b. CITY MANAGER'S UPDATE REPORT

In answering Member Dutra, City Manager Vides spoke about the current street sweeping program and related signage. She stated there was no planned reduction to street sweeping services and spoke about exploring changes to signage as needed.

City Manager Vides, in answering Member Parker, spoke about potential concerns with Federal and State funding for housing efforts. She also spoke about the upcoming District 7 community meeting.

2) City Council Clarifying & Technical Questions

In answering Member Clark, City Manager Vides stated reasons the Wayfinding Project would be funded by the General Fund instead of American Rescue Plan Act (ARPA) funds, as originally planned.

Administrative Services Director Duran, in answering Member Quiroz-Carter, stated the City was already recruiting an economic development position.

In answering Member Parker, Administrative Services Director Duran spoke about the Hospital Reserve fund balance.

City Manager Vides provided additional details regarding the City's responsibility as a cosigner on a loan requested by Watsonville Community Hospital.

In answering Member Parker, Administrative Services Director Duran spoke about the tax revenue received from eligible hotels in the City.

City Manager Vides spoke about the status of two planned hotel developments.

In answering Member Parker, Administrative Services Director Duran provided details regarding Measure R funds.

Member Parker highlighted the importance of industrial businesses as job providers in the community. She requested information regarding the decrease in supplemental tax collections, the increase in median age of City residents, and changes in amounts of building application reviews and inspections.

In answering Member Parker, City Manager Vides spoke about the changes in building application review and building inspection requests.

City Manager Vides answered Member Montesino's question regarding the status of the Wayfinding Program and reopening of the City's landfill.

In answering Member Clark, City Manager Vides stated there was already a contractor selected for the Wayfinding Program.

Member Clark expressed concerns regarding the amount of funding dedicated to the Wayfinding Program and potential to utilize funds for other purposes.

City Manager Vides stated staff was exploring additional areas and projects in which to invest funding.

Mayor Orozco thanked staff for meeting with her to answer questions regarding the budget and efforts to plan for investment in the community.

In answering Mayor Orozco, Police Chief Zamora provided details regarding functions of the Police Civilian Manager position that was approved earlier.

Administrative Services Director Duran answered Member Parker's questions regarding legal fees paid through December, allocated funding for that purpose, and recovering legal fees regarding Ceiba School litigation.

3) Public Comments

Bernie Gomez, District 1, spoke about the possibility of directing funds towards community activities and considering the quality of life of residents.
