A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WATSONVILLE APPROVING THE FOURTH AMENDMENT TO CONTRACT FOR CONSULTANT SERVICES BETWEEN THE CITY OF WATSONVILLE AND TRAFFIC PATTERNS, LLC., FOR ON-CALL TRAFFIC ENGINEERING SERVICES, INCREASING COMPENSATION IN THE AMOUNT OF \$125,000, FOR A REVISED TOTAL CONTRACT AMOUNT OF \$505,000 AND EXTENDING THE TERM TO JUNE 30 2026; AND AUTHORIZING AND DIRECTING THE CITY MANAGER TO EXECUTE THE SAME

WHEREAS, on December 22, 2021, the City executed a contract with Traffic Patterns, LLC. (TP), for On-Call Services for Design Review and Off-site Improvement Concept Plans in an amount not to exceed \$95,000, and a contract expiration date of June 30, 2024; and

WHEREAS, on February 27, 2024, the City Council adopted Resolution No. 27-24 (CM), approving the First Amendment to Contract, increasing the contract compensation in the amount of \$95,000, for a total contract amount not to exceed \$190,000; and

WHEREAS, on May 28, 2024, the City Council adopted Resolution No. 90-24 (CM) approving Second Amendment to Contract and increasing the contract compensation, in the amount of \$95,000 for a total amount not to exceed \$285,000 and extending the Contract Term to June 30, 2025; and

WHEREAS, on February 11, 2025, the City Council adopted Resolution No. 27-25 (CM) approving Third Amendment to Contract and increasing the contract compensation in the additional amount of \$95,000 for a total amount not to exceed \$380,000; and

WHEREAS, this Fourth Amendment to Contract will increase compensation by \$125,000 for a total contract amount not to exceed \$505,000 and extend the contract term from June 30, 2025 to June 30, 2026; and

WHEREAS, additional funding is needed to ensure that the On-Call Traffic Services for Design Review, Traffic Engineering Studies, Traffic Analysis Review, Private Development Site Plan Review and Off-Site Improvement Concept Plans Services can continue through fiscal year 2025-2026.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF WATSONVILLE, CALIFORNIA, AS FOLLOWS:

1. Adopting a contract for project management services with Traffic Patterns, LLC. does not meet CEQA's definition of a "project," because the action does not have the potential for resulting in either a direct physical change in the environment or a reasonably foreseeable indirect physical change in the environment. This amendment poses no new impacts that have not been previously considered.

2. The Fourth Amendment to the Contract between the City of Watsonville and Traffic Patterns, LLC., a copy of which is attached hereto and incorporated herein by this reference, is hereby approved.

3. The City Manager is hereby authorized and directed to execute said Amendment for and on behalf of the City of Watsonville with minor revisions that may be approved by the City Manager and the City Attorney.
