#### FOURTH AMENDMENT TO CONSULTANT SERVICES CONTRACT BETWEEN THE CITY OF WATSONVILLE AND GLOBAL CONCEPTS

THIS FOURTH AMENDMENT TO CONTRACT for consultant services is entered

into by and between the City of Watsonville ("City") and Global Concepts ("Consultant")

#### RECITALS

WHEREAS, City and Consultant have previously executed a Consultant Services Contract to revise for Office Space Design Services and Installation of Cubicle Office Furniture dated October 12, 2020; and

WHEREAS, the original contract was in the amount of \$96,000 with an expiration date of October 9, 2022; and

WHEREAS, subdivision (c) of § 3-5.210 exempts supplies and materials which are unique, available only from one source, or sought to match existing equipment or supplies already in use (also known as a sole source purchase); and

WHEREAS, Global Concepts carries office products and pre-owned office furniture that match with the City's office furniture; and

WHEREAS, on August 10, 2023, First Amendment was executed to amend Section 2. Term of Contract, and Section 3. and Exhibit "B" both entitled Schedule of Performance, to be extended to June 30, 2024; and

WHEREAS, on September 12, 2023, the City Council adopted Resolution No. 175-23 (CM) approving the Second Amendment and increasing the contract amount by \$95,000 for a revised total contract amount of \$191,000; and WHEREAS, on December 30, 2024, the City Council adopted Resolution No. 245-

24 (CM) approving the Third Amendment to amend Section 2. Term of Contract, and Section 3. and Exhibit "B" both entitled "Schedule of Performance", to be extended to June 30, 2025; and

**WHEREAS**, the Fourth Amendment of the Contract for Consultant Services is in the best interest of the City of Watsonville.

NOW, THEREFORE, the City and the Consultant agree that the Contract shall be

amended as follows:

Section 2. is hereby amended to add the following:

# "Section 2. Term of Contract. The term of the Contract shall be extended to June 30, 2026."

Section 3. and Exhibit "B", both entitled "Schedule of Performance" is hereby amended to read:

#### "All work shall be completed by June 30, 2026."

All other terms and conditions of the Contract dated October 12, 2020, as amended, shall remain in full force and effect.
