FIRST AMENDMENT TO CONSULTANT SERVICES CONTRACT BETWEEN THE CITY OF WATSONVILLE AND HARRIS & ASSOCIATES, INC.

THIS FIRST AMENDMENT TO CONTRACT for consultant services is entered into by and between the **City of Watsonville** ("City") and **Harris & Associates, Inc.,** ("Consultant") this day of ______. The City and Consultant agree as follows:

RECITALS

WHEREAS, on June 25, 2024, City Council adopted Resolution No. 115-24 (CM) approving a Consultant Services Contract with Harris & Associates, Inc., for On-Call Engineering and Development Review Services; and

WHEREAS, the original contract was in the amount of \$200,000 with an expiration date of June 30, 2025; and

WHEREAS, under subdivision (a) of § 3-5.210 of the Municipal Code provides that an exemption from the purchasing process requirements if an emergency requires that a contract be placed with the nearest due to the vacancy of Principal Engineer and the recruitment process not yielding qualified candidates, staff requested a proposal from Harris & associates, Inc., for on-call engineering services and development review services; and

WHEREAS, the City has extended the term of contract and added to the compensation; and

WHEREAS, the First Amendment of the Contract for Consultant Services is in the best interest of the City of Watsonville.

NOW, THEREFORE, the City and the Consultant agree that the Contract shall be amended as follows:

1

Section 2. is hereby amended to read as follows:

"Section2. Term of Contract. The term of the Contract shall be from July 1, 2024, to June 30, 2026, inclusive."

Section 3. and Exhibit "B", both entitled "Schedule of Performance" is hereby amended to read as follows and shall supersede the original completion schedule date:

"All work shall be completed by June 30, 2026."

Section 4 and Exhibit "C" are hereby amended to read:

"Section 4 and Exhibit "C" both entitled "Compensation" of the Contract, are hereby amended to provide an additional amount of compensation of One Hundred and Fifty Thousand Dollars (\$150,000) for professional services, increasing the total obligation of the City from \$200,000 to \$350,000.

All other terms and conditions of the Contract dated July 1, 2024, as amended,

shall remain in full force and effect.
