**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
WATSONVILLE APPROVING PLANS AND SPECIFICATIONS AND
CALLING FOR BIDS FOR THE 2025 PAVEMENT REPAIR PROJECT,
NO. ST-25-15187 (ESTIMATED COST OF \$2,358,000 WILL BE FUNDED
FROM THE SB1 TRANSPORTATION FUND)**

WHEREAS, at its February 11, 2025, meeting, Council approved Resolution No. 43-25 (CM), accepting the City of Watsonville 2024 Pavement Management Program Update Report. The Report assessed the condition of existing city roads and provided a six-year plan of pavement projects; and

WHEREAS, projects identified in Year 1 of the Pavement Management Program have been included in the 2025 Pavement Repair Project, No. ST-25-15187, design has been completed, and the project is ready for advertisement to bid.

**NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY
OF WATSONVILLE, CALIFORNIA, AS FOLLOWS:**

1. This action is exempt from the requirements of the California Environmental Quality Act (CEQA) in accordance with CEQA Guidelines Section 15378(b)(5), in that adopting a Resolution approving plans and specifications and calling for bids for the 2025 Pavement Repair Project does not meet CEQA's definition of a "project," because the action does not have the potential for resulting in either a direct physical change in the environment or a reasonably foreseeable indirect physical change in the environment and if a "project," is exempt under the "common sense" exception (14 Cal. Code Regs. § 15061(b)(3)) because it can be seen with certainty that there is no possibility that this action may have a significant effect on the environment.

2. That the plans and specifications for the 2025 Pavement Repair Project, No. ST-25-15187, copies of which are on file in the Office of the City Clerk and

incorporated by reference in this Resolution, are hereby approved.

3. That the Purchasing Officer is hereby authorized and directed to call for public competitive sealed bids in accordance with Title 7, Chapter 14 of the Watsonville Municipal Code for the above named project, and that the bids are to be opened through the City's electronic procurement bidding portal, on approximately Tuesday, July 29, 2025, at 3:00PM, and the City Clerk is hereby directed to give notice inviting such sealed bids in the time, form, and manner provided by law.

4. That electronic bids shall be delivered to the City of Watsonville Purchasing Office in a manner identified in the bid documents.

5. That after the bids are opened, they shall be tabulated and analyzed and a report submitted to the City Manager, who shall recommend the awarding, or other action, to the Council at its next regular meeting, or as soon thereafter as possible.
