A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WATSONVILLE APPROVING THIRD AMENDMENT TO CONTRACT FOR PROFESSIONAL SERVICES BETWEEN THE CITY OF WATSONVILLE AND BEAR ELECTRICAL SOLUTIONS, LLC, A LIMITED LIABILITY COMPANY, FOR CITY-WIDE STREETLIGHT MAINTENANCE, PROJECT NO. TR-23-14011, INCREASING CONTRACT COMPENSATION IN THE AMOUNT OF \$150,000 FOR A REVISED TOTAL CONTRACT AMOUNT OF \$450,000; AUTHORIZING A BUDGET APPROPRIATION IN THE AMOUNT OF \$35,000 FROM THE GENERAL FUND (0150), AND AUTHORIZING AND DIRECTING THE CITY MANAGER TO EXECUTE SAME

WHEREAS, On July 18, 2023, the City Council adopted Resolution No. 145-23 (CM) awarding a contract to Bear Electrical Solutions, Inc., a corporation, for City-wide Streetlight Maintenance, Project No. TR-23-14011, in an amount not to exceed \$100,000 per year with the option to extend by one year for up to two additional years; and

WHEREAS, on October 23, 2024, the City executed the First Amendment to contract, extending the contract term to July 18, 2025; and

WHEREAS, on October 6, 2025, the City executed the Second Amendment to Contract, extending the contract term to July 18, 2026; and

WHEREAS, additional funding is needed to ensure that the on-call services for streetlight maintenance and repairs can continue for the remainder of the term of the contract.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF WATSONVILLE, CALIFORNIA, AS FOLLOWS:

1. No additional California Environmental Quality (CEQA) review is required for the Contract Amendment with Bear Electrical Solutions, Inc. On July 18, 2023, the City Council declared the City-wide Streetlight Maintenance as exempt in accordance with CEQA Guidelines Section 15378 (b)(5), as it does not meet CEQA's definition of a

“project”. This Third Amendment does not add any new or more significant impacts that have not already been analyzed.

2. The Third Amendment to the Contract between the City of Watsonville and Bear Electrical Solutions, Inc., a corporation, a copy of which is attached hereto and incorporated herein by this reference, is hereby approved.

3. That the budget appropriation of \$35,000 from the General Fund [0150] to budget account 0150-510-7333 is hereby authorized.

4. The City Manager is hereby authorized and directed to execute said Amendment for and on behalf of the City of Watsonville with minor revisions that may be approved by the City Manager and the City Attorney.
