

**SECOND AMENDMENT TO CONSULTANT SERVICES CONTRACT
BETWEEN THE CITY OF WATSONVILLE
AND HARRIS & ASSOCIATES, INC.**

THIS SECOND AMENDMENT TO CONTRACT for consultant services is entered into by and between the **City of Watsonville** ("City") and **Harris & Associates, Inc.** ("Consultant") this of _____. The City and Consultant agree as follows:

RECITALS

WHEREAS, on December 12, 2023, the City Council adopted Resolution No. 238-23 (CM) approving contract with Harris & Associates, Inc. for the Municipal Services Center (MSC) Improvements, Design Build, Project Management, and Environmental Documentation Services; and

WHEREAS, the original contract was in the amount of \$327,801 with an expiration date of December 31, 2024; and

WHEREAS, a Request for Qualifications (RFQ) asking for qualified consultants to assist the City with on-call design and construction management services was issued with a submittal deadline on August 15, 2020; and

WHEREAS, a list was developed for qualified consultants for on-call design and construction management services and Harris & Associates, Inc. is on this list; and

WHEREAS, Harris & Associates, Inc. submitted a proposal for the Municipal Services Center (MSC) Improvements, Design Build, Project Management, and Environmental Documentation Services and Public Works Administration reviewed and accepted the proposal; and

WHEREAS, on January 28, 2025, First Amendment was executed to amend Section 2. Term of Contract to December 31, 2025; and

WHEREAS, the Second Amendment of the Contract for Consultant Services is in the best interest of the City of Watsonville.

NOW, THEREFORE, the City and the Consultant agree that the Contract shall be amended as follows:

Section 2 is hereby amended to add the following:

"Section 2. Term of Contract. The term of the Contract shall be extended to December 31, 2026."

Section 3. and Exhibit "B", both entitled "Schedule of Performance" is hereby amended to read:

"All work shall be completed by December 26, 2026."

All other terms and conditions of the Contract dated January 8, 2024, as amended, shall remain in full force and effect.
