A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WATSONVILLE AWARDDING CONTRACT TO EUROFINS ENVIRONMENTAL TESTING SOUTHWEST, LLC., IN AN AMOUNT NOT TO EXCEED \$160,997 FOR THREE YEARS FOR LANDFILL GROUNDWATER ANALYSIS SERVICES REGULATORY COMPLIANCE AND AUTHORIZING AND DIRECTING THE CITY MANAGER TO EXECUTE SAME

WHEREAS, § 3-5.500 of the Municipal code provides that an RFP or RFQ process is found to be an effective and efficient way to procure professional services and procurement of professional services shall be based on proposals solicited from capable professionals and be evaluated based on a combination of factors including education, training, experience and demonstrated competence and professional qualifications necessary for the satisfactory performance of the services required; and

WHEREAS, § 3-5.540 of the Municipal Code provides that contracts for professional services estimated to cost more than One Hundred Thousand and no/100ths (\$100,000.00) Dollars must be awarded by the Council, and that the selection will be based on demonstrated competence and on the education, training and experience and professional qualifications necessary for the satisfactory performance of the services required, that cost will not be the only basis for selection, use a qualifications-based selection process as described in subdivision (a) of § [4527](#)¹ of the California Government Code and negotiated as described in § [4528](#); and

WHEREAS, written cost proposals were requested from four qualified laboratories in December 2025 to assist the City with landfill groundwater testing and analysis; and

WHEREAS, three qualified firms submitted a scope and fee cost proposal to provide the requested services; and

WHEREAS, staff has reviewed the proposals received and the City Manager has recommended that the proposal from Eurofins Environmental Testing Southwest, LLC. be accepted as the best response.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF WATSONVILLE, CALIFORNIA, AS FOLLOWS:

1. This action is exempt from the requirements of the California Environmental Quality Act (CEQA) in accordance with CEQA Guidelines Section 15378(b)(5), in that adopting a Resolution awarding contract to Eurofins Environmental Testing Southwest, LLC., for landfill groundwater testing and analysis services does not meet CEQA's definition of a "project," because the action does not have the potential for resulting in either a direct physical change in the environment or a reasonably foreseeable indirect physical change in the environment and if a "project," is exempt under the "common sense" exception (14 Cal. Code Regs. § 15061(b)(3)) because it can be seen with certainty that there is no possibility that this action may have a significant effect on the environment.

2. The Council hereby awards a contract to Eurofins Environmental Testing Southwest, LLC for groundwater testing and monitoring, in an amount not to exceed \$160,997.00 over a three year term and a copy of the Contract for groundwater testing and monitoring between the City of Watsonville and Eurofins Environment Testing Southwest, LLC., which is attached hereto and incorporated herein by this reference, is hereby approved.

3. The City Manager is hereby authorized and directed to execute said contract for and on behalf of the City of Watsonville with minor revisions that may be approved by the City Manager and the City Attorney.
