A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WATSONVILLE AWARDING CONTRACT TO SWT ENGINEERING, INC., A CORPORATION, FOR CONSULTING SERVICES FOR THE WATSONVILLE LANDFILL PHASE IV DEVELOPMENT DESIGN, PERMITTING, CONSTRUCTION SUPPORT, AND CONSTRUCTION QUALITY ASSURANCE (CQA) SERVICES, IN AN AMOUNT NOT TO EXCEED \$399,138, AND AUTHORIZING AND DIRECTING THE CITY MANAGER TO EXECUTE SAME (\$399,138 WILL BE FUNDED BY THE CAPITAL IMPROVEMENT PROGRAM (CIP) CONTINGENT UPON APPROVAL)

WHEREAS, Section 3-5-500 of the Municipal code provides that a Request for Proposals (RFP) or Request for Qualifications (RFQ) process is found to be an effective and efficient way to procure professional services and procurement of professional services shall be based on proposals solicited from capable professionals and be evaluated based on a combination of factors including education, training, experience and demonstrated competence and professional qualifications necessary for the satisfactory performance of the services required

WHEREAS, § 3-5.540 of the Municipal Code provides that contracts for professional services estimated to cost more than One Hundred Thousand and no/100ths (\$100,000.00) Dollars must be awarded by the Council, that cost will not be the only basis for selection, use a qualifications-based selection process as described in subdivision (a) of § 4527¹ of the California Government Code and negotiated as described in § 4538, be based on factors including those in subdivision (a) of § 4527 and that results be the best value to the City, based on demonstrated competence and on the education, training and experience and professional qualifications necessary for the satisfactory performance of the services required.

WHEREAS, a Request for Proposals (RFP) was issued on March 17, 2021, for consulting services for the Watsonville Landfill Phase IV Development Design, Permitting, Construction Support and CQA Services; and

WHEREAS, the deadline for submittal of Request for Proposals was April 30, 2021; and

WHEREAS, City staff ranked the proposals received for the consideration of the City

Manager and submission to the City Council; and

WHEREAS, the City Manager has recommended that the proposal from SWT Engineering, Inc., a corporation, in an amount not to exceed \$399,138, be accepted as the best response.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY
OF WATSONVILLE, CALIFORNIA, AS FOLLOWS:

- 1. That the proposal of SWT Engineering, Inc., a corporation, in an amount not to exceed \$399,138, is hereby accepted.
- 2. That the Contract for Consultant Services between the City of Watsonville and SWT Engineering, Inc., a corporation, for consulting services for the Watsonville Landfill Phase IV Development Design, Permitting, Construction Support and CQA Services, a copy of which Contract is attached hereto and incorporated herein by this reference, is fair and equitable and is hereby ratified and approved.
- Consultant shall file FPPC form 700s and 805s pursuant to section 19 of the
 Contract.
- 4. That the City Manager be and is hereby authorized and directed to execute the Contract for and on behalf of the City.
 - 5. That all other proposals are hereby rejected.
