A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WATSONVILLE ACCEPTING A \$73,872 STATE OF CALIFORNIA ALCOHOL POLICING PARTNERSHIP (APP) PROGRAM GRANT ADMINISTERED BY THE DEPARTMENT OF ALCOHOLIC BEVERAGE CONTROL FOR FISCAL YEAR 2021-2022 TO REDUCE CRIME AND PUBLIC NUISANCE PROBLEMS ASSOCIATED WITH ALCOHOL BEVERAGE OUTLETS IN THE CITY; AUTHORIZING AND DIRECTING THE CITY MANAGER OR HIS DESIGNEE TO EXECUTE ANY NECESSARY DOCUMENTS; AND APPROPRIATING SUCH FUNDS TO THE SPECIAL GRANTS FUND

WHEREAS, the Watsonville Police Department submitted a grant proposal to the State of California Alcohol Policing Partnership (APP) Grant Program administered by the Department of Alcoholic Beverage Control (hereafter referred to as ABC) to reduce crime and public nuisance problems associated with alcohol beverage outlets in the City; and

WHEREAS, the City of Watsonville was awarded a \$73,872 grant by the California

Department of Alcoholic Beverage Control for Fiscal Year 2021-2022; and

WHEREAS, the City of Watsonville desires to undertake a certain project designated to reduce alcohol-related disorder issues in the City to be funded in part from funds made available through the Alcohol Policing Partnership Program (APP) administered by ABC.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY
OF WATSONVILLE, CALIFORNIA, AS FOLLOWS:

- 1. That the \$73,872 grant from the California Department of Alcoholic Beverage Control for Fiscal Year 2021-2022 is hereby accepted.
- 2. That the City Manager of the City of Watsonville or his designee is hereby authorized and directed to execute in the name of the City of Watsonville, any and all documents required by the California Department of Alcoholic Beverage Control,

including any extensions or amendments thereof and any subsequent contract with the State in relation thereto.

- 3. It is agreed that any liability arising out of the performance of this contract, including civil court actions for damages, shall be the responsibility of the grant recipient and the authorizing agency. The State of California and ABC disclaim responsibility for any such liability.
- 4. That the grant funds received hereunder shall not be used to supplant expenditures controlled by this body.
  - 5. It is also agreed that this award is not subject to local hiring freezes.
- 6. That the \$73,872 grant is hereby appropriated to the Special Grants Fund [0260].
