5. PRESENTATIONS & ORAL COMMUNICATIONS

5.a ORAL COMMUNICATIONS FROM THE PUBLIC

Steve Trujillo, District 7, stated his concerns with K-mart closing and the impacts it would have on the shopping center and surrounding neighborhoods. He asked staff to address homelessness around that area and to revitalize the shopping center.

Eli asked for an update on the sale of the Porter building to Pájaro Valley Arts and requested that the City support the arts.

Celeste stated her concerns with the criminal justice system's impact on minorities. She spoke about the death of Tamarío Smith while in custody and questioned why Council had not requested an independent investigation into the matter.

5.b ORAL COMMUNICATIONS FROM THE COUNCIL

Member García spoke about her participation in Pájaro Valley Community Health Trust's retreat and highlighted their work in the Health Trust's Strategic Plan. She requested the City work with Pájaro Valley Health Trust to create a community garden at the corner of Main Street and Pennsylvania Drive and to work with them on a Health in All Policies ordinance.

Member Estrada thanked Teresa Martinez for her efforts in revitalizing the Carey/Davis Community Gardens, as well as other volunteers and organizations that contributed. He spoke about his participation in the trash pick-up day at the slough and thanked Jeanie O'Donnell for leading these cleaning efforts.

Member Hurst wished all fathers a happy Father's Day and thanked them for their work in the community.

Member Montesino thanked the public for attending the meeting and expressed his desire to hear the public's comments, especially those relating to the budget.

Mayor Pro Tempore Parker spoke about her attendance of the opening of the Women's Business Center, in partnership with El Pájaro Community Development Corporation. She spoke about her meeting with County Supervisor Caput regarding the Pájaro River Levee and thanked staff for installing mile markers. She invited the public to the Pájaro Valley Chamber of Commerce Mixer at Staff of Life on June 24.

Member González wished everyone a happy Father's Day. He asked the public to participate in the upcoming Santa Cruz Metropolitan Transit District's Board Meeting to advocate for pursuit of grant funding for establishment of an operations and maintenance facility for buses.

Mayor Dutra spoke about several events he attended over the previous weeks. He encouraged each Council Member to work with residents to establish District clean-up events. He invited the public to participate in the City' Fourth of July festivities.

9.a CONSIDERATION OF FISCAL YEARS 2021-22 & 2022-23 BUDGET & RELATED ACTIONS

1) **Staff Report by Administrative Services Director Czerwin**

2) **City Council Clarifying & Technical Questions**

Administrative Services Director Czerwin and City Manager Huffaker, in answering Member García, explained the process for amending the proposed budget. City Manager Huffaker stated a supplemental budget including the American Rescue Plan would be brought to Council in the Fall.

Member García asked Administrative Services Director Czerwin to respond to a petition received by Council from members of the community which requested \$4.3 million be taken from Police and distributed among other departments.

In answering Member González, Assistant Police Chief Sims spoke about the impacts of reducing the Police Department's budget by \$4.3 million.

3) **Public Hearing**

Maria Elena de la Garza, District 2, thanked staff for conducting an additional town hall meeting to allow for public input on the budget. She spoke about the importance of prioritizing equity during the budget process.

Steve Trujillo asked Council to be thoughtful when making any changes to the budget and increase funding for the Library and Parks & Community Services. He requested that all fireworks be made illegal in Watsonville.

Bernie Gomez, MILPA collective, stated his concerns with staff's response to the letter sent to Council regarding reallocation of Police funds to other departments and provided suggestions for reorganizing Police services.

Tony read part of the Watsonville Budget Demand Letter submitted to Council by members of the community requesting reallocation of \$4.3 million from the Police budget to other departments.

Yesenia Jimenez thanked staff for increasing funding for Parks & Community Services and the Library. She requested staff explore alternate ways for Police to provide services.

Karina Moreno, District 7, requested Council prioritize youth programs, transportation, and science programming when approving the budget. She asked Council thoroughly review the budget, reduce substantial raises, and not approve the proposed budget.

Anissa Balderas, District 2, asked Council to reallocate funds from Police budget towards other community services. She requested that Council consider placing Measure Y on the ballot.

Eli requested reduction of police services and use that funding to collaborate with community organizations to provide mental health services.

Celeste Gutierrez requested that Council reconsider the proposed budget and invest in a summer youth employment program. She asked for more investment in Parks and Community Services, infrastructure, and in aid for those recently released from incarceration.

Edgar Ibarra asked Council to focus on equity in the budget and invest in the community. He requested that Police further engage with the community.

Elias Gonzales, District 5, requested Council to prioritize community needs in the budget. He asked staff to invest in the library, parks and recreation, youth employment and sidewalks.

Itzel Godinez read part of the Watsonville Budget Demand Letter submitted to Council by members of the community requesting reallocation of \$4.3 million from the Police budget to other departments.

Fernie read part of the Watsonville Budget Demand Letter submitted to Council by members of the community requesting reallocation of \$4.3 million from the Police budget to other departments.

Cristal Gonzalez-Avila asked staff to invest in arts and spoke about her experiences as part of an immigrant family.

Juan Gomez expressed his concerns with the budget's impact on the community and asked for reallocation of \$4.3 million from the Police budget to community programs.

Vanessa Quiroz-Carter spoke in support of the Watsonville Budget Demand Letter. She requested more services for youth and the elderly.

Eileen Clark-Nagaoka, District 6, asked Council to reconsider the budget and reduce funding for Police. She requested that Parks & Community Services receive more funding.

Monike Tone asked staff to be considerate of the homeless population that lives near the Pájaro River, particularly during the Pájaro River Levee Improvements Project.

Andrea del Carmen Vazquez read part of the Watsonville Budget Demand Letter submitted to Council by members of the community requesting reallocation of \$4.3 million from the Police budget to other departments.

Brenda Blake requested hiring of additional police officers for patrol and asked for the return of the Coffee with a Cop program.

Jessica Carrasco thanked the City for funding Ramsay Park renovations. She requested increased funding for Parks & Community Services and the Library. She asked the City to provide job opportunities for youth and college graduates.

Xitlali, District 2, expressed her concerns with lack of investment from the City in assisting marginalized communities. She asked for investment in the City's infrastructure and create opportunities for youth.

Gabriel Medina requested that Council reallocate funding from Police to other City services.

Karen Chavez spoke about the effectiveness of various crime prevention programs in the City and requested that Council prioritize equity when considering the budget.

Member González expressed his concerns with the Watsonville Budget Demand Letter and expressed support for youth employment programs. He spoke about the need for continued conversation on the budget.

Mayor Pro Tempore Parker spoke about the necessity for approval of the CalPERS smoothing reserve resolution.

Member Hurst spoke about his past experience with school budgets and the need for collaboration to create a balanced budget.

Member Estrada spoke about the need for continued collaboration with the public on the budget process and highlighted the additional allocations made to Parks & Community Services for the Ramsay Park renovations.

Mayor Dutra spoke about investments made in the Parks & Community Services department and stated he would wait for the Ad Hoc Committee on Policing & Social Equity's recommendations prior to considering changes to Police funding.

In answering Member García, Environmental Projects Manager Yasbek and Assistant Public Works & Utilities Director Rodriguez spoke about the process for determining the number of bicycles necessary to start the program, and ability to obtain more bicycles needed for City residents.

Environmental Projects Manager Yasbek, in answering Member Hurst, spoke about funding for the proposed program.

In answering Member Estrada, Assistant Public Works & Utilities Director Rodriguez spoke about existing Bike Smart and Walk Smart safety programs in partnership with Ecology Action to prevent pedestrian accidents.

In answering Member González, Environmental Projects Manager Yasbek spoke about the process for selecting a vendor to provide the bike share program. He stated the program would include a balancing service to ensure bicycles are returned to the proper locations. Public Works & Utilities Director Palmisano explained the request for proposal process for the proposed program.

Community Development Director Merriam, in answering Member González, spoke about the possibility of reduced rental fees for low income community members.

In answering Mayor Dutra, Community Development Director Merriam spoke about the possibility of the City obtaining revenue from the program.

Environmental Projects Manager Yasbek, in answering Mayor Dutra, spoke about potential for the City to obtain scooters for public use, independently from the program,
