A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WATSONVILLE OVERRULING OBJECTIONS, IF ANY, AND ORDERING ABATEMENT OF A PUBLIC NUISANCE ON 26 LOTS OF PRIVATE PROPERTY OF THE SUNSHINE GARDENS SUBDIVISION, TRACT 1587, WATSONVILLE, CALIFORNIA, (NEAR 1773 SANTA VICTORIA AVENUE), PURSUANT TO CHAPTER 5-17 OF THE WATSONVILLE MUNICIPAL CODE

WHEREAS, on July 6, 2021, the City Council adopted Resolution No. 207-21 (CM) declaring that the condition of the property at or near 1773 Santa Victoria Avenue, Watsonville, California, consisting of 26 partially constructed units of residential buildings possibly being injurious to health, indecent, offensive to the senses, and a public nuisance and possibly be abated or removed in order to protect the public health, safety and welfare; and

WHEREAS, a public hearing was set and noticed for Tuesday, August 24, 2021, at 6:30 p.m., in the City Council Chambers, 275 Main Street, 4th Floor, as the time and place for a public hearing to hear any objection to the proposed destruction or removal of the public nuisance.

WHEREAS, in accordance with Executive Orders N-33-20 and N-29-20, this public hearing will be held virtually via Zoom at https://cityofwatsonville-org.zoomgov.com/j/1604661504 without a physical location from which members of the public may observe and offer public comment.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY
OF WATSONVILLE, CALIFORNIA AS FOLLOWS:

1. That any and all objections to the proposed clearance of specified structures, and abandoned personal property, trash and debris upon the private property identified as lots 3-28 inclusive of Tract 1587 as reported by the Building Official are hereby overruled.

That the Building Official is hereby authorized and directed to abate such nuisance or cause the same to be abated, by having such nuisance removed by any legal method, and the Building Official and his deputies, assistants, employees, contracting agents, or other representatives are hereby expressly authorized to enter upon said private property for that purpose.
