# 5. PRESENTATIONS & ORAL COMMUNICATIONS

#### 5.a ORAL COMMUNICATIONS FROM THE PUBLIC

Steve Trujillo expressed his concerns with the use of illegal fireworks during Fourth of July and requested fireworks be banned in Watsonville. He suggested non-profit organizations find alternatives to selling fireworks to raise funds.

Eli spoke about her concerns with the process for conducting City meetings and requested a process for filing complaints against Council. She requested funding from the American Rescue Plan be utilized to fund youth programs.

Celeste thanked Councilmembers who met with her to discuss their vision for Watsonville. She also thanked Mayor Dutra for supporting women running for office locally and at the County level.

Michael expressed disagreement with reduction of Police funding. He spoke about his concerns with the use of Measure Y funds.

Nancy Faulstich spoke about Regeneración Pájaro Valley Climate Action's EVs for Everyone project and encouraged members of the public to visit their website and learn about rebate opportunities with electric vehicles.

Elaine Johnson, Neighborhood Courts Program Coordinator for Santa Cruz County District Attorney's Office, invited the public to volunteer to their program, especially bilingual speakers.

Assistant Police Chief Sims provided an update regarding Police response to fireworks related calls over the weekend.

Member González spoke about Pájaro Valley Little League games taking place throughout the week.

Member García spoke about her participation during the National Association of Latino Elected Officials Annual Conference. Member Estrada spoke about his participation in Empower Watsonville Coalition, led by Pájaro Valley Prevention & Student Assistance and in the Fourth of July Bike Ride. He spoke about his attendance to a one-year anniversary event honoring Federico Castaneda's passing. He expressed condolences for the passing of Eduardo Murillo.

Member Montesino asked City Manager Huffaker for an update on the annual fireworks display.

Mayor Pro Tempore Parker invited the public to visit Staff of Life and Sushi Qu. She stated she would be analyzing the budget during the summer break. She invited the public to attend Slavic

American Cultural Organization's and the Sons and Daughters of Italy Annual Scholarship barbecues.

Mayor Dutra spoke about various events he attended. He thanked Carlos Campos for his work with the Outside the Frames art event. He spoke about efforts to establish a sister city relationship with Portugal.

6. REPORTS TO COUNCIL -- No Action Required

### 6.a CITY MANAGER'S UPDATE REPORT

City Manager Huffaker, in answering Member García, spoke about the presence of the COVID-19 Delta variant in the region.

City Manager Huffaker, in answering Member Estrada, spoke about the challenges of holding hybrid meetings as well as the expiration of the Governor's emergency order allowing for virtual Brown Act meetings in September of this year.

# 6.b PRESENTATION REGARDING THE AMERICAN RECOVERY PLAN ACT (ARPA) BY ADMINISTRATIVE SERVICES DIRECTOR CZERWIN

Administrative Services Director Czerwin, in answering Member García, spoke about the potential for American Recovery Plan Act (ARPA) funding being allocated to non-profit and mental health organizations and the requirements these organizations must meet to be considered.

City Manager Huffaker answered a question from Member García about partnering with organizations to meet the need for affordable housing in Watsonville using ARPA funds. He mentioned Encompass Community Service and MidPen Housing's ongoing affordable housing project as an example.

Administrative Services Director Czerwin, in answering Member González, stated the City would include non-profits that provide youth services in its consideration of ARPA fund usage. City Manager Huffaker stated staff would bring a more comprehensive plan to Council for utilizing these funds after further analyzing federal guidelines.

Administrative Services Director Czerwin answered questions from Member Montesino about using funding for neighborhood parks and the City's fiber loop project which would provide Wi-Fi to Ramsay Park and the Plaza.

In answering Member Estrada, Administrative Services Director Czerwin spoke about the possibility of providing rental and utility bill assistance to the community regardless of immigration status.

Tony Vittal, Chief Operating Officer for U.S. Longton, Inc., stated concerns with the bidding process for Public Works projects as outlined in the Municipal Code. He stated his office did not receive sufficient notice from the City regarding Items 7.b. and 7.x.

# 1) Report by Public Works & Utilities Director Palmisano

# 2) City Council Clarifying & Technical Questions

Public Works & Utilities Director Palmisano, in answering Member González, explained how electric vehicles promote the net-negative emissions goal for Watsonville and the challenges in making them accessible to the community. He spoke about the potential infrastructure uses of back-up generators.

In answering Member Estrada, Sr. Civil Engineer Yasbek spoke about the potential for installing micro-grids in Watsonville.

Public Works & Utilities Director Palmisano, in answering Council Member Hurst, spoke about possible funding sources for achieving net-negative emissions and supporting green businesses.

In answering Mayor Dutra, Public Works & Utilities Director Palmisano spoke about the potential mileage-based tax being considered by the State and grants awarded to the City to install electric vehicle charging stations. He spoke about alternative funding sources for this purpose.

Sr. Civil Engineer Yasbek, in answering Mayor Dutra, spoke about grants to install charging stations in City-owned parking lots that staff would be applying for. Sr. Civil Engineer Yasbek stated staff was hoping to work with groups such as Ecology Action to ensure access to charging stations for all members of the community regardless of where they live.

# 3) Public Input

Pam Sexton, Regeneración volunteer, asked Council to support the net-negative emissions goal. She asked Council to analyze the budget to ensure cost effectiveness.

Steve Trujillo stated his concerns with rising gas prices and the importance of supporting electric vehicles. He requested Sr. Civil Engineer Yasbek to look into installing microgrids in Watsonville. He requested fireworks be banned in the City.

Karina Moreno thanked the Council for prioritizing climate safe goals for the community.

Nancy Faulstich, Regeneración Director, spoke about future funding opportunities for climate change initiative projects. She spoke about options for charging electric vehicles.

Anissa Balderas, District 2, spoke about the impact of climate change on low income communities. She asked Council to support youth, low income citizens and Watsonville's farmland by endorsing Climate Safe California goals.

Jessica Perez, Regeneración volunteer, asked Council to vote in favor of this item.

Celeste Gutierrez expressed her concerns with privatizing electric grids to charge vehicles. She stated the consumption of animal products contributed to global warming and asked the City not to invest in this industry.

Jo Ann Baumgartner, District 7 spoke about various ways in which the community can support the City's climate safe and net-negative emissions goals.

Eli requested Council reanalyze the budget to ensure equity. She thanked Council for taking immediate action against climate change and requested they meet other community needs.

Bernie Gomez spoke about the importance of providing incentives for the community to support the City's climate action goals. He asked Council to consider using a portion of ARPA funding to support alternative forms of transportation.

Edgar Ibarra, MILPA Collective, spoke about the impacts of gentrification on the community. He asked Council to pursue climate change goals that would benefit both current and future generations.

  - 1) Report by Community Development Director Merriam
  - 2) City Council Clarifying & Technical Questions In answering Member García, Community Development Director Merriam spoke about Santa Cruz County's approval process for the modifications. She explained that even with reduced parking, the project met requirements for residential developments. She

stated the changes to the process for soil remediation did not require a new Environmental Impact Report.

Community Development Director Merriam, in answering Mayor Pro Tempore Parker, stated the project addendum served to identify what changes were made to the original project.

City Attorney Smith, in answering Mayor Pro Tempore Parker, stated the City had never encountered any issues when working with John Fry.

John Fry, Project Manager, in answering Mayor Dutra, spoke about the process for determining price range for homes in the development. He stated this would depend on variables such as construction costs and the City's affordable housing requirements.

In answering Member Hurst, Pat Hoban, Webber, Hayes & Associates, spoke about State guidelines for toxic substance control, including soil remediation. He stated the review and approval process for the remediation had been completed. He spoke about the post-construction site management plan in place which included annual site inspections.

Community Development Director Merriam, in answering Member Montesino, spoke about the need to use Loma Vista Drive as public access for the development. She spoke about possible additional access sites that were discussed.

Mr. Fry, in answering Member Estrada, spoke about the phased process and cost of hauling away contaminated soil from the development site.

Mr. Hoban answered a question from Member Estrada regarding the potential for the contaminated soil to cause health issues. He spoke about preventative measures being taken to eliminate such risk.

Mr. Fry, in answering Member Estrada, stated a deed would be filed with the title office making potential buyers aware of the contaminated soil buried underneath the property.

Mr. Hoban, in answering Member González, explained the process for the removal of the contaminated soil. He stated compaction engineers would ensure soil compaction standards were met. Mr. Fry explained there would be no public vehicle access on Loma Vista during the first phase of the project.

In answering Mayor Pro Tempore Parker, Community Development Director Merriam stated staff agreed with the remediation process set forth by the developer. She explained the County had a pre-approved list of engineers qualified to prepare remedial action plans and stated Webber, Hayes & Associates was on that list.

Community Development Director Merriam, in answering Mayor Pro Tempore Parker, stated the item would only need to be brought back to Council in the event the County required major modifications that would change the current tentative map. She spoke about the developer's process for choosing the proposed remediation plan.

Mr. Hoban, in answering Mayor Pro Tempore Parker, spoke about confirmation sampling done on the soil to ensure all contaminated parts were removed. He stated the plan

submitted to County Health, which was based on State guidelines, was deemed appropriate.

Community Development Director Merriam answered a question from Mayor Pro Tempore Parker regarding the consequences of the item being rejected by Council. She stated the City would be left with the original project approval, which the developer did not feel was feasible.

Mr. Fry, in answering Mayor Pro Tempore Parker, listed the various modifications made by the design team he worked with over the last 10 months. He listed the various construction projects in Watsonville he has been involved in and stated he would not stay on should Council choose not to approve the modifications.

Community Development Director Merriam, in answering Member García, explained the reasons for the modified height of the roofing on the houses. Mr. Fry stated the height of the pitch of the roof was flattened, but this did not change the amount of living space or the ceiling height.

#### 3) Public Hearing

Mayor Dutra opened the public hearing.

Bob Culbertson, Watsonville Wetlands Watch, stated his concerns with the process for noticing the hearing and the availability of the modified plans for review. He said he believed the modifications should have been approved by County before being brought to Council. He further stated his concerns with the proposal to bury contaminated soil.

Noriko Akiyama Ragsac expressed her concerns with potential exposure to toxic chemicals from the contaminated soil. She asked Council to allow the public additional time to review all related documents and receive answers to questions.

Steve Trujillo stated his concerns with the contaminated soil located near a residential area. He stated the City's goals to be environmentally friendly should include developers. He asked staff to reject the proposed modifications until the County has concluded their review.

Holly Heath, Seaview Ranch Homeowners Association Board Member, requested Council postpone approval of this item to allow time for additional geotechnical analysis.

Celeste stated her concerns with the transparency and inclusivity of the public hearing process. She asked staff to consider the environmental impact caused by the development and its effects on future generations.

Carolina Portillo Franco, Seaview Ranch Homeowners Association Board Member, stated her concern with the proposed plan to bury contaminated soil. She expressed her concerns with installing a roundabout as part of the development due to the potential dangers for children, senior citizens and the disabled.

Jovita Quezada expressed concerns for children's safety with the installation of a roundabout. She further expressed concerns with the chemicals found in the contaminated soil and their potential negative health effects.

After checking if anyone in the teleconference wanted to speak on the matter and hearing none, Mayor Dutra closed the public hearing.

4) 1<sup>st</sup> MOTION: It was moved by Member González, seconded by Member García to deny the resolutions below:

#### 5) City Council Deliberation on Motion

Mayor Pro Tempore Parker stated moving forward with the project was a necessary step towards creating housing in Watsonville. She expressed her concerns with rejecting staff recommendation.

Member García expressed her concerns with the County not having yet approved the soil remediation plan, the lack of information on slope stability and seismic activity.

Member Hurst stated there was a housing crisis facing the City. He listed the potential benefits of the development for Watsonville.

Member González expressed his concerns with the cost of the development. He stated concerns with burying contaminated soil and the lack of final approval of the remediation plan by the County and enumerated past issues the City has encountered with the developer.

Community Development Director Merriam, in answering Mayor Pro Tempore Parker, explained the development agreement would be considered by Council after the Planning Commission reviewed it.

# 2) City Council Clarifying & Technical Questions

City Clerk Vázquez Flores, in answering Member García, stated the measure required signatures by 10% of voters to either be placed on the ballot or for Council to accept the signatures and approve the initiative. She stated a complete report would be brought back to Council for analysis no more than 30 days after signatures were verified.

City Attorney Smith, in answering Member García, stated Council could amend the General Plan to include the initiative or have it placed on the ballot.

In answering Mayor Pro Tempore Parker, City Attorney Smith explained the collaborative work done by various organizations to place Measure U on the ballot in 2002. He stated changes would be made to the General Plan if the Measure was allowed to expire.

In answering Member Montesino, City Attorney Smith stated the City reverted back to the 2005 General Plan, which included Measure U.

City Manager Huffaker, in answering Member Hurst, stated staff was requesting direction from the Council to move forward with preparing a comprehensive report on the initiative petition.

City Manager Huffaker, in answering Member González, explained WPA's lawsuit was largely due to what they perceived to be insufficient airport land use compatibility provisions in the 2030 General Plan.

City Manager Huffaker, in answering Mayor Pro Tempore Parker, stated the findings of the report would be shared with the Council and the public. He spoke about the potential for additional public input.

#### 3) Public Input

Sam Earnshaw spoke about other jurisdictions who have urban limit lines in place, and the potential benefits for Watsonville. He stated an urban limit line helped support growth and development within City limits. He asked Council to support renewal of the measure.

Karina Moreno spoke about the importance of protecting the wetlands. She stated her concerns with the impact gentrification would have on housing in the future. She expressed her support for renewal of the measure and asked Council to support it as well.

Eli spoke about the importance of farmland in job creation. She inquired about the cost of the report staff would prepare and stated protecting the wetlands should be a primary goal for the City. She asked staff to pursue alternative uses of open spaces within the City.

Celeste stated the renewal of Measure U would encourage creative use of the City's open spaces. She asked Council to support protecting the Earth.

Bernie Gomez asked Council to find innovative ways to use vacant spaces in the City to benefit residents. He spoke in opposition of any removal of farmland or wetlands.

4) **MOTION:** It was moved by Member Montesino and seconded by Member García to refer proposed initiative measure to City Manager to prepare a report on any or all of items allowed by California Elections Code Section 9212.

#### 5) City Council Deliberation on Motion

City Manager Huffaker, in answering Mayor Dutra, stated outside agencies would work in collaboration with City staff to prepare the report.

In answering Member García, City Manager Huffaker stated the report would include a study on potential impact to sensitive environmental areas.

City Manager Huffaker, in answering Mayor Dutra, stated the protection of environmental areas was inherent to the initiative petition. He explained the City did not plan to develop these areas.

In answering Mayor Pro Tempore Parker, City Manager Huffaker stated the process of preparing the report could include copies of both the original Measure and maps as well as proposed changes.
