Section 4 is hereby amended to read:

"Section 4 and Exhibit "C" both entitled "Compensation" of the Contract, are hereby amended to provide an additional amount of compensation of Thirty-Nine Thousand Dollars (\$39,000) and 5% contractual increase for annual subscriptions for professional services.

All other terms and conditions of the Contract dated May 17, 2020, as amended, shall remain in full force and effect.
