Steve Trujillo, District 7, thanked Mayor Dutra for recognizing Domestic Violence Awareness Month. He stated he hoped Watsonville Pilots Association would reach a settlement with the City regarding ongoing litigation. He spoke about the State housing requirements.

Kate Hinnenkamp, Community Action Board (CAB), thanked Council for the funding given to CAB's Immigration Project. She provided a report regarding scholarships awarded to students seeking to renew their DACA permitsand read a statement from a recipient. She stated there was still scholarship funding available for those in need of DACA renewal services.

Kristal Salcido thanked Mayor Dutra for recognizing Domestic Violence Awareness Month. She spoke about her work as a sexual assault prosecutor with the Santa Cruz County District Attorney's Office. She invited Council to visit the SKY Center.

Member Montesino spoke about his field trip with Parks & Community Services staff to look at all-inclusive playgrounds.

the Council. She spoke about the City's partnerships with various local art organizations and a potential ordinance to establish funding for public art.

Member Estrada spoke about events he attended over the past weeksand thanked everyone who helped organized these events.

Mayor Pro Tempore Parker spoke about events she attended over the last weeks. She thanked City staff for maintaining safe street conditions during the recent storm. She expressed appreciation for Barbie Gomez and invited the public to attend her fundraiser for Teen Challenge Monterey Bay.

Mayor Dutra invited the public to support newly opened HoneyLux Coffee on Aviation Way. He spoke about events he attended over the past weeks. He thanked everyone who collaborated in Evening with the Mayor. He invited the public to attend upcoming Halloween events.

- 9.a. CONSIDERATION OF POLICE & SOCIAL EQUITY AD HOC COMMITTEE REPORT
 - Staff Report by Assistant City Manager Vides, Interim Police Chief Sims, and Chief Facilitator Niklaus (American Leadership Forum) Jaime Molina spoke about community engagement sessions held as part of the Ad Hoc Committee's process.

Olga Diaz, COPA, spoke about the challenges faced during community input sessions regarding interactions with Police.

Mayra Bernabe, COPA, spoke about the trauma as a result of Police interaction expressed by community members. She spoke about the need for additional programs and services for the community. She offered suggestions for ensuring citizens' concerns were addressed after calling Police.

Maria Rodriguez, employment programs director of CAB, spoke about the shared safety workgroup that engaged with the community as part of the Ad Hoc Committee's process. She spoke about the impact of crime and the services needed for victims.

Suzanne Brutschy, Applied Survey Research, spoke about the responses received from community engagement sessions and surveys sent to Watsonville residents regarding quality of life, policing, and safety.

2) City Council Clarifying & Technical Questions

In answering Member García, Assistant City Manager Vides, spoke about the potential to include non-English speaking community members in future engagement efforts.

Chief Facilitator Niklaus, in answering Member García, spoke about the meaning of cultural healing as a recommendation of the Ad Hoc Committee.

Assistant City Manager Vides spoke about action proposed by the Ad Hoc Committee to achieve cultural healing. She stated staff and Council needed to collaborate on an implementation plan.

In answering Member García, City Manager Huffaker stated staff planned to move forward with implementation of the recommendations in an expeditious manner.

Interim Police Chief Sims, in answering Member Hurst, explained the meaning of "selfinitiated traffic stop" referenced in the Ad Hoc Committee's report.

In answering Member Estrada, Assistant City Manager Vides spoke about community engagement opportunities during implementation of the Ad Hoc Committee's recommendations.

3) Public Input

Anissa, Ad Hoc Committee Member, spoke about cultural healing and the need for funding arts and LGBTQ resource centers. She thanked outside organizations who conducted community input efforts. She thanked Joy Flynn for her work with the Committee. She spoke about ways the City could ensure transparency.

Jen Salinas- Holz, Ad Hoc Committee Member, spoke about the reinstatement of the School Resource Officer program. She asked that all members of the community be given the opportunity to provide input.

Elias González, District 5, thanked the Ad Hoc Committee for their work. He expressed concerns regarding racial equity in the community. He asked for an explanation regarding the resignation of Joy Flynn as a community engagement leader as part of the Committee's efforts. He asked Council to fund community programs.

Pam Sexton expressed concerns regarding conflicts of interest in implementing the recommendations of the Ad Hoc Committee. She requested Council analyze the budget to ensure equity and to fund youth programs.

Eileen Clark- Nagaoka, District 6, asked Council to fund Parks and Community Services and youth programs. She spoke about the potential benefits of implementing the CAHOOTS mental health crisis intervention program.

Eric Strum, Ad Hoc Committee Member, acknowledged the City for guiding conversations around a difficult topic. He asked for the Committee's report to be given to the future Chief of Police for implementation. He asked staff to act on the Committee's report.

Bobby Marchessault, Ad Hoc Committee Member, spoke about the challenges encountered during the Committee's process. He asked Council to implement recommendations and to provide opportunities for community input regarding the School Resource Officer program.

Nancy Faulstich, director of Regeneración Pájaro Valley Climate Action, spoke about the relationship between racial equity and climate equity. She spoke about Regeneración's Front Line Allies group's efforts to address racism issues in the community.

Steve Trujillo, District 7, asked Council to implement the Ad Hoc Committee's recommended actions. He spoke about the history of racial conflicts in the City. He asked staff to hold community engagement events at various locations, and to be inclusive of older adults and youth.

Karina Moreno, District 6, expressed support for several of the Committee's recommendations. She stated climate justice and social justice were related.

Yesenia Jimenez, District 7, spoke about the Committee's recommendation to fund Parks & Recreation Services not affiliated with the Police. She requested transparency in the handling of complaints against Police.

Kristal Salcido, Ad Hoc Committee Member, spoke about the Caminos program and the potential for expanding its services. She spoke about the Police's CARE program to respond to mental health crises.

4) **MOTION**: It was moved by Member García, and seconded by Mayor Pro Tempore Parker to approve staff recommendation.

In answering Mayor Pro Tempore Parker, City Manager Huffaker stated the City's goal was to hire a permanent Chief of Police before the end of the year.

Member García spoke about her involvement in the creation of the Ad Hoc Committee as a response to community concerns regarding the Police.

10. a. CONSIDERATION OF CLIMATE ACTION & ADAPTATION PLAN

1) Staff Report by Principal Planner Meek, Environmental Projects Manager Yasbek, and Assistant Public Works & Utilities Director Palmisano

2) City Council Clarifying & Technical Questions

In answering Member García, Environmental Projects Manager Yasbek spoke about the Community Advisory Committee.

Environmental Projects Manager Yasbek, in answering Member García, stated the City wanted to collaborate with organizations working with local farmers regarding implementation of the Climate Action Adaptation Plan (CAAP).

Assistant Public Works & Utilities Director Palmisano stated the City was working with Assemblymember Robert Rivas in support of a bill promoting regenerative agricultural practices.

Principal Planner Meek, in answering Member García, spoke about the criteria used for the Initial Study and Negative Declaration.

In answering Member Estrada, Environmental Projects Manager Yasbek explained the reasons the CCCAP did not include the light rail.

Environmental Projects Manager Yasbek, in answering Member Estrada, spoke about the importance of public access to broadband internet.

Assistant Public Works & Utilities Director Palmisano, in answering Member Estrada, stated staff would provide more frequent updates at the Council's request.

In answering Member Estrada, Environmental Projects Manager Yasbek spoke about staff's efforts to make information understandable for the public. He spoke about the change from PG&E to Central Coast Community Energy as the City's electricity provider.

Assistant Public Works & Utilities Director Palmisano stated staff planned to provide more understandable information about Central Coast Community Energy.

Environmental Projects Manager Yasbek, in answering Mayor Pro Tempore Parker, explained the need for State and Federal funding to help the public implement aspects of the Climate Action & Adaptation Plan.

Assistant Public Works & Utilities Director Palmisano stated staff worked with State legislators in pursuing funding for implementation of CAAP projects, such as electric vehicle infrastructure.

In answering Mayor Pro Tempore Parker, Environmental Projects Manager Yasbek spoke about how Parks & Community Services' Urban Forest Management Plan was connected to the Climate Action & Adaptation Plan. Environmental Projects Manager Yasbek, in answering Mayor Pro Tempore Parker, stated the City was a leader in addressing climate change issues.

In answering Member Montesino, Environmental Projects Manager Yasbek spoke about ways the community could implement changes outlined in the CAAP.

Environmental Projects Manager Yasbek, in answering Mayor Dutra, spoke about the difference in services provided for residents by PG&E and Central Coast Community Energy.

In answering Mayor Dutra, Environmental Projects Manager Yasbek spoke about a potential ordinance requiring new buildings in City limits to be all electric.

In answering Mayor Dutra, Assistant Public Works & Utilities Director Palmisano spoke about the potential to convert the City's vehicle fleet to electric, including pursuing funding.

Environmental Projects Manager Yasbek, in answering Mayor Dutra, stated the City received a grant for the purchase of an electric garbage truck.

3) Public Hearing

Mayor Dutra opened the Public Hearing.

Woody, District 7, invited the Council and public to attend Campaign for Organic and Regenerative Agriculture's (CORA) Town Hall on November 14. He spoke about the negative impacts of soil fumigants. He stated CORA was working to facilitate the transition to regenerative agriculture.

Steve Trujillo expressed concern over the decline of the monarch butterfly population. He spoke about the need for electric vehicles and asked for installation of a charging station on the Cabrillo College campus.

The following speakers spoke in support of the Climate Action Adaptation Plan and provided suggestions on actions the City could take to further address the issue: Yesenia Jiménez, District 7 Nathalie Olivas Anissa Nancy Faulstich, director of Regeneración Pájaro Valley Climate Action Stu Jenkins, District 3 Karina Moreno Pam Sexton Mayra Bernabe Eileen Clark- Nagaoka

Seeing no one else approach the podium, Mayor Dutra closed the Public Hearing.

Member García stated Watsonville was the first city to pass a resolution that declared a climate emergency and asked the Governor to take action.

Mayor Dutra spoke about the need to ensure compliance with City policies addressing environmental issues. He spoke about the importance of planting trees and other greenery to support infrastructure.

2) City Council Clarifying & Technical Questions In answering Mayor Pro Tempore Parker, Principal Planner Meek explained the reasons for the proposed storage space modifications.

Principal Planner Meek, in answering Mayor Dutra, stated the project would be the first of its type granted an exception from the required storage space per unit.

In answering Member García, Principal Planner Meek spoke about the reasons the application was submitted under Density Bonus Law.

Nick Miller, project architect, in answering Member García, stated ample bicycle storage was included as part of the project.

In answering Member García, Max Heninger, Eden Housing Project Developer, stated the size of the housing units surpassed the requirement for affordable housing set by the State. He stated outdoor communal storage space would be included.

In answering Member García, Mr. Heninger spoke about the total amount of units in the project.

Mr. Miller, in answering Mayor Pro Tempore Parker, spoke about the cost concerns that led to the modification request.

Mr. Heninger stated they had been awarded tax credits and were ready to begin construction in early 2022. He spoke about cost issues, and labor and material shortages that presented challenges in moving forward.

3) Public Hearing

Mayor Dutra opened the Public Hearing.

Yesenia Jimenez gave suggestions for providing additional storage space. She spoke about challenges with housing and the potential for constructing higher density buildings.

Seeing no one else approach the podium, Mayor Dutra closed the Public Hearing.

5) City Council Deliberation on the Motion

Mayor Dutra stated his concerns with the lack of an environmental impact report and traffic study prior to project approval.

In answering Mayor Dutra, Mr. Miller stated they were collaborating with Public Works & Utilities to address the location of overhead utilities.

In answering Mayor Pro Tempore Parker, Mr. Heninger spoke about potential issues if residents wanted to install their own storage units and reasons they could not reduce the number of housing units to accommodate additional storage.

Member García stated the Housing Authority of Santa Cruz County viewed the proposed development as a model that other Senate Bill 35 projects could follow.
