A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WATSONVILLE DECLARING CANVASS OF SPECIAL MUNICIPAL ELECTION HELD ON DECEMBER 7, 2021

WHEREAS, the Council of the City of Watsonville, by Resolution No. 276-21 (CM), called a Special Municipal Election to be held in the City on December 7, 2021, as required by law, for the object and purpose of electing the following municipal officer of the City of Watsonville:

1. That the County Clerk's Certification of the Votes Cast, marked Exhibit "A," attached hereto and incorporated herein by reference, and on file with the City Clerk, be, and the same is hereby entered upon the minutes of this Council as a statement of the results of the Special Municipal Election.

2. That the whole number of votes cast in District 2 were <u>371</u> at the Special Municipal Election.

3. That the list of candidates nominated for District 2 for office of Council Member to fill unexpired term to December 2024 to be filled at the Special Municipal Election and the names of the candidates which were set forth in the petitions assembled and filed with the City Clerk as required by law and the number of votes cast in favor of each candidate were as follows:
