1. ROLL CALL

Mayor Dutra, Mayor Pro Tempore Parker and Council Members Estrada, Hurst, García, and Montesino were present.

4.a. ORAL COMMUNICATIONS FROM THE PUBLIC

María Elena de la Garza, executive director at Community Action Board, thanked Member García and Carmen Herrera-Mansir for coordinating a meeting with various non-profit agencies regarding support for the homeless population. She spoke about potential solutions to address the issue and asked Council to prioritize it.

Sandra Varela, Watsonville Works, spoke about support services and programs offered to the homeless. She requested Council's help in fulfilling housing and supply needs in order to continue offering services.

Patrick Orozco, tribal chairman of Pájaro Valley Ohlone Indian Council, offered a prayer in honor of Member Parker becoming Mayor. He sang a tribal song and spoke about its history.

Deb asked for an update from staff regarding the closure of K-mart and the effects on the shopping center.

Xitlali, District 2, spoke about challenges faced by the unhoused population during winter. She spoke about ways that community members had provided aid. She asked Council to approve an emergency resolution to broaden shelter options and asked for transparency in the approval of Consent Agenda Item 5.I.

Carmen Herrera-Mansir, executive director for El Pájaro Community Development Corporation, asked Council to consider emergency action to provide additional support services to homeless members of the community.

Monike Tone, Pájaro Valley Homeless Union President, requested Council act to prevent homeless encampment clearings of the population living near Pájaro River. She spoke about challenges faced due to displacement, cold weather, and lack of resources. She asked Council to provide aid.

May Bauer asked Council and Police to cease homeless encampment clearings and for restrooms and other facilities to be made available to them. She stated there were many people who required assistance due to their health conditions and spoke about the potential negative impact of separating these members of the community from each other.

Eli, District 7, asked that Police encampment clearings scheduled for the following day be stopped and that the homeless encampment on Bridge Street be allowed to remain. She listed the supply needs for the homeless encampment and requested Council approve an emergency resolution to fund a warming center and expand shelter options.

Julie Guerrero spoke about the needs of the homeless population and asked Council to provide support for them.

Karina, District 5, asked Council to provide support and resources for the unhoused population. She asked the City to ensure local businesses in the Airport area thrived.

Dr. Nancy A. Bilicich, District 7, provided an update regarding Pájaro River Flood Management Agency meetings. She stated impact fees had not yet been established in regards to river levee improvements.

Steve Trujillo, District 7, stated he contacted Assembly Member Rivas to request the ban of spraying of pesticides and listed its negative side effects. He asked Council to support organic farming and to support the homeless community.

4.b. ORAL COMMUNICATIONS FROM THE COUNCIL

City Manager Huffaker, in answering Member Montesino, spoke about the homeless encampment located in a publicly owned parking lot on Bridge Street. He stated notice of its clearing had been provided and the intent was to relocate the homeless to shelters.

Member Montesino stated homelessness was a difficult issue to address and thanked members of the community who provided aid and support.

Member Hurst thanked the public for their participation and thanked City staff for their work.

Member García spoke about a meeting she organized to discuss homelessness issues in the downtown area. She spoke about concerns brought forward by attendees and listed strategies to address them. She spoke about a future steering committee meeting that would help determine how Council could assist. She stated a meeting between department directors and County representatives would be held to identify immediate action.

Member Estrada stated Council was working to provide support for the homeless population. He stated he would continue speaking with community members and support Member García's initiative to find solutions.

Mayor Pro Tempore Parker spoke about action being taken by Council and staff in Monterey County to provide support and housing for the homeless population. She thanked staff and non-profit organizations for their work.

Mayor Dutra stated newly opened Grace Harbor Women's Center had resources for women needing assistance. He spoke about Santa Cruz County Metropolitan Transit District's collaboration with Toys for Tots for the Stuff the Bus event and spoke about his attendance of the Watsonville Community Band concert.

Ramon Gomez inquired about the reasons for wanting to move Watsonville to a different Congressional District and requested images of the current maps.

Member Dutra stated he submitted a letter to the State expressing preference of keeping Watsonville in the 20th Congressional District.

Peter Radin spoke about the history of the California Citizens Redistricting Commission and stated there was a short time period to appeal to the Commission regarding the proposed district boundaries.

Trina Coffman- Gomez requested Council approve a resolution in support of keeping Watsonville in the 20th congressional District.

Dr. Nancy Bilicich, District 7, spoke about the City's collaboration with Congressman Panetta on the Pájaro Levee reconstruction project. She requested Council approve the proposed resolution.

Peter Radin provided suggestions for addressing the California Citizens Redistricting Commission and recommended focusing on communities of interest and connections with other parts of the 20th Congressional District.

MOTION: It was moved by Member García, seconded by Member Dutra to approve a resolution declaring opposition to the proposed Congressional District Map.

Member García spoke about Watsonville's communities of interest in Santa Cruz and Monterey counties.

City Clerk Flores encouraged the public to contact the California Citizens Redistricting Commission.

Member Hurst spoke about Watsonville's shared communities of interest in Santa Cruz and Monterey. He encouraged the public to participate in the State's redistricting process.

Member Dutra stated several local leaders had already sent letters opposing the proposed map.
