

**THIS FIRST AMENDMENT TO CONSULTANT SERVICES CONTRACT  
BETWEEN THE CITY OF WATSONVILLE  
AND SDI PRESENCE LLC**

**THIS FIRST AMENDMENT TO CONTRACT** for consultant services is entered into by and between the **City of Watsonville** ("City") and **SDI Presence LLC** ("Consultant") this \_\_\_\_\_. The City and Consultant agree as follows:

**RECITALS**

**WHEREAS**, the City and Consultant have previously executed a Consultant Services Contract to provide project management services dated July 19, 2021 ("Contract");

**WHEREAS**, the Consultant has requested additional time to complete the work program causing additional time to the project completion; and

**WHEREAS**, the amendment of the Contract for Consultant Services is in the best interest of the City of Watsonville.

**NOW, THEREFORE**, the City and the Consultant agree that the Contract shall be amended as follows:

Section 2 is hereby amended to read:

***"Section 2 entitled "Term of contract" and Exhibit B entitled "Schedule of Performance" of the Contract, is hereby amended to read as follows: "The term of this Contract shall be from 07/12/2021 to 04/30/2022, inclusive."***

Section 4 is hereby amended to read:

**"Section 4" and "Exhibit C" both entitled "Compensation" of the Contract, are hereby amended to the new not to exceed total compensation amount of Two Hundred Fifty-Seven Thousand Six Hundred Dollars (\$257,600) for professional services.**

Exhibit B is hereby amended to include:

**Work Plan. SDI will complete the IT Department's Work Plan and provide recommended staffing levels to accomplish the projects identified during the TAC workshop conducted on November 30, 2021**

Exhibit C is hereby amended to include the following provision:

**Consultant anticipates travel costs of up to \$21,000.00 for the three-month period beginning on the execution date of this amendment until April 30, 2022. Consultant shall submit actual travel costs to the City for reimbursement. Travel costs associated with Meals should be invoiced at the per diem amount of \$69.**

All other terms and conditions of the Contract dated July 19, 2021, shall remain in full force and effect.
