

RESOLUTION NO. _____ (CM)

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WATSONVILLE AUTHORIZING THE PURCHASE OF THIRTY (30) SELF CONTAINED BREATHING APPARATUS (SCBA) PAKS, AND RELATED PARTS, FROM ALLSTAR FIRE EQUIPMENT CO, A CORPORATION, FOR AN AMOUNT NOT TO EXCEED \$298,380.32; AND ONE (1) AIR COMPRESSOR FROM BAUER COMPRESSORS, INC., A CORPORATION, IN AN AMOUNT NOT TO EXCEED \$68,021.92, PLUS \$13,597.76 FOR CONTINGENCIES; AUTHORIZING THE CITY MANAGER PRO TEMPORE TO ISSUE THE PURCHASE ORDER; AND AUTHORIZING BUDGET APPROPRIATION OF AN AMOUNT NOT TO EXCEED \$380,000 FROM THE MEASURE Y FUND

WHEREAS, Watsonville Fire Department personnel utilizes self-contained breathing apparatus (SCBA) when responding to fire incidents; and

WHEREAS, in accordance with the City's purchasing policy, quotes were requested from Allstar and Municipal Emergency Services (MES) for the SCBA paks and cylinders; and

WHEREAS, Allstar and MES are the only two authorized vendors for Scott Air-paks and it was determined by staff that MES submitted an incomplete quote for the SCBA paks and cylinders; and

WHEREAS, Bauer Compressors is a sole source vendor for the requested air compressor pursuant to subdivision (c) of § 3-5.210 of the Municipal Code which exempts from competitive bidding. The equipment, and supplies are unique, available only from one (1) source, or sought to match existing equipment or supplies already in use (also known as a sole source purchase); and

WHEREAS, the current SCBA equipment has exceeded its lifetime and replacement of this outdated equipment is necessary.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF WATSONVILLE, CALIFORNIA, AS FOLLOWS:

1. That the Council hereby authorizes the purchase of thirty (30) Self Contained Breathing Apparatus (SCBA) and related parts for the Watsonville Fire Department from Allstar Fire Equipment Co., a corporation, in an amount not to exceed \$298,380.32.

2. That the Council hereby authorizes the purchase of one (1) Air Compressor for the Watsonville Fire Department from Bauer Compressors, Inc., a corporation, in an amount not to exceed \$68,021.92.

3. That the Council hereby authorizes \$13,597.76 for contingencies to make any necessary building modifications to fit the new, larger, air compressor and adjustments to personal equipment.

4. The purchase from Bauer Compressors, Inc., is exempt from the purchasing procedures of Chapter 5 of Title 3 of the Municipal Code as a sole source purchase under subdivision (c) of § 3-5.210 of the Municipal Code.

5. That the City Manager Pro Tempore is hereby authorized and directed to issue purchase order for and on behalf of the City of Watsonville.

6. That the budget appropriation of an amount not to exceed \$380,000 from the Measure Y Fund [0310] is hereby authorized.
